

Board of Governors

The Board of Governors meets at least once each quarter to consider ways and means by which the Association might seek to further the objectives of the US Army Reserve and to conduct such other business that might come before the Board.





The 63d Infantry Division Association honored Major General Henry K. Kellogg by proclaiming their last annual meeting held on 8 May 1976 in his honor. Colonel Tommy Gilliam, President of the organization presented a plaque inscribed:

In recognition of his outstanding leadership as the former 63d Infantry Division Commander; for his continuous contribution of advice and military expertise toward a strong national defense; for his untiring efforts while serving on key policy making committees that work for a strong, more professional United States Army and United States Army Reserve; and for his many years of devoted duty to his country through active service, work as a citizen soldier and as a citizen concerned with the future of our Country, we sincerely proclaim this 8th day of May, 1976, MG HENRY K. KELLOGG NIGHT as an expression of our appreciation.

General Kellogg was also presented a Certificate recognizing his many years of service in the Reserve Officers Association.

BOARD OF GOVERNORS-Activity Report

The Board of Governors reelected COL Tommy R. Gilliam as President for a second consecutive term. The Board meets each quarter to consider current program and problem areas of the U.S. Army Reserve and to take whatever action is deemed appropriate to further the objectives of the overall USAR program.

Of particular concern to the Board have been recent developments as to future plans and policy for the Los Alamitos and Fort MacArthur military reservations, and the future program of the USAR at these sites. Proposals have been made and initial steps already taken that would transfer control of Los Alamitos to the California National Guard, such action has already been accomplished with respect to such training sites as Camp Roberts and Fort Irwin.

A special committee was established to develop ways and means by which the Association might support the most effective Reserve program at the Fort MacArthur and Los Alamitos facilities. The committee was also charged with a responsibility of making recommendations to the Board in other areas of consideration, including the preservation of past records and articles of historic interest of the 63d Infantry Division, and the development of an awards program.

The Board is continuing in the effort to seek support of the California Congressional Delegation in those areas which will further the objectives of the U.S.Army Reserve program.

The Board has been gratified by the support of the membership of the Association. Of note is the fact that at present 75 individuals have become Life Members.

New Army Chief of Staff Is Veteran of 63rd Div.

General Earle G. Wheeler, World War II Chief of Staff of the 63d Infantry Division, is the new Army Chief of Staff, succeeding General George H. Decker who retired effective Sept. 30.

General Wheeler joined the 63d Infantry Division as Chief of Staff in May, 1943, and served with the unit in the European Theater of Operation from early 1945 until September, 1945.

General Wheeler was Director of the Joint Staff from April 1960 to February, 1962, before going to Camp des Loges, near Paris, and NATO Headquarters as Deputy Commander-in-Chief of the U.S. European Command.

New Center Important As USAR Headquarters

The General George S. Patton, Jr. USAR Center in Maywood, Calif., already is the largest Army Reserve Center in the nation, and the Army plans to spend \$500,000 in a renovation program beginning in 1963.

Located on 35 acres which have been part of the Cheli AFB, the Patton Center now is headquarters for some 3,000 Reservists who train one night a week and on periodic modern combat proficiency. Sundays.

Largest unit represented at the Maywood center is the 63d Infantry Division. Some 1800 of its more than 7500 members train here.

The center comprises 25 buildings, the largest occupied having 86,000 feet of floor space. It provides a readily accessible training headquarters and handy mobilization point.

Payrolls and expenditures of the General Patton USAR Center total more than \$1 million annually and are clearly important to the Southland community.

'Wolfhounds' Aid Japanese Orphans

Members of the 3rd Battle Group, 27th Infantry, of the 63rd Infantry Division, known as the "Wolfhounds," held a dinner recently to raise funds for the Holy Family Home, an orphanage near Osaka, Japan, where members of the unit in wartime became legend in their efforts to help Japanese children.


He also is an MTS in Space and Communication Group's Defense Systems Division, Advance System Labs.




