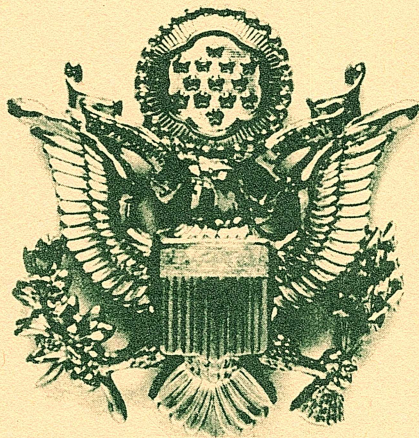
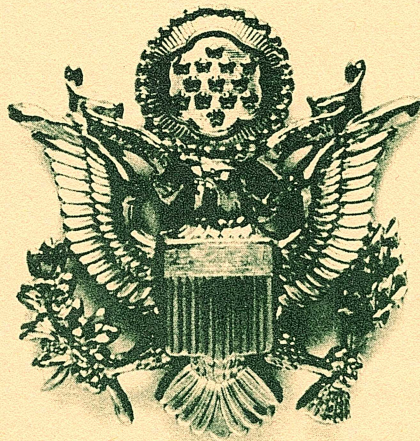


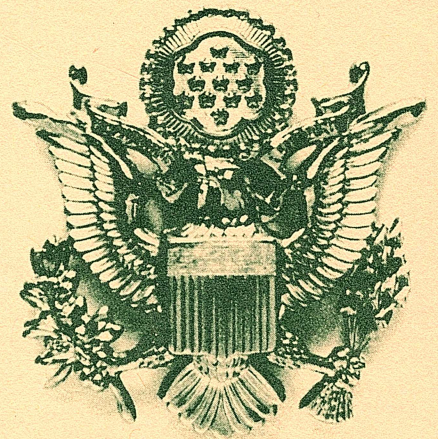

BOARD OF GOVERNORS -- ACTIVITIES REPORT

The period of 1980-81 may be characterized as one of intense interest and feeling of accomplishment on the part of the members of the Board of Governors. As President, CW4 Ernst H. Andreas has through his leadership, guided the Board in its new direction to consider ways and means that the Association may effectively assist in promoting a strong National Defense, and help to develop a means by which the overall objectives might be accomplished.

The Political Action Committee (PAC) of the Board of Governors has taken positive steps in formulation of a Council of National Defense Oriented Organizations - Southern California. Elsewhere in this report, a copy of the inquiry and invitation that has been put out to local organizations is shown for your information and hopefully, assistance in implementation in some of your other activities.

The Board has been kept fully informed of the program of the Army Reserve particularly within the scope of the 63d ARCOM; having been briefed on the budgetary matters concerning construction of new facilities, supplies and equipment, new organizational structures and manpower problems.

During the past year consideration has been given to a renewal of the awards program recognizing an outstanding cadet of the ROTC or Jr. ROTC within the Southern California area.

A series of newsletters has been published for better communication between our members on the activities of the Board of Governors and its committees as well as general news concerning our members. The Board will welcome your comments and input to these publications.

As recently announced in the Newsletter, the dues structure was changed effective 1 January 1981: Life Members \$30.00; 3 year members \$12.00; and 1 year members \$5.00. Prior to the change members were given an opportunity to become life members at the "old rate". The response was tremendous. The roster printed in this annual report indicates all life members as of this date.

As members of the Association have a change in rank, or change in address, please notify the Secretary without delay.

The 63d Infantry Division Association (USAR) has initiated action to form a coalition of chapters, posts, lodges of organizations interested in promoting the national defense and security of the United States. The coalition will be known as the "Council of National Defense Oriented Organizations (Southern California)". We believe that the title defines the purposes and scope of the proposed organization.

During the past few months, we have contacted by letter most of the national headquarters of such organizations as the American Legion, Veterans of Foreign Wars, The Retired Officers Association, Reserve Officers Association of the United States and many more, outlining our plans and requesting the identity of persons such as you, who are in positions of leadership of local organizations. The response by national headquarters has been favorable and encouraging. Also, several local (district, department, state) headquarters have expressed an interest in our endeavors and have encouraged us to proceed.

We are therefor prepared at this time to extend an invitation to your organization to join the Council, and request you indicate your interest on the enclosed application form.

In the near future, probably in June or July, a general meeting will be convened, at which time a draft constitution and additional details will be presented. The meeting will be a dinner meeting, with the cost of the dinner used to defray the cost of the food and the meeting place.

We sincerely hope you will join with us in what we believe to be a vital and necessary step toward a better and more professional defense posture.

General Omar Nelson Bradley, the last of America's five-star generals and a World War II hero so loved by his troops they called him the "GI's General," died April 8, 1981 of cardiac arrest. He was 88.

He was the nation's first chairman of the Joint Chiefs of Staff. He had remained on active duty and had been in the Army almost 70 years, more than any other U S serviceman and spent the last 30 years as general of the Army.

Bradley was regarded as one of the greatest field generals of World War II. He was thrifty with the blood and lives of his men, the master of military tactics and became very proud of his record of winning battles with minimum losses.

From his leadership of the U S First Army, he went to command of the Twelfth Army Group --- originally composed of the First, Third and Ninth Armies and later augmented with the Fifteenth--and had an outstanding part in pushing the Germans back into their homeland.

His million-man command was the largest in American history and included most United States troops in Germany.

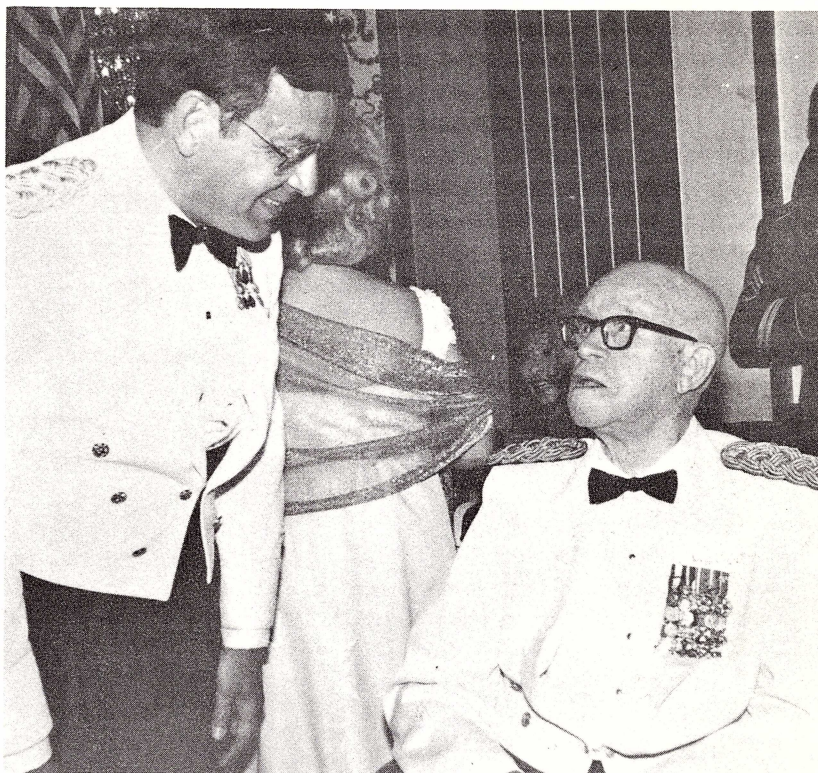
Drew Middleton of the New York Times said that in a war that had its share of synthetic heroes, on both sides, Bradley was genuine. Yet the mild, friendly exterior concealed a character that combined some oddly discordant elements. In repose, he was a folksy person, plain as an old shoe, his aides said; a man who liked to recall anecdotes about his baseball days at West Point and who could chuckle over half-forgotten pranks played on young officers.

But there was a great mental toughness. Once committed to a plan of operations, he would let nothing prevent or delay its execution. He could be coldly furious with the inefficient, but his criticisms were made in private. Only years later would he disclose how he had felt about erring commanders.

Omar Bradley served his country and the cause of free peoples at a time of dire need and, the last of the five star generals is now remembered with appreciation and respect.

ANOTHER MILITARY CAREER CLOSES. . .

Approximately 90 days after my 17th birthday, I enlisted in the United States Army for 3 years. This was 28 June 1946.

After two months of basic training at Camp Polk, Louisiana, and 2 additional months of advanced basic training at Fort Sam Houston in Texas, I was shipped overseas to the Far East Command and assigned to Company "M", 35th Infantry Regiment, 25th Division in Otsu, Honshu, Japan as occupation forces. I was assigned as a machine gunner.

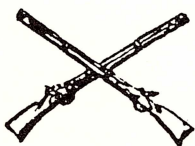
During my 30 months in Japan, I received various assignments and three promotions, but my last 6 months were for me the most rewarding because I was able to play football for our unit and was chosen for All American Ground Forces to play Navy on Thanksgiving day 1948 and earned the title of "Mr. 50" fullback.

Upon my return to the USA, I was honorably discharged on 10 May, 1949, and enlisted directly into the Army Reserve and assigned to HQ 13th Armored Division at Fort MacArthur, California. As an enlisted man working through the ranks I was part of the first troops assigned to the 63d Infantry Division upon its activation and was 1st Sgt, 254th Infantry Regiment, 63d Infantry Division. When I found I could not advance any further a choice had to be made: apply for a warrant or work for a commission. In April 1957 I received my commission as 2d LT Infantry with the 63d Division. I held several positions with the Division, my last one as "DQMSO" (Division Quartermaster Supply Officer). During the deactivation of the 63d Division, I was on duty for 90 days receiving and turning in property of hundreds of property books to Fort MacArthur.

In September 1961 I was assigned as Bn S-4, 309th ASA Bn at Patton USAR Center. This was a very outstanding and rewarding assignment within my career and lasted for 13 years. It was here I received my first command as Captain, commander of the 520th ASA Company, which lasted for two years and proved to be very educational and enjoyable. Later I was reassigned as Bn S-4 again.

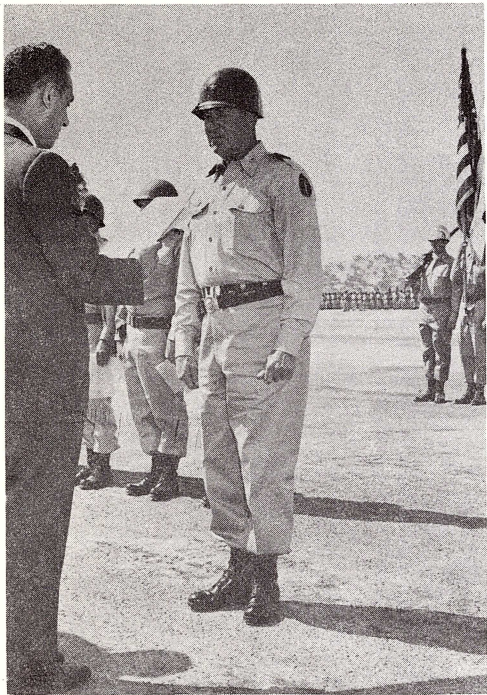
In 1971, I was promoted to Major and assigned as Bn XO, 309th ASA Bn. I filled this position for three years and transferred to HQ 311th Support Brigade. I was with the 311th for 5 years and retired on 16 February 1979, keeping my reserve status.

- NOTE: 1. I have filled and been assigned to every enlisted rank from Private to First Sergeant.
2. In my 30 years in the Army Reserve program, I have never missed a summer training session even though I had to give up my vacation time and in some cases I received no pay from my regular employer during this time of participation.
3. I have made numerous friends during my career and my military life has been fulfilling, rewarding and honorable; and I thank God and my country for the privilege to have been able to serve.
