

WHEREAS, General Kellogg was active and Life Member of this the 63d Infantry Division (USAR) since its inception in 1956; and


WHEREAS, General Kellogg served with distinction as a member of the Reserve Officers Association of the United States, and other important military organizations; and

RESOLUTION OF THE 63D INFANTRY DIVISION ASSOCIATION (USAR)

SUPPORT OF THE PRESIDENT'S POSITION ON THE DEFENSE AND SECURITY OF THE UNITED STATES

WHEREAS, the President of the United States has clearly and accurately recognized a steady deterioration of the comparable readiness posture of the military forces of the United States against that of global commitments and that of possible adversary nations; and

WHEREAS, the President of the United States has presented to the Congress a message expressing an urgent need to establish comparability of the United States military forces with that of possible adversary nations and to insure the defense and national security of the United States:

NOW, THEREFORE, BE IT RESOLVED that

- 1. The 63d Infantry Division Association (USAR) fully supports the position of the President of the United States in improving readiness postures of all Active and Reserve components of all services of the United States military forces, and
- 2. the Office of Secretary of Defense prepare and present to the President of the United States a program for achieving acceptable levels of comparability, said program to consist of progressive milestones expressed in terms of months and/or years; and, that all resources and moneys be allocated proportionately to all branches and components of the Active and Reserve forces in such a manner as to enable the total military structure to achieve acceptable levels of readiness as simultaneously as possible.

Unanimously adopted by the Board of Governors.

## RESOLUTION OF THE 63D INFANTRY DIVISION ASSOCIATION (USAR) REORGANIZATION OF THE ARMY RESERVE (ROAR) PROPOSAL

WHEREAS, the Office of the Secretary of the Army has prepared a proposal the intent of which is to effect a major reorganization in the command structure of the U S Army Reserve, officially entitled "Reorganization of the Army Reserve (ROAR) Proposal", hereinafter referred to as "The Proposal", and

WHEREAS, the Proposal divides command, control, and responsibility for the wartime readiness of the Army Reserve among five or more type headquarters at various levels of command authority and capability thus establishing the opportunity for multiple standards or readiness, and thus extending the span of command and control of the selected headquarters to the possible extent that such headquarters would be non-responsive to the demands of Army Reserve units requiring close support and supervision, and

WHEREAS, the Proposal removes the current level of close command and support by elimination of all Army Reserve Commands (ARCOM), and

WHEREAS, the Reserve Community has been given no opportunity to provide input into the formulation of the Proposal:

NOW, THEREFORE, BE IT RESOLVED that

- 1. the Reserve Community, to include the Office of Chief of Army Reserve, the Senior Army Reserve Commanders Association, and the Reserve Officers Association of the United States be invited and/or required to provide input into the "Reorganization of the Army Reserve (ROAR) Proposal", and
- 2. the Office of Secretary of the Army delay presentation of the Proposal to the Army staff or the Congress of the United States until the Reserve Community has had reasonable time to study and prepare recommendations related to the provisions contained in the proposal.

# RESOLUTION OF THE 63D INFANTRY DIVISION ASSOCIATION (USAR) REDUCTION IN FUNDING FOR COAST GUARD

WHEREAS, the Coast Guard is a military service and a branch of the armed forces of the United States at all times, functioning as a service in the Department of Transportation, except when operating as a service in the Navy (14 USC §1); and

WHEREAS, the Joint Chiefs of Staff have determined significant military readiness missions for the Coast Guard in support of the Navy; and

WHEREAS, the Secretary of the Department of Transportation must exercise leadership under direction of the President in support of the transportation needs of national defense (49 USC  $\S1653(a)$ ); and

WHEREAS, the Secretary of the Department of Transportation may not revise any policy, standards or criteria relating to the Coast Guard without appropriate action by Congress; and

WHEREAS, the Secretary of the Department of Transportation must fully consider the need for operational continuity of the Coast Guard in the needs for national defense (49 USC \$1653(b) (1); and

WHEREAS, the Secretary of the Department of Transportation must provide for such peace-time training and planning of reserve strength and facilities as is necessary to insure an organized, manned and equipped Coast Guard when it is required for wartime operation in the Navy (14 USC §145); and

WHEREAS, the House Subcommittee on Coast Guard and Navigation has determined the Coast Guard is currently unable to meet its military readiness mission due to lack of resources; and

WHEREAS, the recent reduction in funding for all Coast Guard missions will further deteriorate its ability to fulfill its military readiness responsibilities;

NOW, THEREFORE, BE IT RESOLVED that the 63d Infantry Division Association (USAR) urgently expresses to the President its grave concern over insufficient funding being provided in the current budget to the Department of Transportation to permit the Coast Guard to meet and maintain its military readiness for national defense and further urges the President to insure that sufficient resources are promptly provided for this purpose.

Unanimously adopted 9 February 1982.

Security of the United States, with special attention to the support of the Reserve Components of all branches of the military service.

Specific actions taken by the committee and prepared for the review and support of your Board of Directors are three of the resolutions shown above that deal with the recently announced plan to reorganize the Army Reserve, the restoration of funding for the Coast Guard and the resolution to support the President of the United States in the position he has taken on our National Defense.

The Committee is continuing its efforts to develop a Council of National Defense Oriented Organizations in the six counties which comprise the Southern California area.



## A New Shop For The USAR At Los Alamitos AFR C





























## the annual meeting '82...















### On the road again. . .

with LTC Irving C. and Lucille Myers and COL Noel B and Johnnie Pattinson. West Germany, 15 Jul 81--The Myers drove from their apartment in Hochheim (between Weisbaden, Frankfurt, Mainz) to Frankfurt Airport to meet the 11:10 Pan Am from Los Angeles. Plane arrived at 13:30 with the Pattinsons. Took them back to the American Arms Hotel in Weisbaden. All had dinner at Am Arms--Pattinsons stayed overnight and the Myers returned to their apartment.

16 Jul 81--All had breakfast at Am Arms--loaded the Renault 18TA, with luggage rack, and at 0830 headed up the Autobahn toward Travemunde near Lubeck, on the North Sea. Arrived Travemunde at 1705 (620 km). Secured 2 rooms at Seegarten Hotel; had

dinner at the Marco Polo Restaurant.

17 Jul 82--After breakfast, drove to Ferry Dock; boarded TT Saga Linie; the Musical Director took us under his wing, but he played a dirty sax; Captain's Buffet Lunch was excellent--lots of fish. Arrived Malmo Sweden about 1700, got rooms at Hotel Anglais (owned by the Salvation Army); nice rooms, but Rube Goldberg designed

the bathroom shower. Dinner in a cellar--Kockska Krogen--good food.

18 Jul 82--After breakfast headed northeast toward Alghult, home of Johnnie's relatives. Next day (Sunday) was spent celebrating. Family reunion at the Silvereke Farm, complete with 65 cousins, nephews, neices, etc., and the barn decorated with the California Bear Flag. For the next 18 days, we traveled with, visited, lived with, toured and ate with assorted relatives in Alghult, Halleforsnas, Stockholm and During this period, we took a Silja Line Ferry "Silvia Regina" 3-day tour to Helsinki, Finland; a very beautiful trip thru the Swedish and Finnish archepelegos, and a Helsinki City tour with an English speaking taxi driver. From Stockholm, the party drove north to Mora and Dalaland, the woodcarving country, home of the famous wooden horses; from there across the ski highlands and into Norway, on the road to Bergen; over, around and thru mountains, across windswept snow fields, when suddenly the road dropped to a narrow shelf cut out of a rock wall--the head of the EIDFJORD. This was a thrilling ride down a spiral slide, thru tunnels, alongside crashing waterfalls; finally down to HARDANGER FJORD which was crossed by ferry to ULVIKFJORD. We spent a few days at Ulvik riding the fjords, then continued on the road to Bergen. We spent 2 days seeing the sights of Bergen, then back tracked to Ulvikfjord and across to the other side of Hardangerfjord by ferry. It's not easy to get out of Bergen by land. From there the road to Kristiandsand led across the Norwegian highlands, up narrow mountain roads, thru endless tunnels, some 6 kms, across snowfields, past skilifts and finally down some green valleys to the southern coast.

12 Aug 82--We took a ferry from Norway to Hirtshals, Denmark. Next day to Copenhagen. Spent a fascinating evening in Tivoli Gardens. Next day a city tour, by taxi, to see the highlights, including the Mermaid in the harbor. From Copenhagen south to

Rodeley and ferry to Puttgargen, Germany.

16 Aug 82--Stopped at Krafeld, Pat's old HQ's. Then back to the American Arms in Weisbaden for the Pattinsons, and the Myers to the Hochheim apartment. The next couple of days were spent doing laundry, resting, visiting German Customs for a pink card for Pat and Johnnie so they could use the Commissary and Exchange facilties, and a couple of visits to the USAF Hospital Clinic for medicinal purposes (the hostages were treated there.)

18 Aug 82--The Pattinsons took Rheincruise, and visits to Rudesheim, Baccarat; got the Renault serviced, patronized the APO then to the American Express for French, Ital-

ian, and Swiss currency.

21 Aug 82--Started the second leg of the journey; took the road to Trier (lots of Roman ruins). Travelling the Rhine and Moselle valleys there are grapes as far as the eye can see; this means lots of wine, and the four of us are having a tough time trying to reduce the oversupply. Next into Luxembourg, to the capital, and to a very memorable sight, the American Cemetery with the graves of thousands, including General Patton. On the following day we crossed into France, stopped at Verdun for "under the arm" sandwiches; and then on the Peage toward Paris. Stopped at Reims to see the outstanding Cathedral.

23 Aug 82--Sunday, we visited Paris. Good day to drive thru this city, not much

traffic; saw Bastille, Notre Dame, Seine, Louvre, Tuilleries, Place de Concorde, Eiffel Tower, Les Invalides, Ecole Militaire, Arc de Triomphe and had coffee on the Champs Elysses. Took the road to Orleans, to the stutue of Joan d'Arc, the Cathedral, then along the Loire Valley to Blois. Dinner that night in an old monastery down some narrow lanes in the old city. Next day visited two of the most interesting of the many Loire Valley Chateaux, Chevrigny and Chenonceaux. Then southwest thru Limoge (to buy some china), Perigeaux (city of Roman ruins), Agen, and Auch (the D'Artangnan city) Tarbes, and into Lourdes, under the snow covered Pyrennes.

26 Aug 82--Lourdes is jammed, narrow streets are full of visitors and pilgrims, bus loads from all over Europe. Took a walking tour of the village, saw Bernadette's high lights, and candlelight procession at night to the Shrine. At 0600 the next morning, activity started in the streets; we all went to visit the Basilica, Shrine, Grotto. That night we visited the Candlelight Procession--very impressive--thousands of people-candles, wheelchairs, guerneys, litters, hospital beds; the lame, ill, crippled and blind. When we left thousands were still in line coming into the grounds; a very im-

pressive and exciting phenomenon.

28 Aug 82--From Lourdes to Tarbes to Toulose, and on into Carcassone, the complete and intact walled city--one time post on the French-Spanish border. Next day, on the road to Narbonne, Montpelier, Nimes--to see the Arena, the Gardens--then to Avignon--to see the French Papal Palace (the French Vatican). The road then led to Toulon, Heyeres, St. Tropez, St. Raphael, and into Nice. Spent three days enjoying the French Riviera--Grasse, the perfume center--Vence, St. Paul de Vence. Next on to Monaco, and Menton, where we crossed the border into Italy. Travelled the Autostrada toward Genoa, then to Milan, then Lakes Maggiore and Como.

2-7 Sep 82--We toured, viewed and enjoyed Lake Como, Lugano, and three exciting days

in Bellagio.

8 Sep 82--On the road to Lucerne, back to Lugano, thru the Swiss border station, up thru Gottard Pass--no longer over the Pass, but now thru a 17.5 km tunnel to the other side of the mountain, and another tunnel of 12 km, then into Lucerne. Two days to shop, tour, relax, eat. Next over another Pass and into Interlocken. Highlight of two days here was the trip up Lauternbrunnen Valley to Trummelback Falls--inside the side of the mountain--powerful waterfall--20,000 litrs/sec--drains three mountains--Elger, Monck and Jungfrau. The road then led to Thun, Bern, Zurich, Appenzell--a picturesque mountain village in the Heidi country; then on to Leichtenstein and the capital city Vaduz; and on into Austria, Feldkirk, thru the Aarlburg Pass (tunnel 14 km), and into Landeck. From Landeck the road led to Innsbrucke, Wilten and the ornate pretty church of Our Lady of Wilten (Basilica), and the Olympic Ski Jump; then to Worgl, Kitzbuhl, Mittersil, Zell am See. Next to Salzburg--a visit to the locale of "The Sound of Music", and an evening at the Marionette Theatre. Then on to Vienna for three days of nostalgic sightseeing--city tour, the Spanish Riding School at night, Schloss Schonbrunn--also a bus trip to Budapest, Hungary (a beautiful city, and worth the frustrating experience of passing thru the Hungarian Border Stations twice--in and out.


18 Sep 82--Left Vienna, on the road to Baden, Mayerling, Vienna Woods, back past Salzburg, crossed the border into Germany, and on to Lake Chiemsee where we stayed at the Lake Chiemsee Hotel (Armed Forces Recreation Center). Next day on to Garmisch-Partenkirken, passing thru Bad Tolz, Miesbach; stayed two days at the Hotel Von Steuben

(Armed Forces Recreation Center).

20 Sep 82--Left for Oberammagau, Landsberg, Augsburg, Donauworth, Nordlingen, and into Dinkelsbuhl. Next day on toward Rothenburg, then to Nurnburg (no rooms at the American Bavarian Hotel, but got referral to Hotel Garni Royal. The road then led to Heilbrun and on to Baden-Baden where there was security everywhere, the Casino and Kurhaus were closed due to a meeting of the International Olympic Committee. From here a day trip back to France to visit Strasbourg. Next day left for Heidelberg, and Weinheim (Pat's old bivouac). Finally back up the Autobahn to Wiesbaden, and the American Arms for the Pattinsons. Spent the next three days at the laundry, Exchange, Commissary, USAF Hospital Clinic, APO, German Customs, Base Library, Rheinblick Country Club (AFRC Golf Course); and one evening at the Hochheim Stadthalle for "Oktoberfest".

29 Sep 82--Drove the Pattinsons back to the Frankfurt Airport, checked in at 0930, said "Goodbyes", and they went into the Security area. On The Road Again covered about

13,000 kms. Between 18 Mar and 15 Jul (before the Pattinsons arrived), the Myers traveled France, Germany, Holland, Belgium, England, Scotland, and Wales. After the Pattinsons departed, between 30 Sept and 3 Nov, the Myers traveled France, Spain, and Germany. On November 4, at 0630, we boarded a C-5A MAC Flight at Rheinmain Air Base, and landed at Dover, Delaware Air Base at 1100 hours. Then by limo to Philadelphia Airport and TWA to LAX. . . .


