

## **National Interest Committee**

POLITICAL ACTION COMMITTEE REPORT

Since our last report to the membership, a number of events of national interest have demanded our immediate attention and timely action:

First, during the 1988 Presidential campaign, the media attempted to discredit the Vice Presidential candidate's service in the Army National Guard during the Viet Nam period, and in doing so belittled and demeaned service in the Reserve Components of the Army as an acceptable and honorable means of discharging one's military obligations. Our reaction was a resolution condemning the attitude of the media, but at the same time being very careful to avoid any involvement with the political aspects of the situation. The result was widespread support of our position in the letters we received from Governors, Senators, and members of the House. Perhaps the most significant were those from Senator Sam Nunn, Chairman of the Senate Armed Services Committee, and from the Governor of the State of New Hampshire, John H. Sununu, who is now the Chief of Staff of President Bush's Administration.

Next, our attention was directed toward the Medicare Catastrophic Coverage Act which was passed into law in 1988. Τn this matter we joined and supported a coalition of more than thirty other organizations founded jointly by The Retired Officers Association (TROA) and the National Association of Retired Federal Employees. The coalition is now formally known as the Coalition for Affordable Health Care, and it's purpose is to correct the gross inequities contained in the new law. We are currently preparing a resolution which will proclaim our support of CAHC, and support of a bill (S.335) introduced by Sen. John McCain (Ariz), which would delay by one year the supplemental premiums and all benefits that were to become effective in 1990 and beyond, so that public hearings can be conducted to assess the real needs of older Americans for catastrophic protection. We urge our members to support this effort by communicating with their elected representatives in Congress.

Finally, we generated a letter writing campaign in opposition to the proposed budget cut in our COLA. Details of this campaign are contained in our 1989 Annual Meeting Newa Letter.

This committee now has a new name. The term "Political Action Committee", or "PAC", has come into general disfavor due to highly financed, self-serving organizations using the term. Since our goal is to insure the National Defense and Security of the United States, the Board decided to avoid any possible stigma of selfish interests. Henceforth, we will be known as the "National Interest Committee"

### RESOLUTION OF THE 63d INFANTRY DIVISION ASSOCIATION (USAR)

SERVICE IN RESERVE COMPONENTS OF THE UNITED STATES ARMY

WHEREAS, the Reserve Components of the United States Army (United States Army Reserve and the Army National Guard) provide 70% of the deployable forces of the Army; and

WHEREAS, the United States Government made the determination for good reason that the program of six years of duty in the Reserve Components (six months of active duty and 5% years of reserve component duty) was an honorable and meaningful means of fulfilling military obligations during the Viet Nam War years; and

WHEREAS, such duty with Reserve Components is on a 100% volunteer basis; and

WHEREAS, the general public is not well informed as to the critical position held by the Reserve Components of the United States Army in the defence of this country; and

WHEREAS, the media selectively made an issue of, and reported in an irresponsible and inaccurate manner, the true value of the Army Reserve Components during the Viet Nam War years; and

WHEREAS, in its typical selective "ignorance" of the programs and policies of the military forces, the news media with few exceptions have demeaned the value of the Reserve Components and deliberately ignored the "Total Army" policy of the United States Army; and

WHEREAS, the media as a whole has inflicted severe damage upon the reputation of the Reserve Components as a meaningful segment of the Army by deliberate omission of facts and publication of half-truths;

NOW, THEREFORE, BE IT RESOLVED that the 63d Infantry Division Association (USAR) condemns the manner in which the media reported on the issue of service in the Army National Guard during the Viet Nam War years;

BE IT FURTHER RESOLVED that the 63d Infantry Division Association (USAR) insist that the media take such steps as are necessary to mend the damage inflicted and to restore in the minds of the public the need for and the reputation of the Citizen Soldiers of the United States.

MG Berwyn (Berk) Fragner, 61, an aerospace executive, longtime spokesman for human resources management and retired Major General in the US Army Reserve, passed away on 18 February and was buried at Mt. Sinai Cemetery, Forest Lawn on 21 February.

He enlisted in the ORC in 1944 as a private and in 1945 attended the University of Delaware as a member of the Army Specialized Training Reserve Program. In 1946 he was graduated from the Field Artillery Officer Candidate School and commissioned a 2LT.

He served with the 64th FA Bn, 25th Inf Div in Osaka Japan. In 1947 he was returned to the United States and entered reserve status.

In 1950 he graduated from the University of Delaware and in 1952 received his MA from Harvard University. Between 1947 and 1960, he served in the Field Artillery in several reserve units and moved to Los Angeles to become Bn S2, 3/77 Arty, then S4, S3 and DivArty Fire Support Coordinator. In 1966-67, he was assigned to the 311th LOG CMD and became part of the original cadre that formed the HQ of the 63d ARCOM. He became Commander of the 311th in 1974 and promoted to BG in July 1965. He became commander of the 63d ARCOM in June 1979 and promoted to Major General in February 1980. He was awarded the Distinguished Service Medal, MSM w 2/OLC and the Army Commendation Medal. He was a life member of the 63d Infantry Division Association USAR.

### Division Cheers New Role

In recognition of its achievements as one of the nation's best Reserve units, the 63rd Infantry Division has been ordered by Sixth Army to expand as rapidly as possible to full strength of 14,672 men.

Lieut. Gen. Robert N. Young personally notified Brig. Gen. Henry K. Kellogg of the honor while the "Blood and Fire" reservists were undergoing summer field training at Camp Roberts and Hunter Liggett Military Reservation.

Gen. Kellogg's announcement of the outfit's new role in national defense strategy was warmly cheered by the troops.

The speedy build-up will create almost unlimited opportunities for promotion. especially in the enlisted ranks, and will increase the yearly pay drill total from 39 to 69.


Effective l July, all elements of the Division are authorized four paid assemblies each month, plus three week-ends each quarter, plus 17 days active duty for unit field training.


An intensive recruiting campaign will be launched immediately, with every member of the Division expected to play an active role. The 13,559 enlisted, 169 warrant officer and 944 commissioned officer slots should be filled before next year's encampment.

The new reserve bill will bolster the ranks, but Gen. Kellogg personally will direct the Division's own enlistment program.

Since all units will need much bigger training areas and armories than now are in use, commanders have been asked to survey their home regions for suitable structures, such as vacant super-markets and other buildings with large floor space. Any member of the Division who knows of a potential site should contact Col. Lyle J. Fitzpatrick. senior Army advisor, at headquarters.


