HISTORY OF BAYLOR COUNTY DURING WORLD WAR II



In 1933 Adolf Hitler was made chancellor of Germany by President Paul Von Hindenburg. In 1934, after Hindenburg's death, Hitler became Der Fuehrer, with absolute power.

In 1936 Hitler repudiated the Versailles Treaty. An alliance was made with Italy.

In 1939 Czechoslovakia was absorbed, and in the same year Poland was invaded. Immediately thereafter, on Sept. 3, 1939, Great Britain and France declared war on Germany. Then followed the famous "blitzkrieg," and the gobbling up of numerous European nations. On June 24, 1940, France fell. On June 22, 1941, Germany began an undeclared war on Russia.

Early in 1941 the United States passed the Lend-Lease Act. In August of that year came the Atlantic Charter. While negotiating peace with the United States, Japan made her treacherous attack at Pearl Harbor, Dec. 7, 1941.

On Dec. 8 Congress declared war on Japan. On Dec. 11th Germany and Italy declared war on the United States, and a few hours later we declared war on them.

On June 6, 1944, came D-Day, when Normandy Beach was invaded; this being followed by the rapid conquest of France and Germany. On May 8, 1945, came Germany's surrender.

This was followed by the surrender of Japan on Aug. 17, 1945.

Baylor County's part in World War II is outlined briefly as follows:

To date the county has provided 875 men for the different branches of the service. With every farm and business undermanned, the production of supplies was kept up at home, and even increased; and all basic activities were maintained.

Baylor County has met every bond quota, together with the Red Cross and War Fund Drives. Over \$2,000,000 was subscribed in bonds, with only a small per cent cashed since. (Some are still buying bonds every month).

O. P. Caldwell was county chairman for war bond subscriptions throughout the war. He says: "All diligence was had that the home front should match the fighting front." Mr. Caldwell was also drive chairman during the first four campaigns. Chairmen for the last four drives were: L. D. Jones, G. H. Jones, Dutton J. Bailes and D. A. Holman. The bond advisory committee consisted of: R. E. Baskin, Geo S. Plants, W. B. Craddock, Dutton J. Bailes, D. A. Holman, W. B. Alexander and J. E. McDuffey. F. H. Bunkley was chairman for all of the United War Fund drives.

The International Red Cross, unusually active in war times, had as chairmen during the war: Geo. S. Plants, L. D. Jones, J. Donnell Dickson and George Sims. Gene Carter was chairman for the closing months of the war. Mrs. Milton Tipton was serving as secretary when the war began. She later resigned and was succeeded by Miss Elaine Harrison. The latter served until her marriage in December of 1945, at which time Mrs. Hattie Robinson took up the work, and is the present secretary-treasurer.

Many helped with the Red Cross. George Sims, J. O. Butler and Emmitt Golden were chairmen of the war drives. Mrs. Chloe Shawver served in a marvelously efficient way throughout the war as home service chairman. She eventually resigned, and this work is being carried on until the official end of the war by Mrs. W. T. Humphreys. Mrs. C. N. Cannon and Mrs. E. F. Murphy have done a fine work as Junior Red Cross chairmen. Mrs. Emmitt Golden, Mrs. Lem Bellows, Mrs. L. D. Jones and many others served faithfully and efficiently in the Red Cross work. All schools of the county helped in this work, and in the war effort generally.

The first organization here for voluntary service was the draft board, with J. O. Butler, T. E. Craddock and S. D. Wallace as the first members. After 3 years and 11 days these men resigned, and the following were appointed: J. T. St. Clair, Lee W. Harris and Ralph Powell. They are still serving. Leonard Wharton is the secretary. Throughout the war J. Donnell Dickson has served as appeals agent for the county board, and Dr. C. E. Johnson has given medical examinations to all of the prospective soldiers.

The ration board was organized, with Judge I. O. Newton as chairman, and E. F. Murphy, Dave Wirz and Russell Morris. Later Mr. Murphy was made chairman of the gasoline panel. Rolly Fancher was chairman of the price panel, and G. E. Whiteside was secretary of the ration board office.

Mark this statement: With exception of the men on full time work, Messrs. Wharton and Whiteside, none of the above-named men or women received one solitary cent for the many hours time they devoted to the various features of war work. A fine tribute is due them.

The Seymour Lions Club performed a great service in sponsoring a memorial on the courthouse lawn for all the boys who were and are in uniform during the war. The white obelisk, 30 feet high, was paid for by voluntary contributions from citizens all over the county. The shaft at present contains the names of 829 veterans, with room yet on one of the sides for an additional 120 names. The committee serving on this memorial consists of: Walter N. Hart, J. O. Butler, J. F. Kemp and O. P. Caldwell.

The above is recognized as a very inadequate description; but if individual mention were made of all those here who had an important part in saving the world for home and civilization during World War II, then there would be no room left in this book for the names of our soldier boys in the succeeding pages.

ADAMS, CALVIN L.

Calvin L. Adams, son of Mr. and Mrs. A. H. Adams, was inducted into the Air Forces July 4, 1944; trained at Sheppard Field, Texas, Laredo, Texas, Lincoln, Neb., Buffalo, N. Y., and Boca Raton, Fla.; served with the Second Air Force; was discharged in June, 1946, while a corporal.

ADAMS, JUNIOR SPEARMAN

Junior Spearman Adams, son of Mr. and Mrs. Archie H. Adams, entered the Army April 21, 1943; trained in Camp Barkeley, Texas, Camp Reynolds, Pa., Camp Shanks, New York; sailed Sept. 8, 1943, for overseas and served in the Middle East and North Africa; spent 28 months overseas; discharged Dec. 7, '45.

ADAMS, WILLARD MELVIN

Willard Melvin Adams, son of Mr. and Mrs. A. H. Adams; entered the Army August 6, 1944; sailed for Pacific Feb. 18, 1945 and fought in the battle of Okinawa; spent 10 months overseas and was awarded Infantry Combat Medal and one battle star; was discharged Nov. 30, 1945.

ANDRUSS, ELDRED J.

Eldred J. Andruss, son of Mr. and Mrs. George W. Andruss; entered Air Corps Jan. 27, 1942; went overseas April 14, 1943; served in ETO with Eighth Air Force; killed Aug. 17, 1943, while flying his seventeenth mission over Germany; was staff sergeant when killed; awarded Air Medal, three clusters.

ARMES, JERRELL A.

Jerrell A. Armes, son of Mr. and Mrs. W. A. Armes; entered Army July 5, 1944; received training at Ft. Sill, Okla., and Camp Hood, Texas, before going overseas in December, 1944; served with an infantry division in the European Theater of Operations; now stationed at Leghorn, Italy.

BAILES, DUTTON JONES

Dutton Jones Bailes, Jr., son of Mr. and Mrs. Dutton J. Bailes, was inducted into the Navy May 15, '45; received training at Memphis, Tenn., Pensacola, Fla., Jacksonville, Fla., and Miami, Fla.; served with Naval Air Reserve training units; is now stationed at the Miami post.

BAILEY, BEN CORBEN

Ben Corben Bailey, son of Mr. and Mrs. C. C. Bailey; entered Navy Aug. 28, 1942; went overseas Oct. 15, 1942; spent 36 months in the Pacific; fought at Kiska, Makin, Kwajalein, Tarawa, Tinian, Leyte, Mindora, Luzon, Okinawa, and other battles; received discharge Oct. 25, 1945.

BAKER, JOHN T.

John T. Baker, son of Henderson Baker, went into the Army Oct. 25, '40; sailed overseas Nov. 21, '41; took part in the battle of East Indies; spent 42 months in Japanese prison camp; awarded Purple Heart and bronze star; held rank of corporal at time of his discharge, May 9, 1946.

BALLERSTEDT, ALBERT JOHN

Albert John Ballerstedt, son of Mrs. C. E. Ballerstedt, of Mabelle, Texas, entered the Army Jan. 28, 1943; sailed for the Pacific May 15, 1943, and spent five months overseas with the medical corps; held the rank of private at the time of his discharge October, 1943.

BALLERSTEDT, HERMAN W.

Herman W. Ballerstedt, son of Mrs. C. E. Ballerstedt of Maybelle, was inducted into Army Air Corps April 14, 1943; trained at Camp Wolters, Keesler Field, Miss., Buckley Field, Colo., Colorado Springs, Colo.; was given his discharge on Aug. 16, 1945.



**BALDWIN, ARTHUR FRANKLIN**

Arthur Franklin Baldwin, son of Mr. and Mrs. J. B. Baldwin, entered the Navy March 7, 1944; trained at San Diego, Calif.; sailed for the Pacific Oct. 19, 1944; spent 16 months overseas; served on a submarine with the 7th Fleet; was discharged Jan. 14, 1946.

BALDWIN, LEWIS E.

Lewis E. Baldwin of Seymour, son of Mr. and Mrs. J. A. Baldwin also of Seymour, was inducted into the service March 6, 1944; received training at Farragut, Idaho, Hawthorne, Nev., and Oakland, Calif.; was given an honorable discharge from the Navy in November, 1945.

BARBER, JACK CRISS

Jack Criss Barber, son of Dr. and Mrs. L. A. Barber, entered the Army Jan. 16, 1941; went overseas January, 1944; served 14 months in the ETO; fought in battles of Rome-Arno, Po Valley, and France; discharged June 8, 1945, as lieutenant.

BARBER, WILLIAM CLAUDE

William Claude Barber, son of Dr. and Mrs. L. A. Barber, entered the Army Oct. 30, 1944; received his training exclusively in Texas; sailed for overseas April, 1945; presently located in Nanking, China; holds rank of sergeant.

BARKER, ELMER WAYNE

Elmer Wayne Barker, son of Mr. and Mrs. C. E. Barker, entered the Army Feb. 6, 1942; trained in Camp Wolters, Texas, and Camp Murray, Wash.; sailed June 18, 1942, for overseas and served in the Aleutians and ETO; discharged after 32 months overseas with Infantry division.

BARKER, J. W.

J. W. Barker, son of Mr. and Mrs. John Barker; was inducted into the Army Aug. 13, 1942; sailed for overseas in August, 1943; served in Northern France, Ardennes and Rhineland with the Seventh Army; spent 29 months overseas; was a master sergeant when discharged Dec. 23, 1945.

BARKER, L. J.

L. J. Barker, son of Mr. and Mrs. C. E. Barker; was inducted into the armed forces Oct. 3, 1942; received training at Camp Wolters, Texas, Fort Sill, Okla., Camp Shelby, Miss., and Camp Polk, La.; was attached to the field artillery; received honorable discharge in September, 1943.

BARKER, LON W.

Lon W. Barker, son of Mr. and Mrs. George C. Barker, entered the Marine Corps on Nov. 13, 1943; trained at San Diego, Calif.; sailed for Pacific Nov. 25, 1944; fought on Okinawa and occupation of China; was given honorable discharge May 4, 1946.

BARKER, WADE T.

Wade T. Barker, son of Mr. and Mrs. C. E. Barker, was inducted into the Army July 10, 1942; trained at Camp Wolters, Texas, Camp Roberts, Calif., Fort Ord, Calif., San Carlos, Calif., Camp Lee, Va., and Fort Sam Houston, Texas; was honorably discharged from service Dec. 8, 1944.

BARTON, NORMAN A.

Norman A. Barton, son of Cleo P. Barton, was inducted into the Army December 3, 1941; received training in Virginia and Missouri before sailing to the Pacific January 20, 1945; was overseas 12 months; holds the rank of warrant officer and is now stationed in Aurora, Mo.

BARTON, ROBERT E.

Robert E. Barton, son of Cleo Barton of Wichita Falls, was inducted into the Coast Guard in May, 1942; received training at Mobile, Alabama, and New Orleans, La.; served as a machinist mate first class until his honorable discharge from the service in August, 1945.

BASKIN, ROBERT EDWARD, JR.

Robert Edward Baskin, Jr., son of Mr. and Mrs. R. E. Baskin, entered the Army on Feb. 21, 1941; sailed for ETO on Jan. 6, 1943; fought on Gustav Line, Battle of Rome, Gothic Line; served with infantry; was discharged with rank of lieutenant colonel on Feb. 19, 1946.

BECK, JAMES DALLAS

James Dallas Beck, son of J. A. Beck of Seymour, entered the U. S. Navy March 7, 1944; trained in Farragut, Idaho and San Diego, Calif.; served six months overseas at Subic Bay, Luzon Island; was given an honorable discharge from the service in December, 1945, while fireman first class.

BELKNAP, DAVID D.

David D. Belknap, son of Mr. and Mrs. T. J. Belknap, was inducted into the Navy May 11, 1944; received instruction at NTC, San Diego, California, and sailed for the Asiatic-Pacific sector July 17, 1944; 18 months overseas; received honorable discharge from the service Feb. 5, 1946.

BENHAM, HORACE B.

Horace B. Benham, son of Mr. and Mrs. M. G. Benham, entered the Army July 17, 1942; trained in Utah, Kansas, Texas and Maryland; sailed for ETO in April, 1945; spent eight months overseas; awarded two service stars, and one Bronze Star; was discharged Dec. 7, 1945.

BENHAM, ISHMAEL B.

Ishmael B. Benham, son of Mr. and Mrs. F. A. Benham; entered service Jan. 12, 1941; sailed for overseas June 6, 1944, and served with both Army and Navy in Ulithia, Philippines and Okinawa; spent 11 months overseas. received special commendation; discharged with 4.0 average.

BENHAM, JAMES ELMO

James Elmo Benham, son of F. A. Benham; entered Army Oct. 17, 1942; went overseas in March '43; served in North Africa, Sicily, Salerno, Anzio and France; was completely disabled near Rome June 28, 1944; awarded Distinguished Service Cross, Silver Star with two clusters, Purple Heart with four clusters.

BERRY, JAMES D.

James D. Berry, son of Mr. and Mrs. J. H. Berry, entered the Army March 6, 1944; sailed for ETO in March, '45; fought in the battles of Belgium, Czechoslovakia, Germany, and Rhineland; was awarded Presidential Unit Citation, and Bronze Star; spent 12 months overseas with Third Army.

BERRY, LAWRENCE LEE

Lawrence Lee Berry, son of Mr. and Mrs. J. H. Berry, entered the Army Sept. 21, 1942; trained at Stockton, Calif., Camp Pendleton, Ore., Walla Walla, Wash., Great Falls, Mont.; sailed for Pacific in August, 1943; 16 months overseas before being killed in action Dec. 6, 1944, on Leyte.

BIGGERSTAFF, ELMER S.

Elmer S. Biggerstaff, Seymour, Texas, was inducted into the armed forces on March 6, 1944. He was sent to Fort McClellan, Alabama, where he received his initial instruction and was stationed for the remainder of his army career. He was honorably discharged November 27, 1944.





BLACKBURN, HOLLIS CLIFTON
Hollis Clifton Blackburn, son of Mr. and Mrs. Eddie Blackburn, enlisted in the Navy Jan. 21, 1944; sailed for the Pacific May 28, 1944; participated in bombing raids over enemy territory for 19 months; was discharged Jan. 21, 1946, as a coxswain.

BLANKENSHIP, VAN EARL
Van Earl Blankenship, son of Mr. and Mrs. Goree Blankenship, entered the Army July 14, 1941; sailed for the ETO Sept. 5, 1943; fought in Normandy, Northern France, Ardennes, Rhineland, and Central Europe; spent two years overseas with First Army; discharged Oct. 4, 1945.

BLEDSOE, E. T.
E. T. (Bud) Bledsoe, son of Mr. and Mrs. T. A. Bledsoe; entered the Army Air Corps in January, 1943; trained at Stinson Field, San Antonio, Texas, during his entire Army career. He was hospitalized during his service, and received a medical discharge April 29, 1943.

BLEDSOE, HENRY H.
Henry H. Bledsoe, son of Mr. and Mrs. T. A. Bledsoe, was inducted into the Army May 19, 1942; received training at Camp Wolters, and Camp Roberts, Calif.; served with an infantry division; held the rank of private at the time of his honorable discharge in October, 1942.

BOONE, LEROY DAVIS
Leroy Davis Boone, Jr., of Seymour, son of Mr. and Mrs. L. D. Boone, entered the Army Air Corps Nov. 19, 1942; received training in Kansas, Texas, and Virginia; held the rank of second lieutenant at the time of his honorable discharge in October, 1945.

BOWMAN, WILLIAM MORGAN
William Morgan Bowman, son of Mr. and Mrs. W. M. Bowman, entered Air Corps Jan. 19, 1942; went overseas Aug. 31, 1942; participated in air offensive over Ploesti, Egypt, Libya, Tunisia, Naples, Foggia, Sicily, Ardennes, and others; was across 31 months; achieved rank of staff sergeant.

BOX, DON EUSTACE
Don Eustace Box, son of W. E. Box of Route 1, Seymour, was inducted into the Navy June 8, 1944; received training at various camps in the States; served with the Navy Armed Guard during his naval career; was discharged March 6, 1946, while a seaman first class.

BRADFORD, ALGIE HOLDER
Algie Holder Bradford of Farmington, N. M., son of Mr. and Mrs. T. G. Bradford of Wichita Falls, entered the Navy June 12, 1945; trained at Camp Decatur, Camp Loma, and San Diego, Calif.; held the rank of seaman second class when discharged Aug. 27, 1945.

BRADLEY, THURON D.
Thuron D. Bradley, son of Mr. and Mrs. William H. Bradley, entered the service Aug. 31, 1945; trained at Camp Lee, Va., Greensboro, N. C.; sailed Jan. 18, 1946, for Germany; served with the Ninth Air Force Division; is stationed in Holskirchin, Germany, at the present time.

BRADLEY, WILLIAM MARVIN
William Marvin Bradley, son of Mr. and Mrs. W. H. Bradley, was inducted into the Navy Feb. 27, 1943; received training at U. S. Naval Training Station, Farragut, Idaho; served with Company 175; was given honorable discharge from the service Sept. 7, 1943.



BRITTON, L. A.
Pfc. L. A. Britton, son of Mr. and Mrs. Barto Britton, was inducted into the Army Nov. 29, 1944; was sent to Camp Wolters, Texas, for training; sailed April 27, 1945, for ETO; spent 16 months overseas; is stationed in Germany at the present time with the Third Army.

BROCK, CURTIS LEE
Curtis Lee Brock, son of Mr. and Mrs. Paul Brock, entered the Navy June 17, 1943; sailed for the South Pacific Sept. 28, 1944; fought in battles of Saipan and Tinian; spent 16 months overseas; served with a supply base unit; was honorably discharged in December, 1945.

BROCK, GEORGE HAROLD
George Harold Brock, son of Mr. and Mrs. Paul Brock, enlisted in the Seabees Jan. 25, 1945; sailed for Point Barrow, Alaska, May, 1945; served there for 10 months, participating in the construction of air strips and roads; was given discharge from the service March 12, 1946.

BROCK, LEONARD ERIC
Leonard Eric Brock, son of Mr. and Mrs. T. E. Brock, of Seymour, entered the U. S. Naval Air Corps, Dec. 21, 1945; received training at Arlington and Athens, Ga.; was an aviation cadet at the time of his honorable discharge Sept. 25, 1945.

BROM, JOHNNY J.
Johnny J. Brom, son of Mr. and Mrs. Ben Brom, entered the Army Sept. 20, 1944; sent to the Pacific in February, 1945; took part in the battle for Okinawa; spent three months overseas with the 96th Division before he was killed in action on Okinawa, May 25, 1945.

BROOKRESON, DEE JAY
