





State Staffs and State Detachments are authorized by the Secretary of War under an Act of Congress, May 12, 1917. The purpose of the State Administrative Staff Corps is to constitute a nucleus of personnel for the administration, supply, mobilization and recruiting of the National Guard in both State and Federal service.



Gery. That part of the detachment located in Indianapolis has duties assigned chiefly with the administration of the Adjutant General's Office and is under the command of Major Ralph Gery.

Two officer vacancies exist in Indiana on the State Staff, by reason of the fact that the Adjutant General is in command of a Field Artillery regiment and the United States Property and Disbursing Officer is on the 38th Division Staff as Finance Officer. Regulations provide that these vacancies cannot be otherwise filled. The officers of the State Staff have been assigned the duty of completing all plans within the State for the rapid and successful mobilization of the National Guard in case of emergency. In addition to this they have completed the required courses assigned by the Joint Army and Navy Selective Service Committee and have submitted plans for recruiting prior to M-day. Coordination of effort in all branches of the service in Indiana is the desire of the Adjutant General and through the State Staff such an effort can be realized.

### ROBERT H. TYNDALL Major General

Commanding Thirty-Eighth Division

Major General Robert H. Tyndall enlisted as Private, F. A., Major General Robert H, lyndall enlisted as Private, F. A., in Battery A, First Indiana Artillery, November 15, 1897. He served during the Spanish-American War in the Twenty-seventh Battery, Field Artillery (Indiana Volunteers), as private. After returning to the States, he continued his service in Battery A, First Indiana Artillery, and was promoted through the non-com-missioned grades to First Lieutenant on April 18, 1902, and Captain on February 22, 1906. On December 29, 1913, he was promoted to the state of Major First Indiana Artillery, and com-

Captain on February 22, 1906. On December 29, 1913, he was promoted to the rank of Major, First Indiana Artillery, and com-manded this Battalion during the Mexican Border Campaign. Immediately after returning from the Mexican Border he started to build his Battalion to a Regiment. This was accom-plished and the Regiment became known as the First Indiana Regiment of Field Artillery, three-inch, which organization later became the 150th Field Artillery of the famous Rainbow Di-vision (42nd). Major Tyndall was promoted to the ank of Colonel, Field Artillery, and served as Commanding Officer of the 150th Field Artillery until the return of the Regiment to the the 150th Field Artillery until the return of the Regiment to the United States at the close of the World War. Indianapolis had

a real Hoosier welcome ready for their march through the city

a real Hoosier welcome ready for their march through the city on May 7, 1919. General Tyndall was awarded the American Distinguished Service Medal for his high technical attainments in the battles of Bacarrat, Champagne, Aisne-Marne, St. Mihiel and Muese-Argonne. He was awarded the French Legion of Honor, Rank of Commander, and the Croix de Guerre with two Palms on November 1, 1918, for skill and courage as an Artillery Colonel. Upon reorganization of the National Guard in 1921, Colonel Vyndall was given a State commission as Maior General and

Upon reorganization of the National Guard in 1921, Colonel Tyndall was given a State commission as Major General, and on March 16, 1923, he was given a Federal commission as Major General and assigned to command the Thirty-eighth Division, troops composed of Indiana, Kentucky and West Virginia. General Tyndall served as National Treasurer of the American Legion from 1919 to 1927. Through the period 1897 to 1938, General Tyndall has ren-dered forty-one years of distinguished service to both the Fed-eral and State governments. He has given unsparingly of his time and resources in furthering the cause of national defense. time and resources in furthering the cause of national defense.

#### FACTUAL HISTORY

The existence of a separately organized enlisted detachment at Division Headquarters is of comparatively recent origin, so an account of its activities, therefore, will be limited largely to a record of the Division Staff officers who, in addition to their other duties, have been assigned the exercise of administrative command. #### FACTUAL HISTORY

In the fall of 1923 Indiana was authorized to organize Headquarters Company, Thirty-eighth Division, and the "Service Club," a luncheon club of World War veterans of the city, acted as sponsors of the Company and assisted greatly in recruiting. The first group of officers were members of this club. The Company was mustered in and given Federal recognition July 7, 1924, with Capt. M. M. Hughel, First Lieut. Albert Hockensmith and Second Lieut. Clair Fosdick as officers. The Company's first field training camp was made at Fort Knox August 1 to 15, 1924, and thirty-two men from the Company attended. In 1926 the Company was divided into what is now

known as Headquarters Company and Headquarters De-

#### FACTUAL HISTORY

The earliest Signal Company of the Indiana National Guard was organized at Indianapolis about 1903 by Wallace Sherwood, who was commissioned a captain in 1907. This organization continued as founded until 1910, when the Indiana National Guard was reorganized as a skeleton division. Wallace Sherwood was appointed division signal officer with the rank of major and Capt. Edwin Abel was given command of the Signal Company. In the latter part of 1913 the Company was reorganized by Horace F.

Hill, Jr., who became its commanding officer. In the fall of 1914 the Company was again reorganized, with Capt. Henry G. Hoss in command. The Signal Com-

pany was called into Federal service and served on the Mexican Border during 1916. When the United States entered the World War, the Company was once more called into Federal service. In September, 1917, Signal Company "A" of Indiana and Signal Company "B" of Kentucky were organized as the 113th Signal Battalion, forming part of the Thirty-eight Infantry Division. These two Signal Companies formed the nucleus for Company "C", and as such completed the 113th Signal Battalion. Company "A" was commanded at this time by Capt. Norman A. Nicolai, who is now Signal Officer of the Thirty-eighth Division. With the reorganization of the army in 1920, the Battalion was dissolved and the Thirtyeighth Signal Company was organized and stationed at Gary, Ind.

In June, 1924, the Company was moved to Indianapolis and reorganized under Capt. Homer W. Hyatt. In 1927

the Signal Company moved into its first real Armory. A the activities of the Signal Company continued to expan-a new Armory became necessary. This new Motor Armor was completed and occupied in May, 1937. In February, 1938 the Signal Company was authorized a strength of six officers and 83 enlisted men, its present strength. Now commanding the unit is Capt. Lawrence H. Brink.





Wide Awake - Wide Awake

Through historical data obtained from various sources, it is evident that the 151st Infantry is entitled to claim its descent from the regiments of the Indiana Militia known variously as the First Infantry, First Regiment Indiana Legion, First Veteran's Regiment Indiana Legion, First Volunteer Infantry and so forth. It can trace its military activities back to the Indian campaigns of the War of 1812, the Mexican War of 1846, the Civil War, the Spanish-American War, and of course, in later years, Mexican Border service and the World War.

The motto "Wide Awake—Wide Awake", adopted by the 151st Infantry and approved by the Secretary of War for use on the regimental coat of arms, was used by the American force during the night immediately preceeding the Battle of Tippecanoe. The force was under command of General William Henry Harrison, afterwards President of the United States.

Following the Mexican War, there appears to have been a disintegration of military organizations within the State of Indiana. Records of the period between the Mexican War and Civil War relative to the Indiana Militia are incomplete, and organization by regiments is not definitely established. However, data obtained from families of early settlers and from military histories indicates that some organizations of the Indiana Legion were taken as units in Civil War regiments. After the Civil War, the State Militia was very defectively organized. Numerous independent military organizations are mentioned during the years immediately following the War. In 1877, the First Regiment Indiana Legion was organized by Adjutant General George W. Russ, from independent existing compani The regiment was reorganized June 12, 1882, and designated the First Veterans' Regiment, Indiana Legion.

At the outbreak of the Spanish-American War the regiment consisted of eleven companies, but an additional company was organized at Vincennes, and assigned to the regiment. The regiment then entered the United States service as the 159th Indiana Volunteer Infantry.

The First Regiment, Indiana National Guard, was the third regiment to enter the service in the Spanish-American War. Its commanding officer was permanently injured while in camp and owing to the delay the regiment was compelled to give up its arms and equipment to supply the two regiments which preceded it in the service. It was mustered into United States service May 12, 1898, and left Camp Mount, Indiana, May 22, 1898, for Dunn Loring, Virginia, arriving there May 24, 1898, leaving the same day for Camp R. A. Alger, where it was assigned to the Second Army Corps. It moved to Camp Meade, Pennsylvania, August 28, 1898, remaining there until September 11, 1898, when it was ordered to Camp Mount, Indiana, arriving on September 13, 1898, and was mustered out on November 23, 1898.

After its reorganization following the Spanish-American War, the regiment remained in State service, with only minor changes, until it was mobilized for service on the Mexican Border in 1916. It was stationed at Llano Grande, Texas, and was on outpost duty at Progresso and Dona Pump, on the Rio Grande River. The regiment was mustered out of service March 14, 1917, and reverted to its former State status.

On July 17, 1917, the First Indiana Infantry was drafted for World War service, and redesignated the 151st Infantry. The regiment was commanded at Fort Harrison by Col. Emmett F. Branch, but when the outfit moved to Camp Shelby, Colonel Branch, due to a severe illness, was (Continued on page 56)

replaced by Lieut.-Col. George H. Healey who commanded the regiment until its demobilization in France. The regiment did not participate in any battle as a unit, but a large part of its officer and enlisted personnel saw service as replacements for other units. The 151st Infantry returned to the United States in the cadre of the Thirty-eighth Division and was disbanded at Camp Taylor, Kentucky, March 8, 1918.

The present 151st Infantry was reorganized in 1921 and received Federal recognition June 30, 1921. Col. D. Wray DePrez commanded the regiment from the date of its reorganization until his promotion to Brigadier General, May 2, 1932. Col. Paul A. Seiberling was placed in command June 6, 1932, and was followed by the prezent commanding officer, Col. Albert H. Whitcomb.

Probably the most outstanding State duty, in which the regiment has taken part, was the call for flood duty along the Ohio River, in 1937. The entire Indiana National Guard was called for this service. The 151st Infantry established Headquarters at Aurora, Indiana, with units on duty at various points from Lawrenceburg to Evansville. The efficient work of the regiment during this duty, was highly commended by officials of cities in which its units served, and the untiring efforts of the officers and enlisted personnel to assist flood refugees and guard their property, has won for them the confidence and gratitude of the entire population of those cities.



The Howitzer Company, 151st Infantry, was organized and Federally recognized at Wabash July 1, 1930, with Capt. Ernest W. Scheerer, First Lieut. Maurice E. Price and Second Lieut. Carl F. Hoefer as officers. The peacetime

strength of the Company is three officers and 63 enlisted men. Of the original roster three officers and ten enlisted men are still with the Company—the officers and four of the enlisted men having had continuous service.

The same Officer Personnel that founded the unit is still in command. The Company was called out on State service to quell a civil disturbance in Madison County February 13, 1937, and was mobilized for duty during the flood emergency of the same month.

The Howitzer Company is a special infantry unit that has come into existence since the World War, consisting of a Company Headquarters and three combat platoons, and serving directly under the Regimental Commander. Principal weapons of a Howitzer Company are the 37 mm gun which is a very accurate low trajectory weapon with a sighting range of 1,800 yards, and the 3-inch Stokes trench mortar, a weapon having a high angle of fire and a max-(Continued on page 320)





#### FACTUAL HISTORY

Company "B," 151st Infantry, was organized and Federally recognized June 24, 1921, as Company "L," 151st Infantry, after a petition of the citizens of Greensburg, Indiana had been sent to the military authorities urging the assignment of a National Guard unit to Greensburg. The officers of the new Company ware Capt. Phillip B. Stapp, First Lieut. Sanford S. Starks and Second Lieut. Charles F. Marlin. Approximately 30 per cent of the enlisted personnel were ex-service men, and the equipment was supplied mostly from unused World War issue. The Company's training for the first year stressed efficient organization, physical condition of the individual and the handling of arms in actual firing.

On November 4, 1921, the Company was called to Indianapolis to parade for Marshal Foch, Commandant of

the Allied armies in Europe and under whom some of the man had served. The parade was made in civilian clothes.

The Company's designation was changed from Company "L" to Company "B" early in 1922. The original Company "B" had been organized on June 15, 1921, at Flora, Indiana. On June 15, 1922, Lieutenant Starks was advanced to Captain and Company Commander, and Ross W. Reed was appointed Second Lieutenant. From August 2 to August 19, 1922, Company "B" served at Stanton during a coal miners disturbance.

Lieutenant Reed was commissioned Captain and given command of the unit January 15, 1924, and Lieutenant Eckert was commissioned First Lieutenant January 18, 1924. Wallace H. Davis was commissioned Second Lieutenant on June 14 of the same year. The personnel of the Company at this time was authorized at more than 100 men.

In 1930 command of the Company was given Harry R. Piles, and during the same year First Lieutenant Eckert

resigned his commission to join the state police force. In July, 1932, Company 'B" was detailed to the Busy Bee Mine for strike duty, and in 1935 was called out to protect lives and property at Terre Haute during civil disturbances. In the 1936 encampment Company "B" participated in perhaps the greatest peacetime maneuver of the United State's history. In 1937 the Company served at Lawrenceburg during the flood of the Ohio river.

#### FACTUAL HISTORY

Company "D," 151st Infantry, was originally organized in 1888 as a part of the regiment which was then known as the First Regiment of Infantry, Indiana Legion. The Company was a militia unit and under laws governing militia companies received no financial support either from the state or national government. A record of its early activities is not at hand, but it is known that Company "D" was called out in June of 1894 for strike duty, and during the next month for a railroad strike.

At the call for troops April 25, 1898, upon the outbreak of the Spanish-American War, Company "D" of the First Regiment was among the first to offer its services to the government. The unit was mustered into service May 12, 1898, and entrained for Camp Alger, Va., where it remained until August 3, 1898. The Company was stationed at several other camps in the United States, but never left for Cuba.

The National Guard was reorganized after the Spanish-American War, March 1, 1898, and Company "D" was once again recognized as a unit of the First Indiana Regiment. disbanded, By 1915 the First Regiment w actically

several of its units having been mustered out of service owing to the withdrawal of Federal support. Company "D," however, remained intact, and was transferred to the Second Indiana Regiment of Infantry, National Guard. At the outbreak of armed hostility between the United States and Mexico, the First Indiana Infantry had ceased to exist, but at the President's call June 19, the Regiment was reorganized at Fort Benjamin Harrison and Company "D" was formed with men from Indianapolis and Danville. Under the command of Capt. Paul F. Stutzman the Company entrained for the Border, arriving at Llano Grande, Texas, July 16, 1916. The Company was mustered out of service March 14, 1917.

When the United States entered the World War, the Indiana National Guard was held in readiness for action which was not long to be deferred. Company "D" was finally stationed at Camp Shelby, Miss., and was built up to a wartime strength of 250 men. In June, 1918, a draft of 69 men from Company "D" was sent overseas as replacements in the First Division. Company "D" as a Com-

pany saw no action in the war, but many of its members were used as reserves in other combat units. The officers of the Company during the World War were Capt. James W. Hurt, First Lieut. Chas. A. Cassady, and Second Lieuts. Frank Mimmick and Howard B. Dewees, with Second Lieut. Eugene P. Wilkerson attached.







#### FACTUAL HISTORY

Company "E," 151st Infantry, was organized July 8, 1921, at Darlington as Company "K," 152nd Infantry. The unit was Federally recognized on September 20, 1921, with Capt. Hector Hamilton, First Lieut. Norman L. Thompson and Second Lieut. D. C. Wray as officers. On January 1, 1922, however, Company "K," 152nd Infantry, was redesignated Company "E," 151st Infantry. Capt. Hamilton resigned his commission on June 15, 1922, and First Lieut. Thompson was promoted to his post as Captain. Second Lieut. Wray was made First Lieutenant at the same time, and First Sgt. Alva C. Warren was promoted to Second Lieutenant.

Warren was transferred to Headquarters, 151st Infantry, June 1, 1938, and Sgt. Clyde F. Reese was appointed Second Lieutenant and assigned to Company "E," 151st Infantry, on June 8, 1938.

The Company performed strike duty at Staunton, Clay City, Jasonville and Patricksburg in 1922; at the Dixie Bee Mine and Jasonville in 1932; at Terre Haute and New Albany in 1935, and at Anderson in 1937. The Company was on duty at Jeffersonville and Aurora during the flood in 1937. Each year Company "E" takes an active part in







# FACIUAL HISTORY

Company "G," 151st Infantry, stationed at Delphi, was organized September 23, 1921, as Company "F," 152nd Infantry, and it was not given the designation it now bears until a statewide reorganization of the National Guard sometime later caused it to be redesignated as Company "G," 151st Infantry. The officers of the unit at the time of its organization were Capt. James A. Wheelan, First Lieut. Floyd Julien, and Second Lieuts. Vernie Brown and Leo Ulm. The Company's enlisted strength was 78 men.

# FACTUAL HISTORY

Headquarters Company of the Third Battalion, 151st Infantry, is an outgrowth of Company "D", 151st Infantry, which was organized at Spencer, Indiana on May 13, 1913. The first officers of the new Company were Capt. James F. Robinson, First Lieut Levi A. Beem and Second Lieut. Sam E. Dunn, After a rapid turnover in officer personnel Sgt. Joseph C. Clark became captain of the



until June 19, 1916, upon which date he was promoted to Major of the First Battalion, 151st Infantry.

Shortly after the Company's organization in 1903, it was called out to quell a race riot in Evansville. There was no further state duty for the Company until the Indianapolis street car strike of 1913. On June 19, 1916 the unit was ordered to the Mexican Border as Company "D", 152nd Infantry, under command of Capt. Levi A. Beem. The Company was mustered out of Federal service in March, 1917, but 30 days later at the entrance of the United States into the World War, it was ordered to Jeffersonville, Indiana, to guard the Quartermaster depot. The Company was eventually sent to Camp Shelby, Mississippi for training, and served overseas under Capt. Bart McGuire as Company "D", 152nd Infantry.

Upon the reorganization of the National Guard following the World War, a field artillery unit at Spencer received Federal recognition on June 23, 1921. On January 14, 1937 the unit was converted from Headquarters Battery and Combat Train, Third Battalion, 150th Field Artillery, to Headquarters Company of the Third Battalion, 151st Infantry. Prior to its conversion, the Battery was commanded by Capt. Lewis E. Hubbard. First Lieut. William E. Treadway, a former Reserve Officer, was appointed to command the new organization. Robert H. Baumgartner was appointed second lieutenant of the Company on December 27, 1937.

From January 26 to February 8, 1937, the Company was stationed at Aurora, Indiana, to do relief work during the Ohio river flood.

# FACTUAL HISTORY

Company "I," 151st Infantry, was first organized in 1903 from the old "McKeen Cadets," which was a semi-military, social group dating back to 1878. The present Company carries the traditions of the McKeen Cadets and of Company "B," Second Indiana Infantry, its official designation from 1903 to June, 1916, when it was called to the Mexican Border for Federal service.

# FACTUAL HISTORY

Company "K," 151st Infantry was organized April 23, 1898, in the courthouse of Martinsville, Indiana, as a unit of the First Infantry Regiment, Indiana National Guard. Its organizer was Grant S. Monical. The following week the Company was mustered into Federal service as Company "K," 158th Volunteer Infantry, to serve for the duration of the Spanish-American War. After spending six months at Chickamauga, Tennessee, the Company was mustered out of Federal service November 4, 1898. Immediately following the Spanish-American War, the

Company was reorganized by Emmett F. Branch as Company "K," First Regiment, Indiana National Guard. This organization remained in the state's service until 1916. On June 19, 1916, the Company was mobilized, with Capt. L. A. Harriman in command, and in July was mustered into Federal service as Company "K," First Indiana Infantry, serving nine months on the Mexican Border.

On August 5, 1917, the Company was again mustered into Federal service as Company "K," 151st Infantry, with Capt. William Waters in command. Company "K" trained at Camp Shelby, Mississippi, and went overseas in October, 1918, with the Thirty-eighth Division. In 1921 when the Indiana National Guard was reorganized, this Company was for a short time designated as Company "F," 151st Infantry, but was soon redesignated Company "K," 151st Infantry.

Members of this organization who have risen to places of honor in the Army are Col. George D. Long, recognized for his gallant service in the Philippines; Emmett P. Branch, who later became Lieut. Gov. of Indiana; Col. Jarvis J. Bain, who became a distinguished engineer in the Army; Maj. Grant S. Monical, a famous surgeon during the War; and Maj. Willis Hedden, a marksman in the Army.

turbances, acting as a guard for President Roosevelt's party during the dedication of the George Rogers Clark Memorial at Vincennes, Indiana, and the flood duty of January and February, 1937. The Company was on duty nineteen days at Evansville during the flood emergency.

For the first four years of its organization the Company was greatly handicapped by a lack of proper housing facilities, as the Armory it then occupied was quite inadequate in size and appearance for drill or social

The 152nd Infantry, Indiana National Guard, was organized in 1882 as the Second Regiment, Indiana Legion, made up of existing companies which at that time were designated as Indianapolis Light Infantry, McKeen Cadets, Evansville Rifles, Richmond Light Guard, Sherman Guards, Waterloo Rifles, McCune Cadets, Remington Guards, South Bend Light Guards, Miller Grenadiers, Pulaski County Blues and the Lebanon Rifles.

In 1895 the designation of the Regiment was changed to Second Infantry, Indiana National Guard. It was mustered into Federal service for the Spanish-American War in May, 1898, as the 158th Infantry, Indiana Volunteers. The Regiment served within the continental limits of the United States and was mustered out of Federal service in November, 1898. It then resumed its station as Second Infantry, Indiana National Guard.

The Second Infantry served on the Mexican Border from June, 1916, to February, 1917.








# FACTUAL HISTORY

The lineage of the Headquarters Company, 152nd Infantry may be traced back to July 16, 1877, when the Indiana Light Infantry was organized and mustered into the Indiana Legion with a strength of 73 officers and enlisted men. Many of its organizers were veterans of Eleventh Indiana Regiment of the Civil War. With the organization of the Second Regiment, the unit was assigned and designated as Company "A", Second Regiment, Indiana Legion.

Upon the expiration of its term of service, Company "A" dropped out of state service on July 16, 1884, but continued its existence as an independent organization. In



1889 the organization decided to re-enter state service and was accordingly assigned to the Second Regiment as Company "D", on July 15, 1889.

On May 10, 1898 the unit was mustered into Federal service for the Spanish-American War as Company "D", 158th Regiment of Infantry, Indiana Volunteers. The Company served only in the United States and was mustered out of Federal service in November, 1898. It was reorganized as the Third Separate Company and re-entered the service of the state on April 12, 1899. When the Regiment was reorganized, the unit received its former designation.

From June, 1916 until February, 1917 the Company served as a unit of the Second Regiment on the Mexican Border, and during the World War served as a unit of the 152nd Infantry, Thirty-eighth Division, but did not

participate in combat. In May, 1919 the organization was disbanded at Camp Taylor. Kentucky. The unit was reorganized as Headquarters Company, 152nd Infantry and again received Federal recognition on October 18, 1921. Its present strength is two officers and 62 enlisted men. The present officers are Capt. John S. Buck and Second Lieut. Jean G. Callahan.







# FACTUAL HISTORY

The men responsible for forming the Company and recruiting members were Capt. Ethan Allen Fulton, Leo L. Maxwell, Owen C. Ruley and Paul E. Elliott. The commanders of the Company have been Capt. Harold Bynon, (1921); Capt. Owen C. Ruley.



The Howitzer Company, one of the four National Guard units located in Portland, first used an inadequate second story storeroom as its Armory. In 1923 the present Armory was built by Morris Weiler, and this immediately became the home of Howitzer Company, 152nd Infantry. It was shared by the other units in Portland; namely, Service Company and Band Section, 152nd Infantry, Howitzer Company, 151st Infantry, and the Medical Detachment, 139th Field Artillery. At present only the Medical Detachment and the 152nd Infantry Howitzer Company remain in Portland. The Armory was purchased by the state of Indiana in 1934, and many improvements have

#### FACTUAL HISTORY

Company "C," 152nd Infantry, was Federally recognized at Salem, Indiana, October 4, 1921, with a strength of three officers and 75 enlisted men. The unit was commanded by Capt. Byron R. Colglazier, and Junior Officers First Lieut. Ira H. Van Cleave and Second Lieut. Luther C. Brown.

In January, 1924, a group of seventeen men was recruited at Vallonia and held split drills on Thursday nights under the supervision of the Company Commander. On June 2, 1925, Capt. Colglazier was promoted to Major and assigned to command the Second Battalion, 152nd Infantry, and First Lieut. Van Cleve was appointed Captain June 9, 1925, and Second Lieut. Freeman H. Hinds was promoted to First Lieutenant. In 1926 Second Lieut. Loren H. Brewer attended the Infantry School at Fort Benning, Georgia. On September 5, 1927, while in command of a guard detail at the Indianapolis Motor Speedway. Captain Van Cleave was struck and killed by the wheel of a speeding racer. First Lieutenant Hinds was promoted to Captain on October 26, 1927.


SALEM, INDIANA

The Company was ordered into State service for strike duty and served at Terre Haute for a period of three days during August, 1932. Lieutenant Brewer was ordered to State duty from August 15 to December 24, 1932, and assigned to provisional battalion at Shakamak Park as Supply Officer. Thirty enlisted men commanded by Lieutenant Brewer were again in State service for strike duty at Terre Haute, from July 22 to July 24, 1935. On November 30, 1935, Captain Hinds resigned and First Lieut. Delbert D. Cornwell was appointed Captain February 1, 1936.

On January 20, 1936, a detachment of Company "C," commanded by First Lieutenant Cornwell, was ordered to New Albany and Jeffersonville for strike duty. This tour of duty lasted three days. On June 14, 1936, three officers and 42 enlisted men formed part of the Guard for the visit of the President at Vincennes, and again at Indianapolis on September 13. Three officers and 55 enlisted men were in active service at Jeffersonvivile during January and February, 1937, on flood duty, and two days after returning from that duty, the Company was called out to Anderson for strike service. At the 1936 annual summer encampment Company "C" was awarded the General George H. Heely Cup for the best Company in the 152nd Infantry Regiment.







#### FACTUAL HISTORY

Company "E," 152nd Infantry, was first organized at Kokomo, Indiana, in 1903 as Company "E," Second Regiment, Indiana Infantry, and under that designation served on the Mexican Border in 1916. The Company was called out for World War service shortly after its return home after the Mexican Border campaign, and in 1919, following the War, Company "E" was returned to its State militia status.

On September 23, 1921, the Company was reorganized at Lafayette as Company "E," 152nd Infantry, Indiana National Guard, commanded by Capt. Daniel H. Bolinger. On April 15, 1927, it was transferred to Tipton and reorganized under the command of Capt. Jesse E. McIntosh.

Company "E," since its reorganization as a National Guard unit, has not been in Federal service other than annual summer field training at Fort Knox, Kentucky. Its State service, however, has been extensive. In July, 1932, the Company was among a group of five companies that assembled at Terre Haute and then traveled to the Dixie Bee Mine to rescue a band of miners imprisoned in the mine by angry citizens. Company "E" served three days at the mine. On August 22, 1932, the Company again returned to the mine and established camp at Shakamak National Park, not being released from duty until September 8, 1932. Company "E" returned to State service from July 22, 1935, to July 31, 1935, serving at Terre Haute. On January 25, 1937, the unit was sent to Evansville on flood

#### FACTUAL HISTORY

The organization of Company "F," 152nd Infantry, was started early in 1930, by Capt. Duke V. Atwood, and was mustered in on March 5, 1930, by Capt. Robert Jones. Lieut. Byron L. Stewart, O. R. C., Infantry, was appointed First Lieutenant and Lieut. Edward E. Kaigi, O. R. C., Artillery, was appointed Second Lieutenant. Harry Vernon was made First Sergeant October 1, 1931.

Lieutenant Stewart commanded the Company during the 1932 field training period while Captain Atwood was serving a tour of duty at the Dixie Bee Mine. On its return from camp, the Company was called out for strike duty at the mine. Captain Atwood was again absent from the Company from February 21, 1933, to June 1, 1933, attending the Infantry School at Fort Benning, Georgia, and First Lieut. Stewart filled his place as Commanding Officer.

#### FACTUAL HISTORY

Company "G," 152nd Infantry, was organized and Federally recognized as Company "A," 151st Infantry, on April 27, 1921. Officers of the Company were Capt. Eugene Lathe and Second Lieut. Fred Sharp, but Captain Lathe resigned on June 5, 1921, and his place was taken by Lieut. Glenn Williams, who was promoted to Captain, November 11, 1921.

Company "A" was redesignated Company "G," 152nd Infantry, January 1, 1922. On September 30 of the same year Captain Williams resigned and First Lieut. Murry Smith assumed command of the unit until the appointment of Capt. Jacob J. Pfenninger, R. O. C., on November 11, 1922. Captain Pfenninger resigned his commission October 31, 1925, and was succeeded by First Lieut. Harry M. Turpin. Lieutenant Turpin received his Captain's commission January 11, 1926, and in February of the next year he attended the officer's course at the Infantry School, Fort Benning, Georgia.



#### FACTUAL HISTORY

Company "H" was organized and Federally recognized as a National Guard unit on October 20, 1921, at Windfall, Indiana. Capt. Albert C. Reeder and First Lieut. Loyd E. Landon were the organizers of the new Company. Within a few months it was evident that Windfall was too small a community to support a National Guard unit, and since the organization of such a unit was underway in Anderson, Company "H" was mustered out of service at Windfall and its records and equipment transferred to the new unit at Anderson. The Company received its Federal recognition at Anderson February 23, 1922, Esmond P. Hershberger, later commissioned Captain, serving as Company Commander. His Junior Officers were First Lie. Frank S. Burroughs and Second Lieut. Walter C. Kegere The enlisted personnel of the new Company was made a largely of ex-service men.

position in California and the death of Lieutenant Kegereis were chiefly responsible for a heavy turnover in officers and enlisted personnel. First Sgt. Raymond G. Swinford was commissioned First Lieutenant November 15, 1922, and Julius Lawson was commissioned Second Lieutenant January 16, 1923. There was no further change until the resignation of Lieutenant Lawson April 12, 1923. His place was not filled until December 31, 1924, when First Sgt. Cecil C. Closser was commissioned Second Lieutenant. On March 17, 1924, Captain Hershberger resigned and Elmer D. Goss, a World War veteran, was commissioned Captain and assigned to command the Company. Lieutenant Closser was given command of the Company July 30, 1928, when Captain Goss was promoted to Major.

#### The Company has been called into service five times uring its history. In 1932 it was detailed to Terre Haute and to Shakamak State Park during a coal miners strike and to Terre Haute again in 1925 during labor trouble. In 1936 the Company was called to Indianapolis when President Roosevelt visited the State, and during the Southern Indiana floods the Company served at Evansville. Company "H" has been stationed in its present Armory since February, 1929.





#### FACTUAL HISTORY

Headquarters Company of the Third Battalion, 152nd

Infantry, received Federal recognition as Headquarters

Gochen, Indiana, on May 23, 1921. In January of 1922 the unit was redesignated Headquarters Company of the Third Battalion, but was transferred to the 152nd Infantry. Its first Commanding Officer was Lieutenant Inebnet, who was succeeded by Lieut. Rance E. Snowberger. Lieutenant Snowberger resigned October 15, 1924, and after several other changes in officer personnel the unit was disbanded at Goshen June 29, 1929.

The unit was reorganized and Federally recognized July 1, 1929, at Fort Wayne, with First Lieut. J. H. Stark, Commanding, and Second Lieut. R. L. Hupp, Communications Officer, and advanced rapidly under the instruction of Sgt. Manis, the Regular Army instructor at Fort Wayne.

From August 9 to 11, 1930, Lieutenant Stark assisted the Regimental Commander as a one-man Regimental Staff in quelling a race riot at Marion. On April 2, 1935, First Lieutenant Stark was appointed Captain in command of newly designated Company "M," and Second Lieutenant Hupp was appointed First Lieutenant in command of Headquarters Company. Staff Sgt. J. F. Davis was appointed Communications Officer. On January 25, 1937, the Company was mobilized for flood duty and billeted at the Indianapolis Motor Armory to await possible emergency duty. On February 11, 1937, the Company was ordered home. From June 30, to July 1, 1937, Headquarters Company was mobilized for threatened violence in Whiting labor difficulties, but did not leave its home station.
