
HUGH WHITE GOVERNOR



CAMP SHELBY

Major General Blanding, Brigadier General O'Keefe and Some Officers of Mississippi National Guard Located approximately twelve miles south of Hattiesburg, Mississippi, Camp Shelby was named during the World War in honor of the first Governor of Kentucky, Col. Isaac Shelby. Born in Maryland, Colonel Shelby, as a member of the Virginia Militia, distinguished himself at King's Mountain, 1780, and in the South Carolina campaign, 1781. As the first governor of Kentucky, he received the thanks of Congress for the Battle of the Thames, 1813.

Named in his honor, this camp was the training quarters during the World War for the Thirty-eighth Division. More than 36,000 men trained here. It was the healthiest large or divisional camp in the United States, having the lowest death rate of any.

#### FACTUAL HISTORY

Company "K," 148th Infantry was Federally recognized in September 1907, as Company "K," Second Ohio Infantry, under the command of Capt. Charles Mooney. The Company was called into Federal service for action on the Mexican Border July 5, 1916, and was mustered out of service March 28, 1917.

On June 15, 1917, the Company was recalled to the service for duty overseas. Its designation at that time was Company "B," 147th Infantry, and as such

it saw service at St. Mihiel, Ypres-Lys, Meuse-Argonne and the Alsace-Lorraine offensive. The Company was released from the service in May 1919.

During the next few years the Company underwent numerous changes in its designation. It became Company "K," Second Infantry June 23, 1919; Company "K," Third Infantry August 2, 1920; Headquarters Company, Third Battalion, 148th Infantry July 1, 1921, and Company "K," 148th Infantry April 1, 1922.

Company "K" was the first company of the Ohio National Guard to be organized after the World War Emil F. Marx, the present Adjutant General of Ohio organized the Company and became its first commanding officer.

land, the property of the State of Mississippi. The State purchased it in 1935 when Camp Shelby was again established as a training camp.

The camp proper is constructed on rolling ground, welldrained, with a good system of roads. Four of the old warehouses of World War construction, as well as part of the old sewerage system used by the Base Hospital during the war, are still in use. It is a regimental camp, and most of the permanent buildings are of brick construction. Ample warehouse facilities are available, as well as ordnance magazines for the storage of ammunition of all kinds. There is an abundance of good water, with a deep well, and water tank and water distribution system.


The regimental layout is complete with the exception of the sixteen mess halls and kitchens, now under construction, and a regimental headquarters building and officers' mess. Concrete tent floors, with underground lighting, add to the convenience of the officers and men. More than 800 trees have been planted since the establishment of the camp in






The State Staff consists of nine officers, including the Adjutant General, the Executive Officer and Assistant Adjutant General, the Inspector General, the Constructing Quartermaster, and the United States Property and Disbursing Officer. The balance of the officers of the State Staff are assigned various duties in connection with property, messing, and matters pertaining to medical care and camp sanitation. In addition to their duties in their respective branches, the officers of the State Staff are studying the laws and working of the Selective Draft, so as to be able to aid in mobilization in case of a national emergency.

The State Detachment, given Federal recognition May 1, 1928, consisting of eleven enlisted men, is divided into two sections: the Adjutant General's section and the United States Property and Disbursing Officer's section. These sections (Continued on page 4)






With 171 men being trained in its ranks since its Federal recognition on December 12, 1924, as Headquarters Company, Third Battalion, 155th Infantry, this unit has served continuously under Captain Talmage B. Tubb, who as a Lieutenant organized it in November, 1924. The unit was redesignated as Headquarters Company, Sixty-First Brigade, on February 26, 1925.

The personnel includes four graduates of the Enlisted Men's Communication Class, Infantry School, Fort Benning, Georgia, while thirteen have the four-year longevity medals. Thirteen non-commissioned officers have an average enlistment of eight and one-sixth years.

Second Lieutenant Ira B. McCullen, who served until January 1, 1930, and assisted in the organization of the Company, was succeeded by Second Lieutenant Keith I. Allen. Sergeant Connie G. Gideon has been a member of the Company since its organization.

The Company served on storm duty at Tupelo from April 6 to April 30, 1936. It has received special commendations in thirteen of fourteen annual armory inspection reports.



### ONE HUNDRED AND FIFTY-FIFTH

Now older than the State of Mississippi and seventh oldest infantry regiment in the United States, the First Mississippi Regiment was handed its first commission, through Daniel Clark as Colonel, on June 1, 1799, by Winthrop Sargent, territorial governor of Mississippi.

It was there in preserving order and establishing stable government when the Magnolia State came into the Union.

Having a memorable part in six wars, the Regimental Color streamers speak eloquently and heroically of more than one hundred years of service during the Indian Wars, War of 1812 with Battle of New Orleans, Mexican War, Civil War, Spanish-American War, and World War.

Under act of Congress, May 13, 1846, one regiment was authorized for each state, to participate in the Mexican Campaign. Mississippi soon saw her unit duly organized with Jefferson Davis in command. He resigned his seat in Congress and joined the regiment in service for the Mexican War. He insisted that the regiment be equipped with rifles. Before reaching Mexico, the old Whitney rifles were issued to his men. From then on the regiment was famous as "The Mississippi Rifles." Memorable was their charge on Monterey where its gallant McClung was wounded.

At Buena Vista, February 22, 1847, Mexicans outnumbered the Americans five to one. American troops were fleeing or falling back in defeat. General Taylor in that dark moment ordered up Jefferson Davis with his First Mississippi Marching quickly into the assault, Davis gave but one order: 'Stand fast, Mississippians.' History was made that day. Other regiments quickly formed with the First Mississippi and drove the Mexicans from the field. "Stand fast" are the words emblazoned today on the regimental shield.

In the Civil War, battle service was seen in heated engagements in Kentucky, Tennessee and other points.

In the Spanish-American War, the regiment was in training at Chickamauga, awaiting orders for action.

In the World War, training was at Camp Beauregard and overseas to Brest.

It was the occasion of the World War that brought an additional name to the regiment. The First Mississipp' Regiment in addition to its original designation was named 155th Infantry in the Federalized National Guard on September 27, 1917.

Col. Geo. C. Hoskins, the first commander of the newlynamed "155th Infantry" was ordered to Fort Sam Houston, Texas, for duty, and Maj. Geo. E. Hogaboom was placed in command. On August 3, 1918, the regiment entrained for overseas and was landed at Brest, France. The regiment did not see action as an organization, but its personnel was transferred to other units and many of its members were in combat before the Armistice. Colonel Hogaboom was transferred to the A. E. F., North Russia, Assistant Chief of Staff G-1. The skeleton organization of the 155th Infantry returned to the United States September, 1919.

Following the World War, several years of inactivity followed. In 1920, the First Mississippi Infantry reorganized and on December 14, 1921, the regiment was again

# FACTUAL HISTORY

This unit was organized in February, 1922, and Federally recognized as Headquarters Company, 155th Infantry, on April 13, 1922, with Capt. Charles F. Barr commanding and Robert G. Saxon as Second Lieutenant. The personnel was recruited from Meadville and surrounding communities, some men coming from considerable distances.

A small room in the basement of the county jail was used as a store room, and the drill ground was the County court yard lighted by gasoline lanterns. In 1925,

with the cooperation of the Board of Supervisors, an Armory was built. Each member of the organization contributed one drill period per quarter to the building fund out of their pay to supplement that of the Board. In 1925, the organization was redesignated Company "A," 155th Infantry.


Changed from a headquarters company to a rifle company, the task of building a rifle range was begun. Application for funds was made, and in 1928 the first unit-owned range in the State was completed and used. In 1929, the organization won the National Trophy for rifle marksmanship and repeated each year for the next three years.

# FACTUAL HISTORY

Participants in several emergency calls, Company "D," 155th Infantry, has also distinguished itself since its organization on August 30, 1927, by winning six of eight trophies presented by the Adjutant General for the highest percentage score in machine gun marksmanship, gaining the cup in 1931, 1932, 1933, 1934, 1936, and 1937.

Capt. Leslie L. Evans, 1929 graduate of the Infantry School, Fort Benning, Georgia, who organized the Company at Kosciusko, was also placed in command when the Company was transferred to Canton. First Lieut. Elliott A. Stokes and Second Lieut. Henry R. Sanderson assisted him.

First called for emergency duty in 1928, Company "D" captured an escaped convict at Philadelphia, Miss., and an escaped convict and murderer at Parchman. Then in 1934, it served at the trial of three negro assault cases at Hernando, and for three weeks on strike duty at Kosciusko. In 1935, it participated in the capture of Raymond Hamilton, desperado, at Jackson; served at the hanging of a negro assaulter at Cleveland, on flood duty at Greenwood, and for the trial of a negro murderer at Walthall. For three weeks in 1936, Company "D" served at Tupelo following the tornado disaster.

Captain Evans has commanded the unit each year since its organization at the field training camps, excepting 1936, when he was granted leave, and 1938, when he was assigned as Battalion Executive Officer. First Lieut. James S. Weatherby commanded the Company for these training

periods. The unit served as support for the assault battalion of the regiment in the Third Army Maneuvers, De-Soto National Forest, Mississippi, in 1938, climaxing eleven years of distinguished service.



tenant Davis was made First Lieutenant and Staff Sgt. Henry L. Rodgers was commissioned Second Lieutenant. Lieutenant Rodgers resigned in January, 1935, and First Lieut. Alfred G. Block, Coast Artillery Corps Reserve, was assigned to the Company as Second Lieutenant on August 6, 1936.

Both officers and ten men served on riot duty at Hernando from January 15 to February 13, 1933, establishing communications. One officer and three men went to Tupelo to map the damage done by the tornado and served from April 15 to April 30, 1936. Two officers and four men were sent to Greensboro to establish radio communications with the Coast Guard during the 1937 flood.

Serving in the Third Army Maneuvers, July 31 to August 15, 1938, this unit was highly commended by Lieutenant Colonel Weaver of the Infantry Reserve and by the Regular Army Umpire assigned to the Second Battalion for their work in establishing, maintaining and operating all types of communication during the combat phase of the maneuvers. Their discipline and spirit also drew fine compliments.





The Company has had an extensive service record since its organization at this station, having been ordered into the state's service on sixteen occasions. It was this Company's service in the 133 levee disturbances along the Yazoo Basin that demonstrated the advantages of coordinating field telephone communication with commercial telephone systems to facilitate the patrol of a large area with the minimum of manpower. This principal of combining telephone systems was used to advantage in the labor troubles at Kosciusko and in the storm devastated area of Tupelo. At the latter place field telephones delivered communications originating over commercial lines to areas where their facilities had been completely destroyed.

# FACTUAL HISTORY

Company "K," 155th Infantry, Mississippi National Guard, was organized at Tylertown, Mississippi, on May 31, 1924.

In 1927, this Company served on riot duty at Jackson, Mississippi. In September, 1934, it was called for duty to control a situation at Magnolia, Mississippi, arising out of the textile strike. In February, 1935, the Company was again called for duty to guard a negro from Jackson to Cleveland where he was tried and convicted and returned to Jackson.

The Company served on the Gulf coast in April, 1937, when President Franklin D. Roosevelt visited there.

# FACTUAL HISTORY

Gulfport's first militia company was organized in 1904, when the city itself was in its infancy. After a series of reorganizations and several long periods of inactivity, there emerged in 1921 a company of machine gunners, recognized by the Federal government on April 21 of that year as Company "M," First Mississippi Infantry. In November, 1921, the First Mississippi, including its Company "M," became the 155th Infantry, which designation remains in effect today.

When emergencies have forced the governor to call for troops, Company "M" has served with distinction. In 1927, guardsmen from the seacoast knew how to man rescue


boats, as well as handle weapons, in refugee camps at Leland and Greenville. Company "M" stood annual Federal inspection in 1926 while walking posts around the Gulfport jail and also successfully guarded prisoners in Bay St. Louis, Jackson, and Cleveland on other occasions.

Machine guns of Company "M" bristled a warning against violence from the roof of a Magnolia, Miss., textile mill when labor troubles beset the industry in 1934. When President Franklin D. Roosevelt visited the Mississippi coast, the Gulfport unit messed and erected tents for a Battalion of troops and guarded the President from enthusiastic crowds as he boarded his train.

Three officers of this unit have completed courses at

service schools. Nine of its non-commissioned officers have been awarded the covered Mississippi Medal of Efficiency. Officers now on division and regimental staff and in the artillery and quartermaster regiments of the state were once enlisted men in Company "M."

has shown splendid spirit and cooperation as exemplified by the volunteer aid of the men when the Armory caught fire from unknown causes on August 25, 1938, causing loss and destruction to clothing and equipment. The Battery turned out almost to a man and voluntarily salvaged as much equipment as possible. Despite shortage of clothing and equipment because of the fire, the Battery carried on with its training. A W. P. A. project to build a suitable Armory for the organization is underway, being sponsored by the City of Greenwood and Leflore County.

In 1933, the Battery, as an organization, did not attend field training because of its recent organization. A few selected sergeants, however, attended field training at Fort Knox, Kentucky. In 1934 and 1935, the Battery trained with the regiment at Fort Knox. In 1936 and 1937, the Battery attended field training at Camp Shelby, Mississippi.

In 1938, the organization participated in the Third Army maneuvers in South Mississippi. The unit received more practical training than most units because communications were installed and maintained during the entire operations and not "simulated" as other conditions had to be.

Capt. William V. Tarver, under whose command the unit was organized, was succeeded by Capt. Frederick W. Koops, Jr., then a Second Lieutenant. Captain Koops was transferred to the regimental staff on January 18, 1937, with Capt. William F. Kerr (then First Lieutenant) assuming command.

This organization served on duty during the Mississippi River flood, 1927; strike duty at Koscuisko, September, 1934; guard duty at Cleveland, February, 1935, during the trial of James Coyner; flood duty in Leflore County, March, 1935; and on tornado duty at Tupelo, April, 1936.

# FACTUAL HISTORY

When a Regiment of Artillery was authorized in Mississippi in the year 1933, Tupelo was allotted one battery. Battery "C" was mustered in by Capt. Derril deS. Trenholm on April 28, 1933, with four officers and fifty men. The officers were Capt. Sam H. Long, First Lieut. Thomas E. Trice, Second Lieuts. Claude F. Clayton and Ralph Means.

The first year was spent in training in basic subjects and in familiarizing the officers and men in the rudimentary principles of artillery. In 1934, the Battery went to its first field training at Fort Knox, Kentucky. For two years the Battery trained there, and in 1936-37-38 at Camp

Lily to First Lieutenant.





# FACTUAL HISTORY

With a World War captain of infantry, Thomas S. Evans, in command, Battery "D," 114th Field Artillery, was Federally recognized as Battery "B," 178th Field Artillery, on May 20, 1926. First Lieut. William E. Roberts, World War naval officer, and Second Lieuts. Joseph Windham and Joseph Lloyd completed the officer personnel.

Field training at Camp Knox, Kentucky, and emergency service during the Tombigbee flood in December, 1926, highlighted the first year of organization. In 1927, Battery "B" again saw emergency service during the Mississippi flood. Field training for 1927 was at Camp Beauregard, Louisiana; 1928, Camp Knox; 1929, Camp McClellan, Mississippi Gulf Coast; and Camp Knox, 1930, 1931, and 1932.



transferred to the Battalion Staff as Captain. First Lieut. Thomas H. Crigler, former cadet at the United States Military Academy, was transferred to the Battery as Executive Officer. Just before camp in 1932, Captain Evans resigned after six years as commander. Capt. W. E. Roberts, transferred from the Battalion Staff, assumed command.

The 178th Field Artillery was redesignated the 114th Field Artillery in November, 1932. In 1933, the 114th Field Artillery became a full regiment. Battery "B" was redesignated Battery "D." Its commander, Captain Roberts, was made Major and commander of the newly-organized Second Battalion. The original First Battalion again trained at Fort Knox in 1933.

The Regiment trained at Fort Knox in 1934 and 1935 and at Camp Shelby in 1936 and 1937. Battery "D" saw active duty following the disastrous Tupelo tornado in April, 1936. On returning from Tupelo, Captain Crigler transferred to the Second Battalion Staff and First Lieut-McPherson was placed in command.

S. A., then assigned to this state as Field Artillery Instructor. The unit received Federal recognition May 2, 1933. Issac W. Walton was its first commanding officer with Charles R. Johnson, Sr., First Lieutenant, and Doyle W. Waldrop, Second Lieutenant.

As the unit was organized so late in the spring, it did not make camp that summer. Captain Walton resigned in June of the same year due to a change in civil vocation positions, and William P. Wilson was appointed commanding officer. With one year of Armory experience, the unit trained for two weeks at Fort Knox, Kentucky, during the summer of 1934.

The next summer the unit make truck convoy to Fort Knox, Kentucky. In 1936, the unit made camp at Camp Shelby, Mississippi, the 114th Field Artillery being the first state guards to encamp at Shelby since the camp was organized. The trip was made in motor vehicles assigned permanently to the unit. The 1937 camp was also made at Camp Shelby, Mississippi. During camp, on July 21, 1937, Horace R. Adair was appointed Second Lieutenant to fill the vacancy vice Lieutenant Guild.

In the summer of 1938, the unit engaged in war maneuvers held in DeSoto National Park located in South Mississippi.







Year Battery in camp. The first emergency duty for the unit was at the textile strike at Magnolia, September 10-25, 1934, with two officers and fifteen men acting as a Headquarters and Communication unit.

Capt. Derril DeS. Trenholm, instructor on duty with the Battery from 1934-1936, established the monthly battalion schools which are still held. During May, 1935, the Battery received its first motor equipment under the plan to motorize the Artillery.

The second field training was at Fort Knox. Going more than 700 miles one way in trucks, the members gained valuable information. In January, 1935, the Battery went to Jackson for the Governor's parade, and in April two officers and seven men did emergency duty at Tupelo as part of the General Headquarters.

Field training at Camp Shelby, Mississippi, was held for the first time in 1936. In April, 1937, the Battery served during President Roosevelt's visit to Biloxi.

The Battery served with the Brown force during the Third Army Maneuvers in DeSoto National Forest in 1938. It won the regimental athletic cup after the maneuvers. A gopher was adopted as the Battery's official mascot. Each year on the day of Federal recognition is a banquet, as the first roll is called. After six years, seven original members are still with the unit.

The 106th Engineers had its beginning during the World War when it was organized as the 114th Engineers, Thirtyninth Division, from Company "A," Engineers, on September 27, 1917, and new units then or subsequently organized. This organization participated in the Meuse-Argonne operation in France and was mustered out May 21, 1919. The 106th Engineers, Thirty-first Division, was organized from Company "A," Georgia Engineers, in 1917, and new units organized largely from the personnel of the First Florida National Guard. It served in France, but not in actual combat, then was mustered out on July 12, 1919. Reorganized as 114th Engineers in 1921-1922, it was redesignated the 106th Engineers organization was reconstituted and a consolidation effected on October 9, 1926.

The 106th Engineers is mainly located in Mississippi, with the Second Battalion in Florida. Originally, Headquarters was at Jackson, Headquarters and Service Company at Drew, the Band at Ruleville, Company "A" at Indianola, Company "B" at Rolling Fork, and Company "C" at West Point. Later the Band was mustered out and reorganized at Millsaps College in Jackson. Company "A" moved to Moorhead, and Company "B" reorganized at Vicksburg.

Col. Charles T. Bookout, retired on January 17, 1934, is the only officer retired for age from this Regiment. The first commander of the First Battalion, he was later promoted to Lieutenant Colonel and served as Executive Officer, giving commendable service in both positions. "Uncle Charlie," as he is lovingly called by both officers and men, is the Regiment's guest each summer during field training. Without his presence, the Regiment would not seem intact.

Priding itself on "esprit de corps" and morale, this organization has never held a summary court. No charges have ever been preferred against either officer or enlisted man, and no one has been confined in the guard house or in quarters for seven years. The Regiment also prides itself upon having always carried out its field training program in its entirety.

The 106th Engineers has received nine commendations in the last four years, one from the Chief of Engineers, one from the Chief of the Map Reproduction Plant, and several each from the Chief of the National Guard Bureau, Corps Area Commander, and the Adjutants General of Mississippi and Florida.


# FACTUAL HISTORY

Since its splendid service to the refugees at Leland, Mississippi, shortly after its organization on March 15, 1927, under Capt. A. A. 





During the field training period of 1935, this unit revised and corrected the existing maps of Camp Beauregard, Louisiana. In the summer of 1936, it revised and brought up-to-date the Special Military Map of Fort McClellan, Alabama, for which the unit was commended by the Chief of Engineers, United States Army, by the Chief of the National Guard Bureau, by the Corps Area Commander, and others. It was during the same period that this unit was instrumental in the design, construction, and operation of an improvised footbridge.

In the summer of 1937, Company "B" made the surveys and a fire control map of the Artillery Range at Camp Shelby. During 1938, the unit developed a new type of road mine which was mentioned favorably by the Board





SHIELD: Per bend sanguine and buff, to chief a prickly pear cactus, to base a fleur-de-lis ail argent.

CRESTS: Those for the regiments of the Louisiana, Mississippi, Alabama and Florida National Guard, in the following order:

LOUISIANA: On a wreath of the colors (argent and sanguine) a pelican in her piety affronte with three young in nest, argent armed and vulned proper.

MISSISSIPPI: On a wreath of the colors (argent and sanguine) a slip of magnolia full flower with leaves proper behind a trident sable.

ALABAMA: On a wreath of the colors (argent and sanguine) a slip of cotton plant with full bursting boll proper.

FLORIDA: On a wreath of the colors (argent and sanguine) an alligator statant proper.

MOTTO: Pret d'accomplir (Ready to accomplish).



Organized in January, 1924, as the Thirty-first Division Quartermaster Train in the National Guard of Mississippi, Louisiana, Alabama, and Florida, this organization was redesignated the 106th Quartermaster Regiment on May 1, 1936.

The regiment is entitled to a streamer in the colors of the Victory Ribbon, without inscription, to commemorate the services of Companies "A" and "D" (one third of the lettered companies of the Regiment) during the World

War.

Saw service in France with his division and was discharged on May 28, 1919. February 17, 1920, commissioned First Lieutenant, Quartermaster Corps, O. R. C. Organized 154th Motor Transport Company, Mississippi National Guard, and was commissioned First Lieutenant and commanding officer of the unit on April 6, 1922. Was promoted to Major, Quartermaster Corps, Mississippi National Guard, and assigned to command the Thirty-first Division Quartermaster Train on August 11, 1924. When the 106th Quartermaster Regiment was organized, the position of Lieutenant Colonel and Executive Officer was assigned the Mississippi National Guard. Major Callicott was promoted to that rank on July 20, 1936, and assigned the duties of Executive Officer. He was graduated from Quartermaster School, 1928, and Motor Transport School, 1936.

# OFFICERS, STAFFAND FIELD ONE HUNDRED AND SIXTH QUARTERMASTER REGIMENT

Headquarters Company and the Medical Detachment were both organized and recognized in the Mississippi National Guard on June 1, 1936.

Company "A" history dates back to the organization in July, 1917, of Troop "E," Second Separate Squadron Cavalry, Mississippi National Guard. This unit was mustered into Federal service on August 9, 1917, redesignated as Company "F," 114th Supply Train, and served in France with the Thirty-ninth Division. After the Armistice, the personnel was transferred to other units and the records returned to the United States by cadre. The unit was demobilized on January 23, 1919. ters Company was organized with seventeen new men and eight men transferred from Battery "F," 114th Field Artillery, Biloxi. Division Quartermaster Platoon was recruited from new men.

First Field Training was at Camp Beauregard, Louisiana, August 9 to August 23, 1936. Headquarters Company (less Division Quartermaster Platoon), served at Biloxi during President Roosevelt's visit on April 28-29, 1937. At Camp Shelby, Mississippi, July 4 to July 18, 1937, the Company participated in a convoy which transported the personnel of the camp to the Gulf Coast and return.

In April, 1938, the strength of the Company was increased from thirty to thirty-two enlisted men. In July, 1938, the Division Quartermaster Platoon was transferred to Ocean Springs.

During the Third Army Maneuvers in DeSoto National Forest, Mississippi, July 31 to August 14, 1938, Headquarters Company for the first time operated with the complete 106th Quartermaster Regiment. Headquarters Company furnished the clerical force for the Regimental Commander, who was also Division Quartermaster. Division gasoline supply for the Thirty-first Division was operated by the Gasoline Supply Platoon of Headquarters Company, which also gave assistance in the issuing of Class 1 supplies.

The Company, now in its third year and perhaps the youngest unit in the Mississippi National Guard, is fast reaching the stage of experience that comes with maturity.

# FACTUAL HISTORY

This unit was Federally recognized as the 154th Motor Transport Company at Senatobia on April 6, 1922, later redesignated 122nd Transport Company.

First Lieut. Albert T. Callicott, organizer and first company commander, served as such until 1925, when he was made Major and Commander, Thirty-first Division Quartermaster Train. He was promoted to Lieutenant Colonel and Commander of the 106th Quartermaster Regiment in 1936.

When the village of Savage was destroyed by a tornado in 1923, Lieutenant Callicott and entire company, serving without pay, restored order and rendered relief. During the 1927 Mississippi River flood, this unit served eighty consecutive days at Vicksburg, being on constant duty


without rest for twenty-four hours a day the first three days.

Serving with Memphis, Tennessee, postal authorities on a civilian basis during the Christmas rush season for nine consecutive years, the unit established an enviable record for careful driving and efficient service.

When City of Tupelo was almost destroyed by tornado in May, 1936, the unit for three weeks did guard duty and aided in relief and rehabilitation work.

In July, 1936, Lieutenant Colonel Callicott, using Company "A" personnel and equipment, augmented by several trucks and drivers from the 114th Field Artillery, organized a convoy of 105 vehicles, which transported the personnel of the 117th Infantry, Tennessee National Guard, from their home stations to Camp Jackson, South Caro-

lina, and return, travelling approximately 1,200 miles without accident and on schedule. Picked detachments have served on guard duty during trials and during floods.

vember 6, 1924, it was finally moved to Jackson on June 3, 1929. Staff Sgt. Nicholas Berbiglia and Supply Sgt. Arthur B. Henry have served in their respective positions rom that time to the present. The former has qualified a Second Lieutenant in the Medical Administrative Corp.

An important part in the development of the Regiment is credited to Maj. William R. Grady, retired, previous Regimental Surgeon. He served in the Mississippi Militia before the World War, in the Medical Corp of the United States Army, and the American Expeditionary Forces. He was rated one of the best sanitary officers in the A. E. F. Always ready to aid a junior officer, he was also respected for his medical military ability. His retirement on September 9, 1936, was deeply regretted.

The whole-hearted cooperative spirit of the medical officers with the enlisted personnel and line officers of this Regiment has been a significant and outstanding fact for the past few years. The personnel is trained and equipped sufficiently to care for all emergencies which may arise in the field training periods in which this Detachment serves.

panies in the state. At that time its membership composed all of Warren County.

Regimental Headquarters Company served with the First Mississippi in the Creek Indian Wars from 1812 to 1814. It became incorporated in 1837 as the Vicksburg Volunteers and later when there became a distinction between the North and the South, the name was changed from Vicksburg Volunteers to the Volunteer Southrons. The word "volunteer" is taken to show they were not in regular service, but would chance all willingly and without draft or compulsion for love of their country.

The Company saw service in the Mexican War with the First Mississippi Regiment under the command of Jefferson Davis. After the Mexican War the name was changed and was known as Company "A." The unit served with the Twenty-first Mississippi Regiment under Colonel Moody during the Civil War from 1861 to 1864.

Company "A" was mustered into Federal service at Camp Pat Henry, Jackson, Mississippi, in 1898 for the Spanish-American War. This Company also took part in the strife along the Mexican Border in 1916, and served with the Thirry-ninch Division of War in 1918 and 1919 The name was again changed and designated as th

Regimental Headquarters Company on November 2, 1921, and has retained that name for the last eighteen years.

Lieutenant. Upon Captain Wise's promotion in 1923, Lieutenant Duggan was promoted to Captain, and commanded the Company until August, 1927. Captain Dugcan was then transferred to the Regimental Staff and was succeeded by Louis A. Cary, who has served as Company Commander until the present time.

This unit has been called on for many tours of state duty, the most important being during the 1927 flood. During this disaster, the Company organized and carried out rescue work and established a refugee camp at Yazoo City, Mississippi, providing shelter and food for a total of 15,000 flood refugees. The Company served for forty days.

In 1927, the Service Company had the sad but signal privilege of serving as honor guard at the funeral of Col. George Quekemeyer, personal aide to General Pershing during the World War.

Other state service consisted of two tours of storm duty at Yazoo City in 1925 and in 1932; guard duty, Tallahatchie Basin, 1933; and three tours of duty in defending prisoners from mobs, at Jackson, at Cleveland, and at Hernando.

The personnel of this organization probably has changed less than that of any other unit in the state. The officers have served with it for more than a combined total of sixty years. Master Sergeants Applebaum, Hood, Netherland, and Mess Sergeant Jenne have a combined record of service of more than sixty years. Many other members have served for more than ten years.

the units were comparatively unstable and changed names frequently. In the course of time, this unit has been known as the Warren Light Artillery, First Mississippi Rifles, Second Independent Company of Infantry, and First Battalion Headquarters Company of the 155th Infantry.

As First Battalion, Fifth Independent Battalion, it had the present Regimental Commander, Col. George E. Hogaboom, as Battalion Commander.

In 1916, the Company was mustered into Federal service for duty on the Mexican Border and was sent to Fort Sam Houston for training. It was mustered out of service at 8 a. m., March 27, 1917, and because of serious relations with Germany was mustered back into service at 1 p. m. of the same day. They trained at Camp Beauregard, Louisiana, until August, 1918, at which time they sailed for France, arriving at Brest about September 1, 1918. There were assigned to the Fifth Depot Division, inth Division.

Since 1921, the latest designation of the organization as the 155th Infantry and the accomplishments of the Com-

pany as a separate unit may be more specifically followed. Upon being mustered into service under its present designation in June, 1928, the organization had as its commander First Lieut. W. J. Voller.

In 1934, First Lieut, C. H. Mackey assumed command when Lieutenant Voller was assigned to the Regimental Staff. In 1936, First Lieut. G. A. Morris was made commander when Lieutenant Mackey was given command of Regimental Headquarters Company. Due to circumstances requiring Lieutenant Morris's services on the Regimental Staff, early in 1938 Lieut. F. W. Melsheimer assumed temporary command of the unit.

This unit has attended all eight encampments of the Regiment since its organization, five at Fort Knox, two at Camp Shelby, and at the Third Army Maneuvers in De-Soto National Park.

Members of the Detachment served with credit to the Regiment in April, 1936, following the Tupelo tornado disaster.

Staff Sgt. Charles E. Lehmberg, Jr., has served as Staff Sergeant since the organization of the Detachment.

it was not until the early spring of 1933 that this city had an opportunity to get a unit. When the 178th Field Artillery Battalion was expanded to a Regiment, the Service Battery, 114th Field Artillery, was assigned to Meridian. Organized April 18, 1933, it was Federally recognized May 1, 1933.

Consisting of a personnel above the average, this unit has received commendations for outstanding work during field training every year since its organization. It received the regimental attendance cup for the highest attendance in 1936 and 1938. This Battery passed the 1937 and 1938 Federal inspections without a single deficiency reported by the inspector.

The Service Battery attended held training at Fort Knox in 1934 and 1935, at Camp Shelby in 1936 and 1937, and participated in the Third Army Maneuvers in the summer of 1938.

Original officers of the Battery were First Lieuts. Frank

McKee and Lee B. Preister, Jr., and Second Lieuts. Beverly M. Leigh, Jr., and Paul L. Tatum. First Lieut. Robert P. Alston succeeded Lieutenant Priester, when the latter moved to another section of the state in 1933. The other three

officers and enlisted men during field training. The band attended field training at Fort Knox and Camp Shelby each summer through 1936.

In 1936, an R. O. T. C. department was established at the University, and approximately three-fourths of this unit's personnel enrolled in the military classes, resulting in a marked increase in "military consciousness." All members enroll in the R. O. T. C. if possible.

In April, 1937, following an increase from twenty-six to thirty-two enlisted men, several additional instruments were secured by the U. S. P. & D. O. for the band. At Camp Shelby in 1937, the band, in addition to furnishing music for parades, played many concerts in the camp area and in Hattiesburg.

During the Third Army Menauvers at DeSoto National Forest in 1938, two concerts each day were given while the Regiment was in concentration area. In addition to this, the members were assigned to various units for the maneuvers and rendered valuable service as messengers. The members of the band receive excellent training through participation in work of the R. O. T. C. together with instruction given in the Band Section.

April 29, 1933, with three officers and thirty-five enlisted men. Officers were Capt. Arthur L. Goodman and Lieuts. Henry H. Hunter and Lawrence L. Mullins.

Due to lack of experience, this organization did not participate in field training during 1933, but it went to Fort Knox, Kentucky, in 1934 and 1935, and to Camp Shelby, Mississippi, in 1936 and 1937. Highlight in the unit's training was in 1938, when the Battery, as part of the Regiment, performed satisfactorily, with the other two Regiments of the Fifty-sixth Brigade, during the Third Army Maneuvers in DeSoto National Forest, Mississippi.

The Battery won the regimental athletic trophy in 1934 and the regimental attendance cup in 1937.

Captain Goodman tendered his resignation, due to business reasons, on January 6, 1937, and Lieutenant Hunter took command. First Sgt. Jack D. Mullen was commissioned a Lieutenant on February 21, 1937, and on July 2, 1938, he was promoted to Captain and given command of the unit.

The organization did special duty at Cleveland, flood duty, June 23 to July 17, 1927, in charge of refugee concentration camp; at Tupelo, April 6 to April 23, 1936, rehabilitation and sanitary work in area destroyed by tornado, and on several occasions for minor riot duty. The Band marched in President Roosevelt's inangural parade in 1937 and was present at the installations of Governors Connor and White of Mississippi. Also an integral part of Millsaps College, the Band maps its programs so that its two functions do not overlap. The traditional purple and white Millsaps colors are worn for college events and the official blue dress regalia for National Guard activities.

Membership is encouraged by the college, which offers scholarships to musicians. One extra curricular hour of college credit is offered as further inducement to band membership. Although National Guard enlistment is limited to thirty-six men, other students may belong to the college band. Some members use their National Guard money to help defray college expenses.

Service in the band entails excellent musical training, for classical as well as military tunes are taught.
