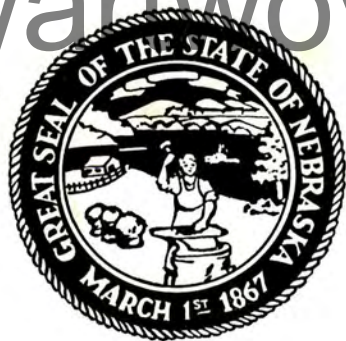

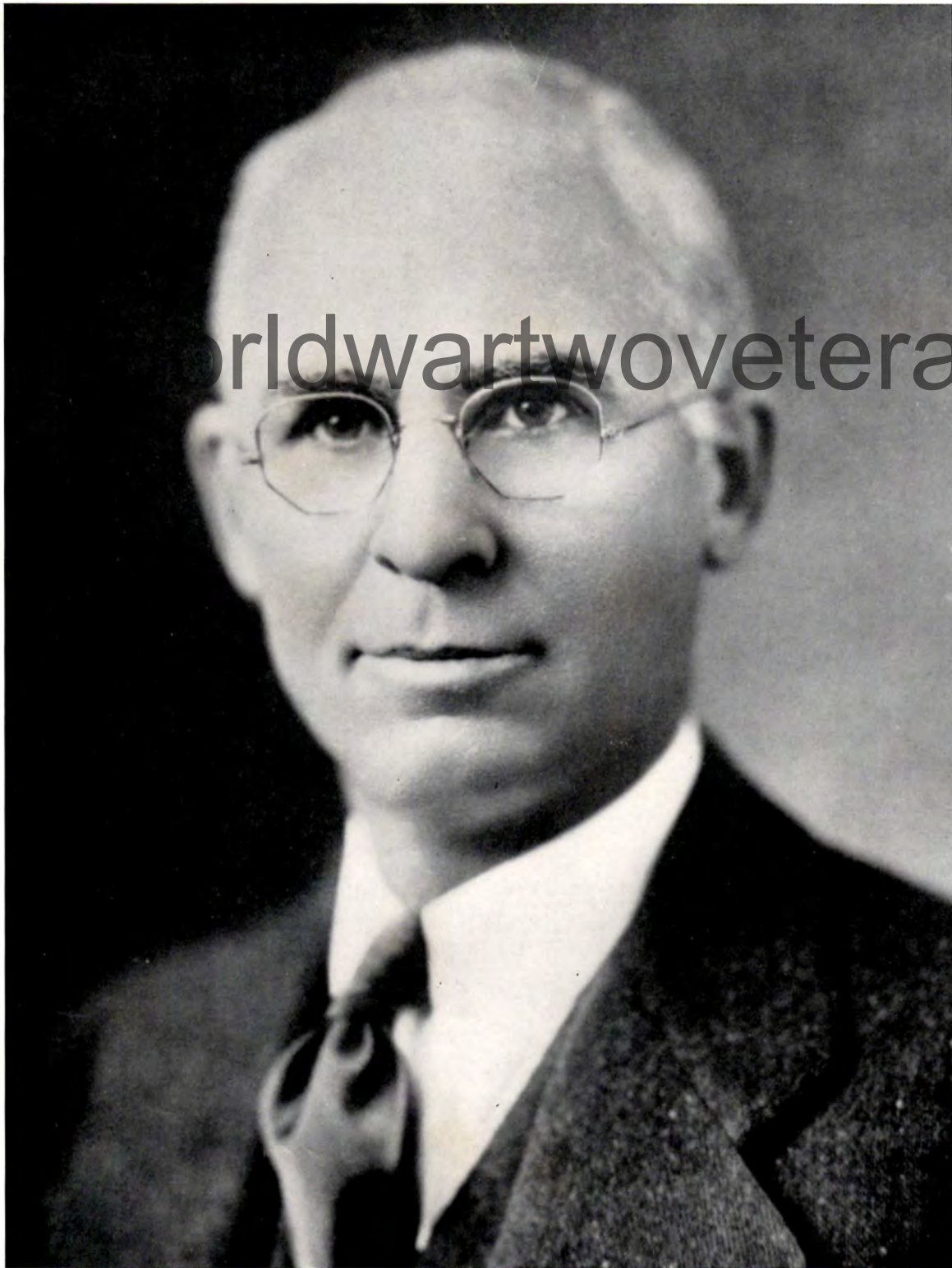

The Nebraska National Guard has been in the service since before and during the Civil War, and, I believe, has participated in every war the United States has had since that time, unless it might have been some minor uprisings that our small Regular Army could take care of themselves.

Having been a member of the National Guard during the Spanish-American War and continuously since September 28, 1900, I feel that I am in a position to judge the officer and enlisted personnel. It is my opinion that never a higher type, more patriotic, trustworthy and moral organization could be found the world over than we have in our National Guard. They have never been called upon for service but that they have given a splendid account of themselves. There is no question in my mind that should they be called upon again they would do even better. They are better equipped and better trained today than they have ever been in their history.

I think it is opportune that this historical sketch be published. To all of the officer and enlisted personnel, I suggest that they seek historical information that may be added to the meager history we have of our National Guard up to this time, so that any future historical sketch that may be published will add to the information and knowledge of our future generations.

Having been Adjutant General of this state since my return from the World War, i. e., March 4, 1919, I desire to express my great appreciation for the splendid cooperation and interest manifested by the officer and enlisted personnel in the reorganization and upbuilding and in the making of the National Guard what it is today.

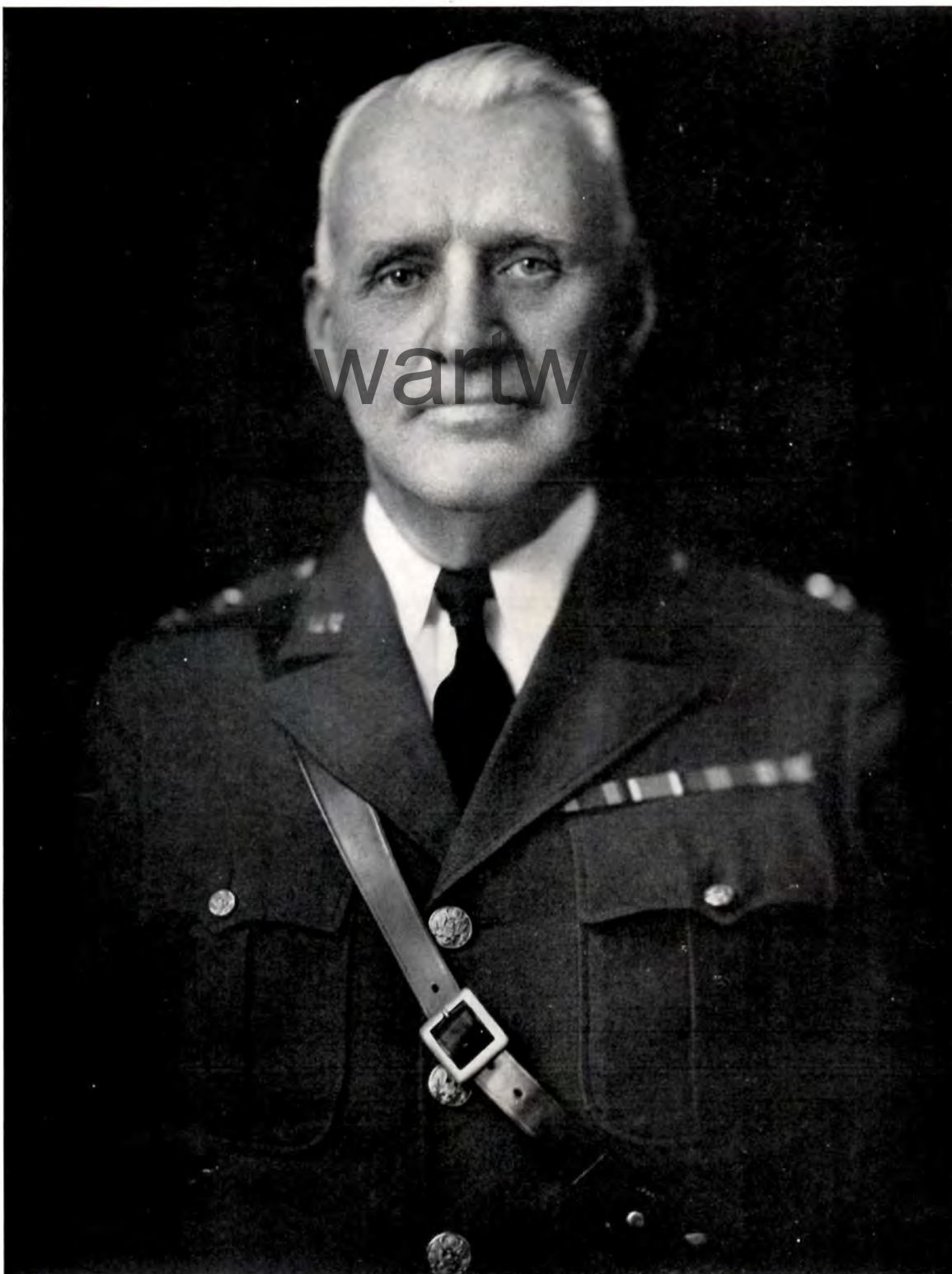

# GREETINGS



# STATE STAFF



The State Staff Corps and Detachment was organized August 6, 1919, there being no organization of its kind authorized prior to the World War. The personnel at the time of Federal recognition consisted of one officer, Major H. C. Stein. Additional personnel was added in 1921, starting in

March with a Major Judge Advocate General's Department. In May there was added a Major Medical Corps, in July a Captain Quartermaster Corps, in August a Captain Ordnance Department and in December a Colonel Adjutant General's Department.

The enlisted personnel of twelve men was recruited in July, 1921, and attended the annual encampment at Camp Dodge, Iowa, with the rest of the Nebraska troops. Other than attending each annual encampment since its organization, the Detachment has served the state as follows: Pack-

# Thirty-Fifth DIVISION

(NEBRASKA ALLOTMENT)



Headquarters Detachment of the Thirty-fifth Division was not organized until practically all the regiments of the Division had been completed. In June, 1932, after a meeting of the Adjutant Generals of the States comprising the Thirty-fifth Division, namely, Kansas, Nebraska, Missouri and Arkansas, an agreement was reached whereby each state was allotted certain officers of the Division Staff. Nebraska was given six officers, these being G-1, G-4, Division Quartermaster and his assistant, Division Judge Advocate and his assistant. These officers were appointed and Federally recognized in 1932.

Brigadier General Charles I. Martin of Kansas was appointed the Major General in command of the Division, which position he held until reaching retirement age. Adjutant General Herbert J. Paul, Nebraska, next Division Commander, also held the post until reaching retirement age in November, 1937.

This unit has participated in annual field training with the balance of the Division Headquarters since its organization and in the Fourth Army Maneuvers at Fort Riley, Kansas, in 1937. It answered the Governor's call for emergency duty during the street-car strike in Omaha in June, 1935, and during the irrigation trouble in Scotts-Bluff County in the fall of 1935.

The Detachment now consists of G-1, G-4, Division Judge Advocate and his assistant, the Division Quartermaster and his assistant having been absorbed in the organization of the 110th Quartermaster Regiment.

In the re-organization of the National Guard after the World War the Headquarters 69th Infantry Brigade was allotted to the State of Kansas, it being a part of the 35th Infantry Division. This Headquarters was organized and federally recognized at Topeka, Kansas, on October 24, 1922. Brigadier General Charles I. Martin was made the Brigade Commander at that time.

This Headquarters remained in the State of Kansas until the promotion of Brigadier General Martin to Major General commanding the Division, at which time it was allotted to Nebraska and was organized and Federally recognized in this State August 16, 1932. Colonel Amos Thomas commanding the 134th Infantry, a part of this Brigade, being promoted to the rank of a Brigadier General and assigned to command of the Brigade.

Since becoming a part of the National Guard of Nebraska this organization has participated in every annual encampment and also during the Fourth Army Maneuvers at Fort Riley, Kansas, in 1937, and during these maneuvers made a very excellent showing in comparison with other National Guard and Regular Army Brigades that took part. It was also on State duty under call of the Governor during the Street Car Strike at Omaha in June, 1935.

The Brigade Commander, as the senior general officer of the Division, took part in the Command Post Exercises, Fourth Army, held on the west coast during the fall of 1935.

All the officer personnel of these Headquarters is located in Nebraska with the exception of one First Lieutenant who is still allotted to the State of Kansas.



# ONE HUNDRED THIRTY-FOURTH INFANTRY



The history of the 134th Infantry, Nebraska National Guard, has its beginning in the proclamation of Acting Gov. Thomas B. Cuming on December 23, 1854. This proclamation called for the organization of the citizens into volunteer organizations of militia where needed in Nebraska territory. At the same time Acting Governor Cuming appointed a Colonel, Lieutenant Colonel, and an Adjutant for the First Regiment, north of the Platte River, and similar officers for the Second Regiment, south of the Platte, which was then a natural and important division line east and west through the territory. The action of the Governor was approved on February 8, 1855, by the "Council" and House of Representatives. On July 30, 1855, Brigadier General Thayer, commanding the First Brigade, Nebraska Militia, was ordered to quell Indian uprisings at Fontenelle. The Second Company from Omaha and the Fontenelle Rifle Rangers mobilized, moved to the scene of action and with little fighting put down the uprising. Many companies were organized later in different localities and were ready for service where needed. In 1856 parts of the First and Second Regiments were ordered out because of troubles with the Pawnee Indians near Salt Creek Basins, in the vicinity of the present site of Lincoln, and again in 1859 were sent to West Point to quell similar uprisings.

At the call of the President in June, 1861, the First Regiment, Nebraska Volunteers, was mustered in the service and left Omaha July 30 by steamboat for St. Joseph, Missouri. The Regiment moved to St. Louis and later embarked on board the steamer White Cloud for Fort Henry, Tennessee.

The Regiment received orders to go up the Cumberland River to Fort Donaldson. On its arrival the ground was covered with snow and the weather was cold but the Regiment moved to the battlefield with Companies "B" and "H" in advance as skirmishers. The Confederates withdrew behind their breastworks, and the Union forces laid siege to the fort. On February 16, the enemy ran up the white flag and surrendered unconditionally to General Grant. The Regiment then took part in the siege of Fort Henry and later left on the steamer John Paris for Crump's Landing, Tennessee. In April, 1862, they marched to Pittsburg Landing. In the engagement that followed the

Regiment's action is covered in General Thayer's report of the battle, a portion of which is here given:

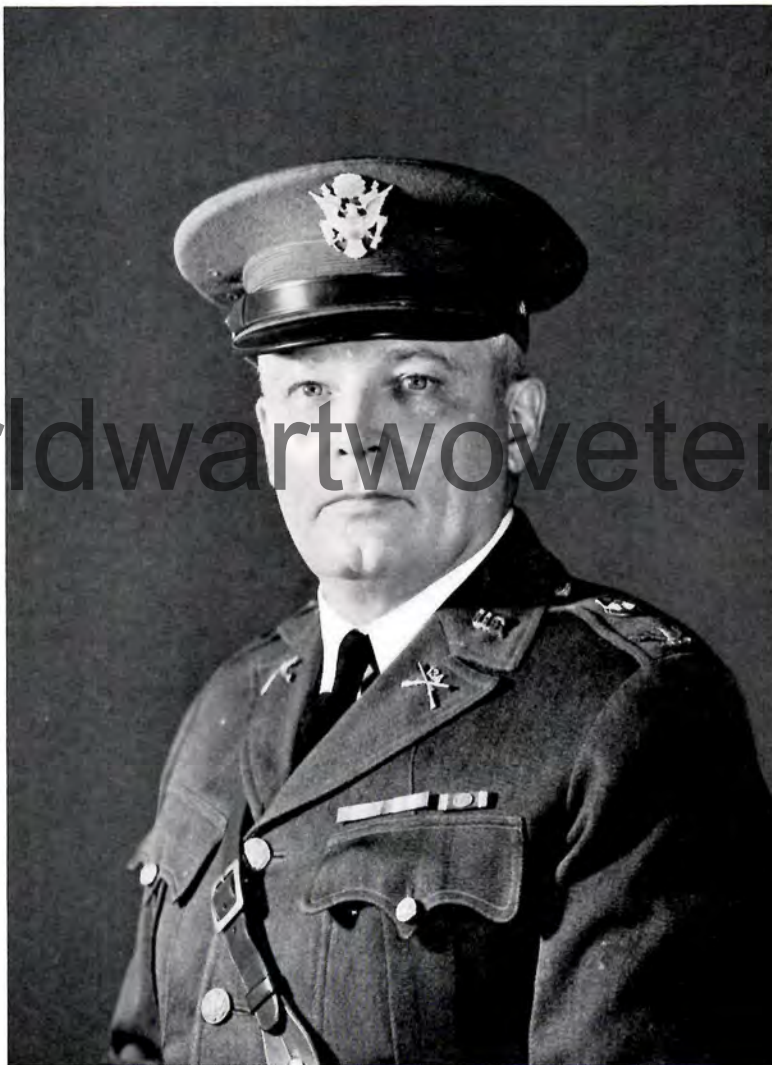
"Headquarters Second Brigade, Army in the Field,  
"Pittsburg Landing, April 10, 1862.

"I have the honor herewith to submit a report of the part taken by the Second Brigade in the battle of Pittsburg Landing.

"Early on Sunday morning, the 6th inst., hearing at my camp at 'Stony Lonesome,' cannonading in the direction of Pittsburg, I immediately caused my command to be put in a state of preparation to march at a moment's notice, and anxiously awaited orders. Soon Major General Wallace and staff rode up, and gave me the desired command to move to the scene of action. At 12 o'clock the brigade was in line of march, the Sixty-eighth Ohio, Colonel Steadman, being directed by me to remain at that point, in conjunction with Colonel Kinney's Ohio regiment, for the purpose of preventing an approach of the enemy by the Adamsville road. We arrived upon the field at Pittsburg at dark, and throwing out a strong force of pickets in front of our line, we bivouacked in order of battle, the troops lying down with their arms in their hands. During the night a severe thunder storm came on. Those who slept, awoke to find themselves in a drenching rain. But they bore their hardships with fortitude and cheerfulness. Capt. Noah Thompson, of the Ninth Battery of Indiana Light Artillery, having come up in the night, and placed his Battery in position in the open field in front, at daylight, on the morning of the 7th, I moved the First Nebraska, Lieutenant Colonel McCord, forward, so that its left rested on the Battery. I then placed the Twenty-third Indiana, Col. W. L. Sanderson, on the right of the First Nebraska, having the Fifty-eighth Ohio, Colonel Bausenwein, immediately in the rear of the two, while Thompson's Battery opened fire upon a battery of the enemy discovered upon the hill directly in front. Having silenced it, I received orders from General Wallace, in person, to advance in echelon. I did so, across the deep ravine, and up the steep declivity where the rebel guns had been planted, keeping Captain Baumer, and his company of the First Nebraska, as skirmishers, in advance, which movement was executed in good order. Here the General directed a change of front of his Division, which was executed by a left wheel

of the whole line. Advancing in line a short distance, we were soon under a heavy fire of the enemy's guns, both artillery and infantry. Moving forward, we emerged from the timber into a small cleared field, where Captain Thompson, having moved forward also, planted his Battery.

"The order then came from General Wallace to move forward; we did so, and emerged from the timber into a large open field. Moving my Brigade onward in full line of battle, reserving our fire, we crossed a deep ravine and passed up on to the high ridge beyond under a terrible fire of musketry and artillery from the Rebels. Arriving on the brow of this ridge, I gave the order to open on them, which was promptly done. Our fire told with fatal effect, for they immediately fell back. A few moments previous to this, observing a body of the Rebel cavalry advancing in the outskirts of the timber on my extreme right, evidently with the intention of flanking us, I directed Colonel Sanderson, of the Twenty-third Indiana, to move by the right flank some twenty rods, so as to bring his Regiment directly in front of them, and to drive them back, a movement which he promptly and successfully accomplished. On getting in front of them, the cavalry discharged. The Twenty-third Indiana immediately returned their fire, and under the lead of their Colonel then pressed forward, and the right flank company of the First Nebraska, Captain Baumer, also giving them a right oblique fire, the Rebels fell back.

"The action now became general along the line. I again gave the order to 'Forward,' and the line advanced as regularly, and with a front as unbroken as upon the parade ground, the First Nebraska, Lieutenant Colonel McCord, moving up directly in front of the enemy's battery. Advancing about twenty rods, and finding that the enemy had made another stand, I ordered a halt, and directed another fire upon them, which continued some fifteen minutes, when, discovering the enemy again receding, we pushed on nearly half a mile, halting as we ascended the brow of each hill (the ground being composed of hills and valleys) and giving them another volley, and then moving forward again. Finally, the enemy were routed from the field."

During 1863 the regiment took part in numerous minor engagements in Mississippi and Arkansas and covered many miles in forced marches. In several instances the men had to march on half rations, in their bare feet, with insufficient clothing to protect them from the inclemencies of the weather. The Regiment served with distinction in the battles at Shiloh and Corinth.

On October 11, 1863, it was redesignated First Nebraska Cavalry and continued service in Arkansas until August, 1864, when the Regiment moved to Nebraska with headquarters at Fort Kearney. Operations against the Indians in Nebraska and Colorado continued until July 1, 1866, when the Regiment mustered out of service.

#### FACTUAL HISTORY

Regimental Headquarters Company, 134th Infantry, was organized in 1921 with Capt. Thomas Q. Thornton as first company commander and Lieut. J. H. McAlpin as junior officer. In 1923 Captain Thornton was promoted to the Regimental Staff and Lieutenant McAlpin was made Captain. Lieut. Howard Wilson was promoted to command of the Company in 1929 when Captain McAlpin moved from the city, but he, too, was later transferred and Lieut. Albert L. McGill was promoted to Captain to fill the vacancy.

Captain McGill, the present company commander, has an extensive service record in the Nebraska National Guard. Enlisting in 1914 in the Fourth Nebraska Infantry, he was made Corporal in camp at Fremont, Nebraska, in 1915. On the return of his organization to

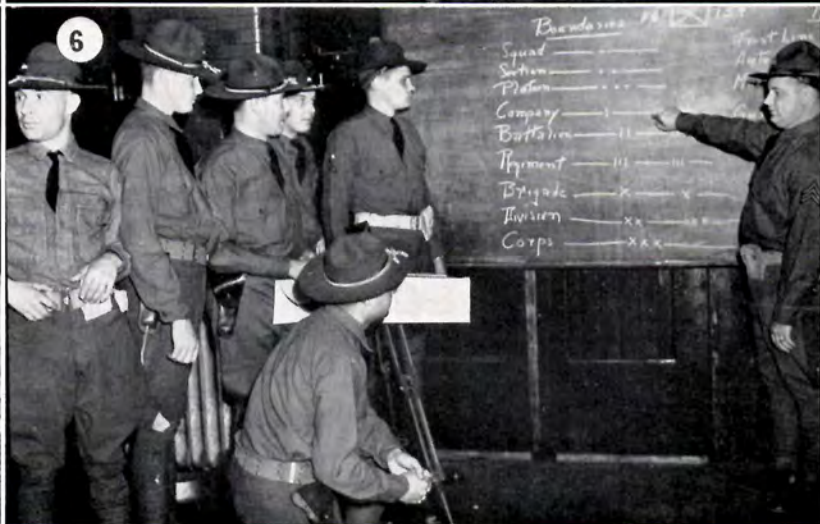
Omaha he was made Quartermaster Sergeant and served in that capacity during the tour of duty on the Mexican Border in 1916.

In June, 1917, when the United States entered the World War, he re-enlisted and was again made Quartermaster Sergeant. In the fall of 1917 the Fourth Nebraska Infantry was converted into the 127th Field Artillery and Sergeant McGill was made Signal Sergeant of Battery "D." In 1918 Sergeant McGill went overseas as Signal Sergeant of Battery "A." He saw service in England and France and returned to the United States and was discharged at Camp Dodge, Iowa, in 1919. In 1925 he enlisted in the Regimental Headquarters Company, 134th Infantry, and was made Signal Sergeant that year at Camp Ashland, Nebraska.

Since that time he has held the rank of Technical Sergeant, First Sergeant and Second Lieutenant. He was promoted to Captain in 1930.

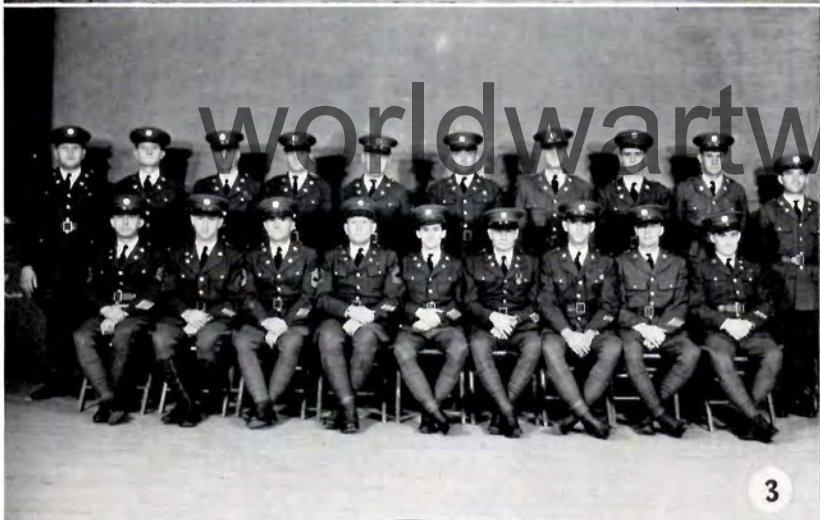

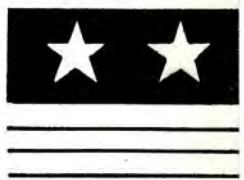

#### FACTUAL HISTORY

Service Company, 134th Infantry, was first organized as Company "D," Second Nebraska State Militia, on June 5, 1879, with Captain Gandy in command. The Company was redesignated Company "A," First Regiment, Nebraska National Guard, July 13, 1881, serving with the rest of its Regiment at Long Pine in the Sioux Indian uprising of 1890-'91, and again in the Philippines during the Spanish-American War and the Philippine Insurrection. This last tour of duty was performed under the command of Capt. George H. Holdeman.

The Company was redesignated Company "M," Fourth Nebraska, on March 14, 1913, with Capt. Roy E. Olmstead in command, and served on the Mexican Border in 1916 under the command once more of Capt. George H. Holdeman. The unit was reorganized as Company "M," Fourth Nebraska, in 1917 and served in the World War as Battery "F," 127th Field Artillery, with Capt. E. E. Newbold in command.

Following the World War, the Nebraska National Guard was reorganized and this Company was reorganized April 14, 1921, as the Separate Company, Provisional Infantry. The Company was redesignated Service Company and Band, First Infantry, on July 1, 1921, with Capt. Chas. O. Sears in command. Captain Sears resigned and Capt. Lee N. Anderson assumed command when the Company was redesignated the Service Company and Band, 134th Infantry, on October 25, 1921.

First Lieut. Harry A. Beckley was promoted to Captain and given command of the Company on December 2, 1932. He is still serving as commanding officer, with First Lieut. Raymond J. Anderson in command of the Transportation Platoon and acting as second in command; First Lieut. Arnold I. Maurer commanding the Supply Section; and Second Lieut. Clark E. Valentine commanding the Staff Section.

The Regimental Band which has been a part of this Company since 1921 is in charge of Warrant Officer George A. McCall, who has served as Warrant Officer since 1921, with the exception of two years.

Captain Beckley, Lieutenant Anderson and Warrant Officer McCall are the only members of the Company who were charter members at the Company's recognition in 1921.

### FACTUAL HISTORY

The Headquarters Company, Second Battalion, 134th Infantry, later to become the Howitzer Company, 134th Infantry, was organized at Gering by Maj. O. E. Davis on July 7, 1921. The Company was commanded by First Lieut. L. E. Cottle, who also acted as Battalion Adjutant. In April, 1925, additional strength was enlisted and the organization was redesignated the Howitzer Company, 134th Infantry. The Howitzer Company had previously been stationed at Mitchell, fifteen miles west of Gering.

Present Company officers are Capt. J. Ned Allison, First Lieut. Leslie J. Laughlin and Lieut. Warren C. Wood. Other officers who have served with the organ-

ization are Capts. J. Fred Nelson and A. F. Hinze and Lieuts. Henry Haldeman and Raymond Sorensen.

The Company has always rated with the best in Armory and field training and has always maintained its authorized strength of sixty-four enlisted men. The Company is proud of its thirty-piece Drum and Bugle Corps with special uniforms, and also of the fact that each of its non-commissioned officers is a high school graduate, seven of whom have completed the Ten-Series Correspondence Course.

The Howitzer Company has attended eighteen annual encampments and has been called out for state service on two occasions. In June the Company accompanied the Regiment to Omaha for duty during the street car strike, and members will never forget the exciting incidents of its first call to riot duty. In late August, 1935, the unit was ordered to Henry, on the Nebraska-Wyoming border, to straighten out an irrigation quarrel. This tour of duty lasted eight days.

FACTUAL HISTORY

Headquarters Company, First Battalion, 134th Infantry,  
was organized at Nebraska City by Maj. Earl M. Cline and



given Federal recognition July 5, 1921, as Headquarters Company of the First Battalion, 134th Infantry. The Company's strength at time of muster was two officers and seventy-seven enlisted men, but this was later reduced to two officers and forty-one enlisted men. In 1927 this strength was later reduced to two officers and twenty-five enlisted men.

This organization handles the communications, intelligence and administrative duties for the Battalion Headquarters and the lower echelons which compose the Battalion. The Company also cooperates with the entire Regiment in similar duties.

Special sectional groups within Headquarters consist of a Company Headquarters, an Intelligence Section, a Communication Platoon Headquarters, a Telephone and Wire Section, a Message Center and Messenger Section and a Radio and Panel Section.

Headquarters Company has attended all Federal field training camps since its organization, and was called out on riot duty at Omaha in June, 1935. Each year the unit has received a "Satisfactory" rating at Federal inspections under the following company commanders: First Lieut. William G. Utterback, July, 1921, to January, 1923; First Lieut. Varro E. Tyler, January, 1923, to July, 1925; First Lieut. Ray A. Thurman, July, 1925, to February, 1928; and First Lieut. Leslie Yager, Jr., February, 1928, to date.

This unit of the Nebraska National Guard is descended from one of Nebraska's oldest military organizations—the "Otoe Rifles," organized in Nebraska City on April 20, 1857.

FACTUAL HISTORY

Company "A," 134th Infantry, was recognized on July 14, 1925, with Capt. Varro E. Tyler in command. The present commander, Capt. Ray A. Thurman, took over command of the Company on March 8, 1928.

Company "A" is one of the direct descendants of one of the oldest military organizations in the state, the "Otoe Rifles," organized April 20, 1857, under command of Capt. Frank Bell. The Company was reorganized and redesignated Company "D," First Nebraska Volunteers, on June 15, 1861, and under Capt. Allen

This Company served as Company "A," Second Infantry, under Capt. W. S. Mapes in the Sioux Indian uprising of 1890-'91; and under Capt. Bill Hayward at Chickamauga during the Spanish-American War in 1898. In 1916 it was on the Mexican Border as Company "B," Fifth Nebraska, under Capt. Jay Holmes, and at Camp Deming, New Mexico, in 1917. The unit entered the World War as Company "B," 134th Infantry, and was used as replacements. As Company "A," 134th Infantry, Thirty-fifth Division, the Company served at the Omaha street-car strike in June, 1935, under Captain Thurman.

Among the commanders of the Company who have advanced to higher rank are Capt. William Bischoff, who became Lieutenant Colonel in 1890, and Capt. Clyde E. McCormick, who is now Colonel and commanding officer of the 134th Regiment.

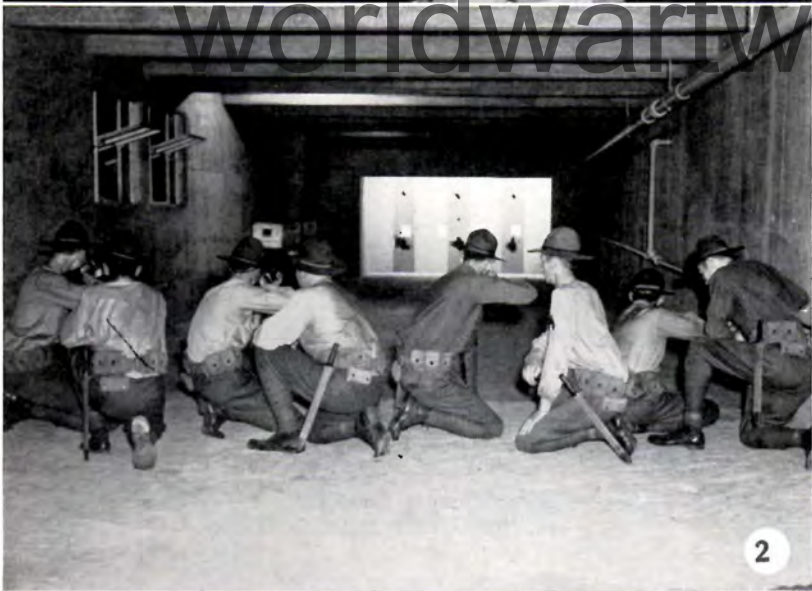

### FACTUAL HISTORY

The predecessor of Company "B," 134th Infantry, was organized in 1913 and mustered out of service May 15, 1916. It was re-recognized January 28, 1921, as the Seventh Separate Infantry Company. On July 1, 1921, it was redesignated Company "B," First Infantry, and on October 25, 1921, was given its present designation of Company "B," 134th Infantry.

The Seventh Separate Company, Infantry, was organized in the fall of 1920 through the efforts of E. D. Fisher, who became the Company's first Captain. The first annual encampment was made at Camp Dodge, Iowa.

On January 28, 1922, the Company was ordered out to Nebraska City for duty during a packing-house strike. Three officers and forty-five enlisted men of the Company served in Nebraska City until the trouble was put down February 16, 1922. First Lieut. Mervin F. Myers was promoted to the rank of Captain and given com-

mand of the Company in 1930. In January, 1932, Leo L. Smith was appointed First Lieutenant, and in 1934 Dewey E. Jackson was transferred from the Inactive to the Active List and assigned to Company "B."

The Company was called out for the Omaha street-car strike on June 15, 1935, and was ordered to South Omaha where the situation was rapidly getting beyond the control of local police authorities. The Company remained on this tour of duty for one week, experiencing no difficulty in controlling rowdy elements.

Company "B" moved into a new state-owned Armory on December 10, 1936. The Armory is modern in every respect and includes such facilities as shower baths, rifle range and drill hall 60x100 feet.

### FACTUAL HISTORY

Company "C," 134th Infantry, was first organized by Gen. L. W. Colby in 1875 as the "Paddock Guards." The Beatrice National Guard unit was designated Company "C," First Nebraska Infantry, in 1879 and since that time "C" has been the letter designation of the Beatrice Company in each of the three regiments of which it has been a part—the First, Fifth, and 134th Regiments of Infantry.

The Company has served on active duty as follows: Burlington railroad strike at Omaha in 1882; Indian uprising in northwestern Nebraska in 1890-'91; packing-house strike at Omaha in 1894; the Spanish-American War in 1898; Philippine insurrection of 1899; tornado relief duty at Omaha in 1913; Mexican Border service 1916-'17; World War 1917-'18; and the Omaha street-car strike riots of 1935.

Company "C," 134th Infantry, was Federally recognized January 26, 1921. This unit served as a Guard of Honor for General Pershing on his visit to Beatrice in August, 1924, and received a warm commendation from him. In 1924 and 1925 the Company won the Regimental Efficiency Cup for camp activities, and in 1929 the Company became the first Nebraska unit to win the Militia Bureau Trophy for excellence in rifle marksmanship. The Company has now won this trophy six times.

The small-bore rifle team of this unit won the Chief of the National Guard Bureau Indoor Rifle Match for Nebraska four years of the six the match has been held. Company "C" was judged the best Company of the Regiment for 1930 and 1931, and second best in 1932, 1933, and 1934. The competition ended in 1934. The unit received seven "Very Satisfactory" ratings at its annual Federal Armory inspection before this comparative rating was discontinued.

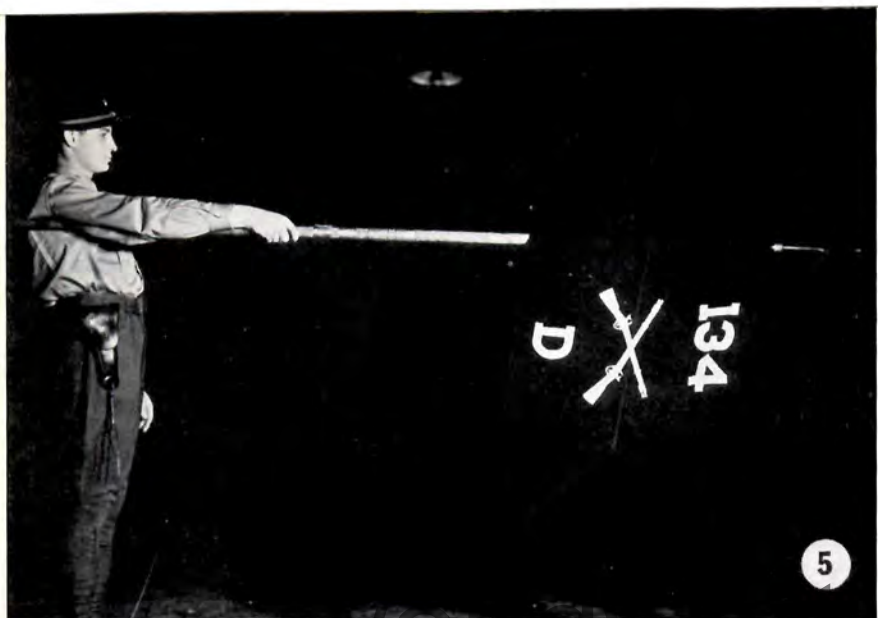

### FACTUAL HISTORY

Company "D," 134th Infantry, was organized May 11, 1923, with Capt. Cecil Cool, First Lieut. Butler B. Miltonberger and Second Lieut. Robert N. Land as officers. Denver Wilson was First Sergeant. Captain Cool left the Company soon after its organization and was succeeded to command by Lieutenant Miltonberger. First Lieutenant Miltonberger and Second Lieutenant Land were both promoted a grade higher after their first encampment and Fred C. Petersen, a World War veteran, was commissioned to fill the vacancy.

Company "D's" first camp was also the first camp ever to be held at Camp Ashland. Aside from learning the art of shoveling, ducking heavy rains and grubbing stumps, the unit came home as green as it left. Since

that time, however, it has made steady progress in military science.

Company "D" won the award of best National Guard Company in the state for the years 1932, 1933, 1934 and 1935. This is indicated by four silver bands on the guidon staff. The award was discontinued after the 1935 presentation.

The Company regrets the fact that it lost its commander, Captain Miltonberger, through promotion. He is now Major of the First Battalion, 134th Infantry.

The Company's only active duty tours so far consist of a call to stand ready during the Republican River flood and the anticipated flood of the South Platte River, and the duty during the Omaha street-car strike. The Company accomplished demobilization and subsequent duty in a creditable manner each time.

Present Company officers are Captain Petersen, First Lieut. Denver W. Wilson and Second Lieut. Dale M. Godwin.

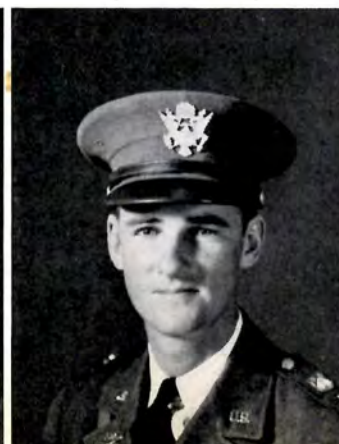

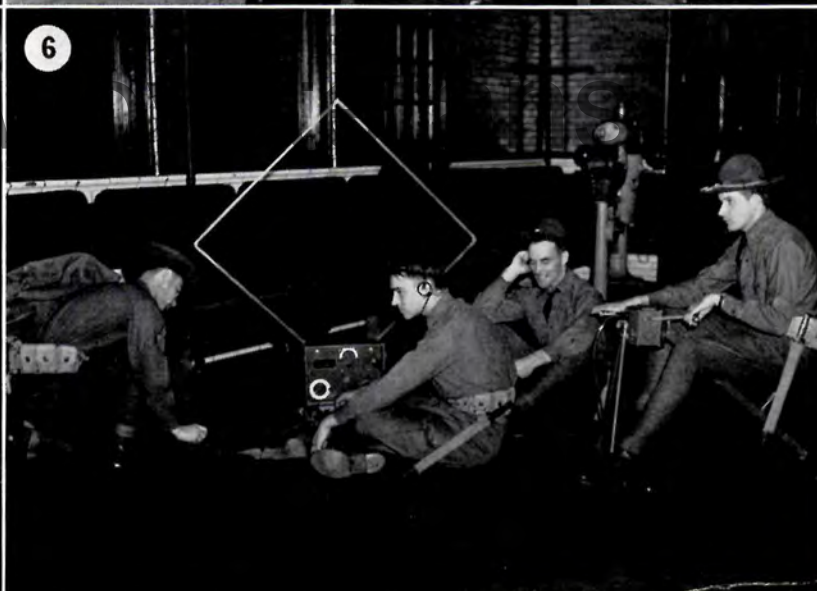
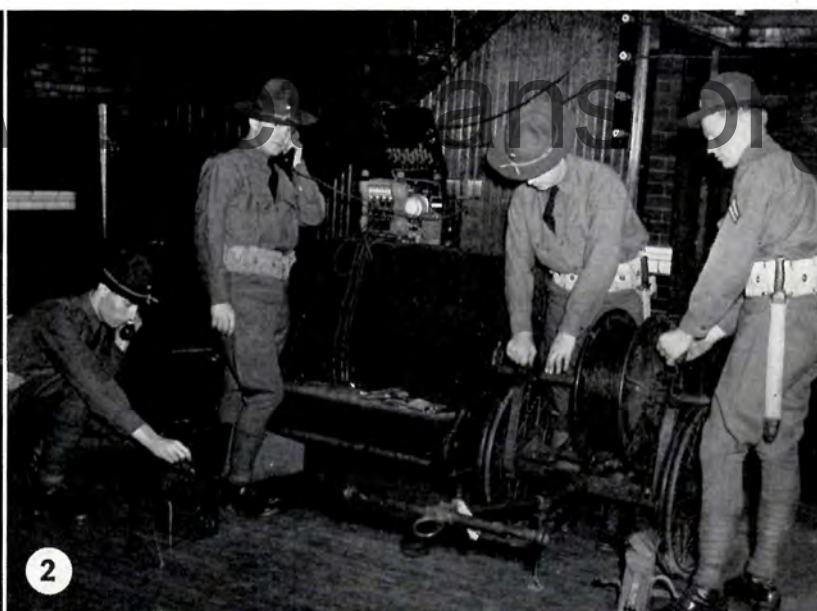

### FACTUAL HISTORY

Company "E," 134th Infantry, was first known as the First Separate Company and was mustered into service June 4, 1920, by Adjutant Gen. H. J. Paul at Scottsbluff, with a strength of eighty-three enlisted men, many of whom were former service men. Original officers of the unit, later to be designated Company "E," 134th Infantry, were Capt. Owen A. Frank, First Lieut. Carl E. Diers and Second Lieut. Jerome W. Smith.

The Company has never had an adequate Armory and as a consequence has been forced to occupy makeshift quarters. The unit has moved nine times. Jerome W. Smith succeeded Captain Frank to command of the

unit, and was in turn succeeded by Capt. Fred W. Stone. Since January, 1929, this Company has been commanded by Capt. Ora A. Eatwell. Other officers are First Lieut. Harold M. Runyon and Second Lieut. Kenneth E. Eckland.

Besides the annual field training at Camp Ashland and the 1937 Fourth Army maneuvers at Fort Riley, the Company has served the state on two occasions. In 1935 the unit was ordered to Omaha for the street-car strike disturbance and again in the same year to the headgates of the Mitchell irrigation ditch pending settlement of a dispute.

Rifle marksmanship has been stressed in the Company's training and several members have qualified for the State Rifle Team during the National Matches at Camp Perry. Three of the ten principals on the 1936 team were members of Company "E." This Company takes an active part in Memorial services each year, and since its organization Company "E" has given military burial for approximately fifty veterans.

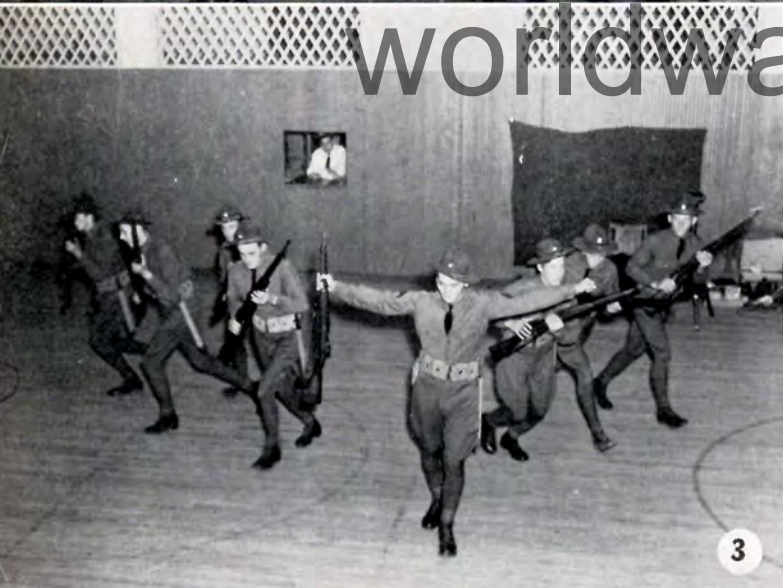
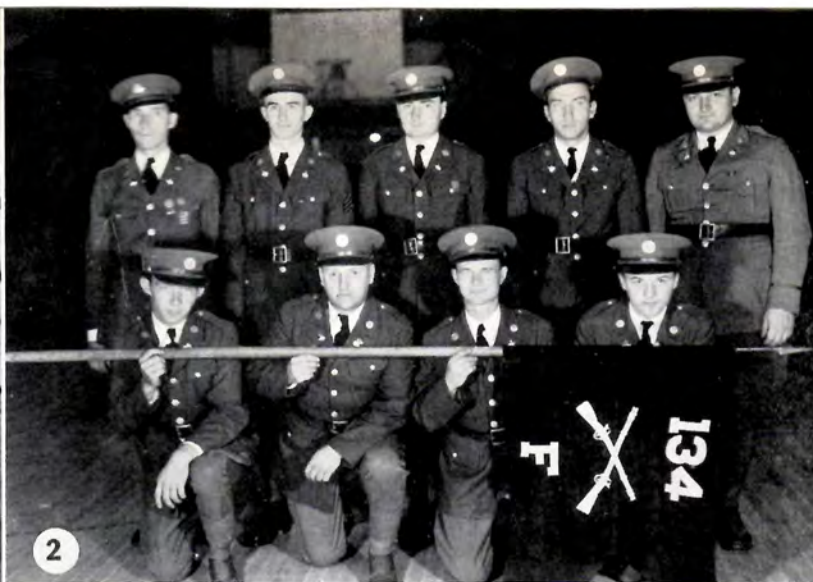
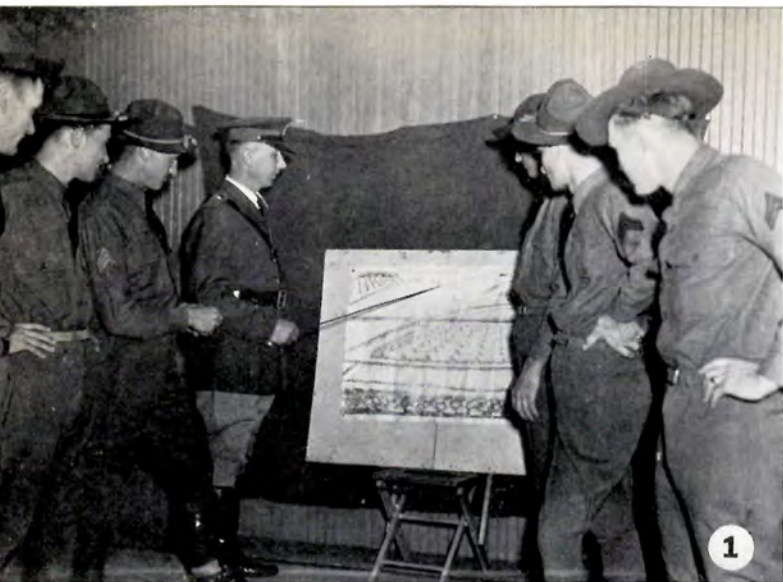

#### FACTUAL HISTORY

The first company of infantry to be organized in Hastings was Company "K," Third Nebraska Infantry, organized in 1898 by Harry S. Dugan for service in the Spanish-American War. On July 2, 1906, the "Hastings Rifles" were organized and in the spring of 1907 the Company was renamed Company "D," Second Infantry. This designation was retained until 1913, when the Company was redesignated Company "G," Fifth Infantry, Nebraska National Guard.

Company "G," Fifth Infantry, was called into service in 1916 and served on the Mexican Border until 1917.

#### HASTINGS, NEBRASKA

On February 15, 1917, the Company was mobilized for service in the World War and redesignated Company "G," 134th Infantry. The Company went overseas with its Regiment, but was later broken up for replacements.

The Ninth Separate Company (Provisional) was organized and given Federal recognition February 9, 1921. The Company was later given the designation of Company "G," First Infantry, Nebraska National Guard, but this was soon changed to Company "G," 134th Infantry.

### FACTUAL HISTORY

The direct ancestor of the present Company "H," 134th Infantry, was mustered into service at Lincoln, Nebraska, May 12, 1898, and during the Spanish-American War served as Company "M," Second Regiment, Nebraska Volunteer Infantry. This unit was commanded by Capt. George Roeder and remained in service until October 24, 1898.

Company "M," Fifth Nebraska Infantry, was organized at Grand Island in 1914, under the command of Capt. Robert McAllister, with First Lieut. Leo Allan and Second Lieut. Ernest Meyer. This unit saw service on the Mexican Border with its original officers, and was mustered out of service in February, 1917.

At the outbreak of the World War, Company "M," Fifth Nebraska Infantry, was ordered with its Regiment

to Camp Cody at Deming, New Mexico. While at Camp Cody the Regiment was reorganized and the Grand Island Company was designated as Company "H," 134th Infantry. It was transported overseas in the fall of 1918 and at the close of the war was mustered out of Federal service at its home station.

This Company was reorganized and given Federal recognition March 25, 1921, under the command of Capt. Ernest Meyer, First Lieut. A. S. Miller and Second Lieut. Bruce Donald. Since that date the Company has been commanded by Capt. A. F. Miller and Edgar Barratt, the present commanding officer. Company "H" served with its Regiment during the Omaha street-car riots of 1935 and took part in several bloodless battles for the protection of Artillery Ridge and other points of scenic interest on the Fort Riley Military Reservation in the summer of 1937.

Members of this Company take pride in the fact that for ten years the Company has won the General's Trophy, offered at Camp Ashland, Nebraska, to the company attaining the highest proficiency at the summer encampment.

#### FACTUAL HISTORY

Headquarters Company, Third Battalion, 134th Infantry, was organized and Federally recognized as a unit of the National Guard on July 6, 1921. The Company was first

granted an authorized strength of thirty-seven enlisted men and two officers, but this was later changed to twenty-five enlisted men and two officers. The Company attended the regular summer encampment in 1921 with only a few months of training.

On January 28, 1922, the Company was called out on state duty to help in quelling the Nebraska City riot. Members of the Company performed very creditably until February 12, when they were ordered home to resume their regular schedule of training. The second time the organization left the state was to attend the Fourth Army maneuvers at Fort Riley, Kansas, in August, 1937.

Headquarters Company was again called out for strike duty in June, 1935, and ordered to Omaha, Nebraska, during the street railway strike of that year.

During the seventeen years of its organization as a Federally recognized unit, the Company has had only six commanding officers, who were: Harry Grainger, Frank Watson, Edwin Hoke, Trev. E. Gillespie, Rolla C. Van Kirk, and the present commander, Clifford L. Dier.

#### FACTUAL HISTORY

In the diversity of its proficiency as well as in the diversity of its personnel, Company "I," 134th Infantry, bears a more striking resemblance to a Regular Army organization, perhaps, than does the average National Guard company. Whether it is executing the complicated gyrations of an intricate close-order drill pattern on the parade ground, or properly following vague, messenger-muddled orders on some far-flung tactical problem, whether it is observing every letter of march discipline on some seemingly useless midnight hike, or carrying out—faithfully and without question—the orders of its superiors in the soul-grinding, sand-bur finding, crawling, walking, running and charging of a maneuver, whether it is slogging, wet and bedraggled through a summer torrent, or sweating through the stifling heat of a summer day, Company "I" can be depended upon

to conduct itself like the organization of well-trained, well-disciplined, well-officered troops that it is.

And not without reason, for its personnel has all the interest in its achievement that the professional soldier has in that of his organization. In its ranks are men who have served in the Regular Army, the Marines, the Navy, and in National Guard units of Massachusetts, Pennsylvania, Minnesota, Iowa, Wyoming and California. Commissions in the Organized Reserves have been both refused and resigned by men who preferred to soldier in the ranks of an active company. Privates from Company "I" who have gone to Regular Army units have almost invariably earned their corporal's chevrons within a year. Men who had their first enlightening taste of military training in this, Lincoln's only rifle company, are serving as commissioned officers in the Regular Army—as officers in command of CCC camps, as flying cadets at Randolph Field, and as officers in the University of Nebraska Cadet Corps.

Since the National Guard's reorganization subsequent to the World War, Company "I," like its fellow companies of the regiment, has been occupied chiefly with preparing itself and keeping prepared for any emergency that might arise. Only twice since the war has it been called into active service, both times by the Governor for service in this state.

### FACTUAL HISTORY

Company "K," 134th Infantry, was organized and awarded Federal recognition January 25, 1921, under the command of Capt. John M. Guild, First Lieut. Douglas Smith and Second Lieut. David M. Martin. The entire Company personnel was recruited from employees of the Union Pacific Railroad.

The succession to command of Company "K" has been as follows: Capt. David M. Marvin, December 16, 1921; Capt. Bert C. Grasborg, February 21, 1922; Capt. Claude T. Frimann, April 14, 1928; Capt. Emil

B. Peterson, March 12, 1931; and the present commander, Capt. Edwin C. Gatz, February 7, 1937, with First Lieut. Harry B. Jacobsen and Second Lieut. Emil C. Wagner.

Since the date of its Federal recognition Company "K" has had but one opportunity of serving the state either in time of disaster or local disturbance. The Company was called out to serve from June 15 to June 21, 1935, during the street-car strike of that year. The entire 134th Infantry was ordered to Omaha to establish martial law and to quell disturbances attendant with the strike. Company "K," with other local units, was first on the scene and bore the brunt of the duties in establishing law and order.

### FACTUAL HISTORY

Company "L," 134th Infantry, is a descendant of one of the Omaha companies of militia which were ordered out by Governor Izard to quell an uprising of the Sioux Indians in 1855. This Company fought in the Civil War and in the Indian uprisings of the 1870's and '80's.

The Company was known as the "Thurston Rifles" in 1890 and three years later was given the designation of Company "L," First Nebraska Infantry. It was called into service in 1898 and sent to the Philippines during the Philippine Insurrection, where it saw service at the capture of Manila on August 13, 1898, and at Luzon on February 4, 1899.

In 1903 the Company was again reorganized as Company "L," First Nebraska Infantry, later becoming known as Company "L," Fifth Nebraska Infantry. The Company was sent to the Mexican Border and served at Llano Grande from July 5 to December 26, 1916. The unit served as a replacement company during the World War.

On August 17, 1920, it was recognized as the Second Separate Company of Infantry, Nebraska National Guard, and was redesignated Company "L," First Infantry, on July 1, 1921. It was given its present designation of Company "L," 134th Infantry, October 25, 1921, under command of Capt. Frank L. Peterson, with First Lieut. Paul Auxier and Second Lieut. Sam Cahnn.

The present commanding officer, Capt. Earl H. Kelso, was given command of the unit upon the transfer of Capt. Alfred Thomsen to the Regimental Staff. Since its reorganization following the World War Company "L" has attended field training camps as follows: Camp Dodge, Iowa, 1921; Camp Berry, Nebraska, 1922; Camp Ashland, Nebraska, from 1923 to 1936; Camp Whiteside, Kansas, 1937; and Camp Ashland, 1938. The unit was called out by Governor Cochrane in June, 1935, to assist in quelling the disturbances caused by the Omaha street-car strike.

This Company is proud of the record of one of its members, Corp. Edward E. Moe. Corporal Moe has not missed an Armory drill or a summer camp since October 11, 1927, and at this time has to his credit 522 consecutive Armory drills.

#### FACTUAL HISTORY

Company "M," 134th Infantry, was organized May 24, 1921, and was given Federal recognition June 7, 1921, under the command of Capt. Erle B. Smiley, with Charles H. Campbell as First Lieutenant and Harry C. Turner as Second Lieutenant. The Company was detailed to Nebraska City for two weeks in February, 1922, and in 1923 Lieutenant Campbell took over command of the Company upon the resignation of Captain Smiley. In 1926

Edward J. Geesen was promoted to the command of Company "M" upon the resignation of Captain Campbell.

Company "M" was called out for active duty in Omaha in June, 1935, in connection with a strike of traction company employees. Captain Geesen was promoted to Major in 1936 and assigned to the Third Battalion, which he now commands. His place as Captain of Company "M" was taken by Erwin A. Jones, with Paul C. Hauck as First Lieutenant and Harold J. Firnhaber as Second Lieutenant.

This Company took part in the Fourth Army maneuvers held at Fort Riley during the 1937 summer encampment.

## *Medical Regiment*



The 110th Medical Regiment is the lineal descendant through World War service of the 110th Sanitary Train (Missouri and Kansas lineage), plus the 166th Hospital Company of the 117th Sanitary Train (Nebraska lineage).

The units of the 110th Medical Regiment originating in Nebraska, Missouri and Kansas served in one or other of two infantry divisions during the World War—the Thirty-fifth and Forty-second. Two hospital companies and two ambulance companies from Missouri and an equal number from Kansas were a part of the 110th Sanitary Train, Thirty-fifth Division (Santa Fe Trail). One hospital company from Nebraska, said to be the oldest independent Medical Department company of the National Guard west of the Mississippi, was an element of the 117th Sanitary Train, Forty-second Division.

This Nebraska Company was the only one of these medical companies to be reorganized after the war before the authorization to organize the 110th Medical Regiment was promulgated. Allocation of the regiment, at first, was to the three states. Later, the entire regiment was re-allocated to Nebraska.

In November, 1922, Dr. H. Winnett Orr of Lincoln, Nebraska, was commissioned by the Adjutant General of Nebraska to organize the 110th Medical Regiment and commissioned Colonel. By May, 1923, little progress had been made owing to numerous obstacles, chief of which was lack of interest among the profession and the public. Only the 130th Ambulance Company had been organized at Hastings, Nebraska. At this juncture, a committee on recruiting consisting of Lieut. Col. David C. Hilton, M. C., Capt. Earl B. Brooks, M. C., and Capt. John Carl Norden, V. C., was authorized to proceed as it saw fit, with

the objective of bringing a Medical Regiment into camp that summer. A house-to-house canvass was put on in Lincoln. Meetings at railroad yards, shops, wholesale houses, factories, colleges, and Y. M. C. A.'s were addressed. Only an occasional prospect enlisted. "Pacifism" was rampant. We had something new which the public did not understand. The average mother was inclined to look on us with suspicion. It seemed that the war to prevent war must be over and she was relieved if we left the home without the boy. The National Defense Act was interesting to people, but they had never heard of it before. The net accomplishment was to muster into the regiment the 166th Hospital Company that had already been Federally recognized two years previously and the 130th Ambulance Company of Hastings, to obtain Federal recognition of the new Lincoln companies (110th Veterinary Company and Service Sections) and of regimental headquarters, June 23, 1923. Thus the 110th Medical Regiment came into existence.

In 1924 the Band at Crete, Nebraska, was Federally recognized and later the present Band was organized at Lincoln, Nebraska. In the same year the 130th Collecting Company was Federally recognized at Columbus, Nebraska. Finally, in May, 1936, the regimental organization as per present peace tables (N. G.) was completed by gaining Federal recognition of the 128th Ambulance Company organized at Fairbury, Nebraska.

Col. David C. Hilton assumed command of the 110th Medical Regiment April 24, 1925.

Under provisions of General Orders No. 16, War Department, 1921, as amended, the 110th Medical Regiment, Nebraska National Guard, is entitled to streamers as follows: (1) Alsace, (2) Lorraine, (3) Meuse-Argonne.

## FACTUAL HISTORY

The antecedants of the Service Company as promulgated by the War Department are as follows:

Organized May 20, 1907, as Field Hospital, Missouri National Guard; January 21, 1916, redesignated Field Hospital No. 1. Mexican Border; Mustered in June 26, 1916; mustered out January 5, 1917. World War: Mustered in June 3, 1917; redesignated Field Hospital No. 137, 110th Sanitary Train, Thirty-fifth Division, October 6, 1917; left U. S. May 19, 1918. Battle Credits: Gerardmer Sector (Alsace) June 30, 1918-September 2, 1918; Grange-le-Comte Sector (Lorraine) September 21, 1918-September 25, 1918; Meuse-Argonne Offensive September 26, October 3, 1918, October 14, 1918-November 8, 1918. Returned to U. S. April 27, 1919; demobilized May 7, 1919.

The post-war reorganization of the service company began with the Federal recognition of the Thirty-fifth Division Medical Laboratory Section under the command of Carl Henrich Bastron, First Lieutenant, M. C., on March 4, 1923.

Two more units were recognized on June 29, 1923. These were 110th Medical Regiment Headquarters Detachment under Earl B. Brooks, Captain, M. C., and Thirty-fifth Division Medical Supply Section under Harry R. Ball, Captain, M. A. C.

The above three units attended the annual encampment in August, 1923.

The Band Section was organized at Doane College, Crete, Nebraska, under Warrant Officer Lumir C. Havlicek on May 15, 1924.

## FACTUAL HISTORY

The 110th Veterinary Company was organized July 23, 1917, as Ambulance Company No. 2, Missouri National Guard. The unit was drafted



August 5, 1917, and was redesignated Ambulance Company No. 138, 110th Sanitary Train, Thirty-fifth Division, on, October 6, 1917. It served in the Gerardmer Sector June 30 to September 18, 1918; the Grange-le-Compte Sector September 21-25, 1918, and the Meuse-Argonne Offensive September 26 to October 3 and from October 14 to November 8, 1918. The Company was demobilized May 7, 1919.

The unit was reconstituted and consolidated in December, 1927, with the 110th Veterinary Company, 110th Medical Regiment which was organized June 29, 1923. Officers at the time of Federal recognition were Capt. Simon W. Alford and First Lieut. F. R. Woodring. Captain Alford has continued as commanding officer to date. Lieutenant Woodring resigned July 1, 1926, and was succeeded by First Lieut. Louis V. Skidmore, who was Federally recognized July 12, 1927.

The maintenance strength of the Company at its Federal recognition was two officers and twenty-eight enlisted men. On January 1, 1926, the strength of the unit was changed to two officers and thirty-six enlisted men. The Company was redesignated Veterinary Company, 110th Medical Regiment, on January 1, 1936.

FACTUAL HISTORY

Company "C," 110th Medical Regiment, was organized and Federally recognized on June 25, 1924. The Company is a descendant of and is entitled to the war service credits of the Sanitary Train of the Rainbow Division. At the time of the Company's reorganization Capt. J. North Evans was in command, with Capt. C. D. Evans, Jr., serving as his junior officer.

Capt. North Evans reached his majority in 1928 and was succeeded by Capt. C. D. Evans, Jr., who remained

in command until his resignation in 1935. He was followed by Capt. R. C. Anderson, the present commander. Lieut. W. H. Pennoyer was commissioned in 1936, but resigned from the Company in 1938. First Sgt. Carroll Brown served until 1927 and was followed by First Sgt. John Putnam, who died in 1929. His place was taken by First Sergeant Brodfuehrer, who now holds that place.

Company "C," a medical unit and therefore not expected to be proficient in close-order drill, surprised infantry instructors in 1928 by winning the trophy awarded the best drilled unit in the state. This Company enjoys the unique distinction of never having been called out for any state emergency, whether strike or flood.

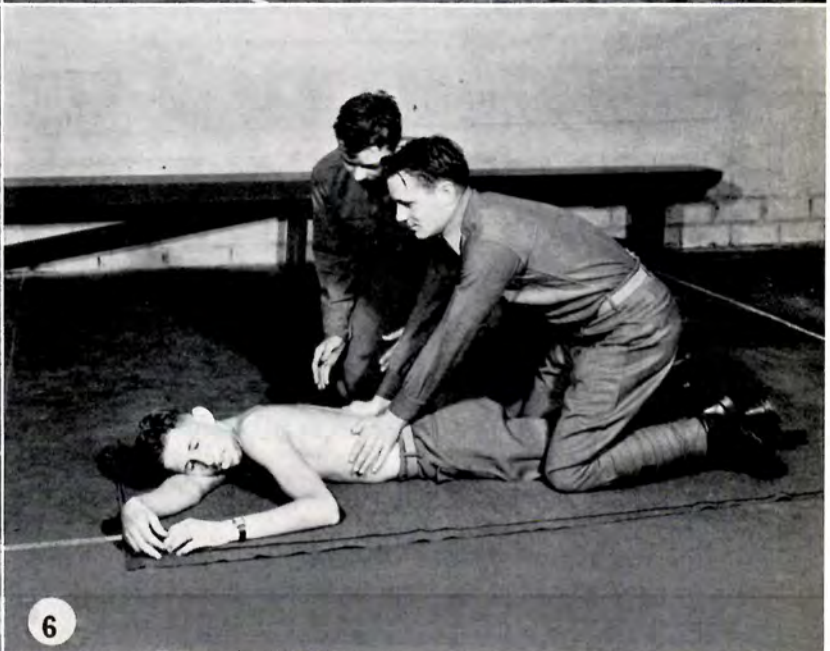
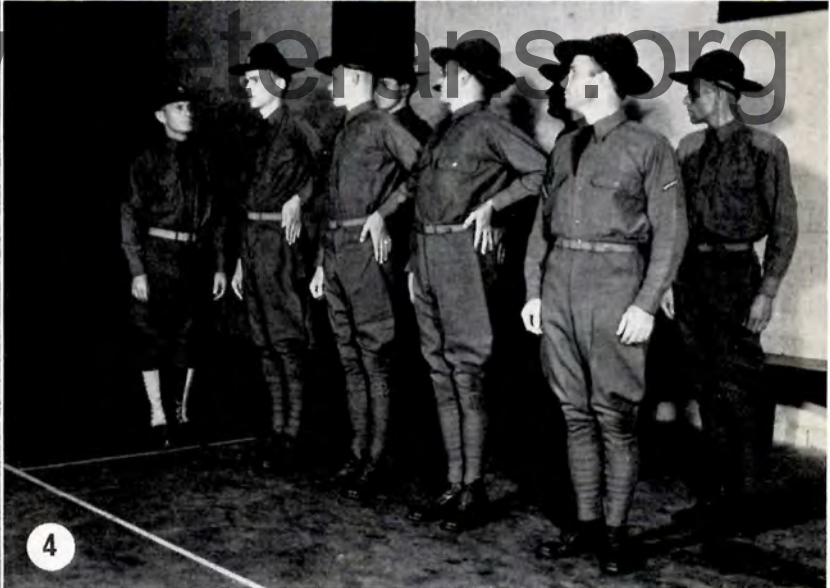

### FACTUAL HISTORY

Company "D," 110th Medical Regiment, the baby of the Nebraska National Guard, was Federally recognized May 22, 1936, after having been given eight days to recruit and examine the personnel, present them for recognition and provide an Armory. After this whirlwind start Capt. George W. Ainlay carried on by outfitting and training his Company to the point where, in one month and a half, the men were ready to take the field for the first annual summer encampment. First Lieut. Miles S. Banks was not assigned as a junior officer until January, 1937.

The habit of working efficiently under high pressure is now one of the Company's outstanding traits, for

since its inception it has participated in twenty-seven community functions. It handled well its assignments in the 1937 Fourth Army maneuvers at Fort Riley and won the Colonel's Cup for Efficiency, as well as the Bugle, at the 1938 encampment at Camp Ashland.

Company "D" is considered to be the lineal descendant of the 140th Ambulance Company of the 110th Sanitary Train, Thirty-fifth Division, demobilized May 7, 1919. This Company was formerly known as Ambulance Company No. 1, Kansas National Guard, organized May 5, 1917. At the time of Company's "D's" organization it was known as the 128th Ambulance Company. It was not given its present designation until January, 1937.

The organization is proud of its new equipment, and it was considered a great event when it transported itself for the first time to the 1938 encampment.

### FACTUAL HISTORY

Company "F," 110th Medical Regiment, was organized December 12, 1911, as Ambulance Company "B," Missouri National Guard. The Company was redesignated Ambulance Company No. 2 on January 22, 1912, and redesignated Ambulance Company No. 1 on January 21, 1916.

The Company was mustered into service June 24, 1916, for Mexican Border duty and was mustered out January 5, 1917. On June 3, 1917, it was mustered for overseas service and was redesignated Ambulance Company No. 137, 110th Sanitary Train, Thirty-fifth Di-

vision, on October 6, 1917. It left the United States May 19, 1918. Its battle credits are as follows: Gerardmer Sector, June 30 to September 2, 1918; Grange-le-Compte Sector, September 21 to September 25, 1918; and the Meuse-Argonne Offensive, September 26 to October 3, 1918, and October 14 to November 8, 1918.

The Company returned to the United States April 27, 1919, and was demobilized May 7, 1919. It was reconstituted and consolidated in December, 1927, with the 130th Ambulance Company, 110th Medical Regiment, which was organized April 5, 1923. On December 23, 1936, the Company was redesignated Company "F," 110th Medical Regiment.

This Company served on flood duty from June 1 to June 4, 1935, at Oxford, Nebraska, along the Republican River, and from June 15 to June 21 of the same year in Omaha during the street-car strike.

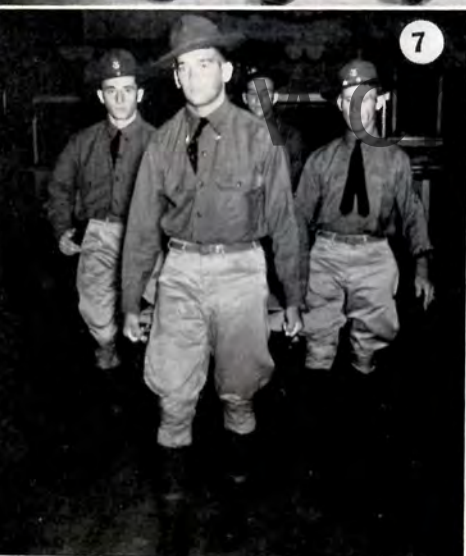

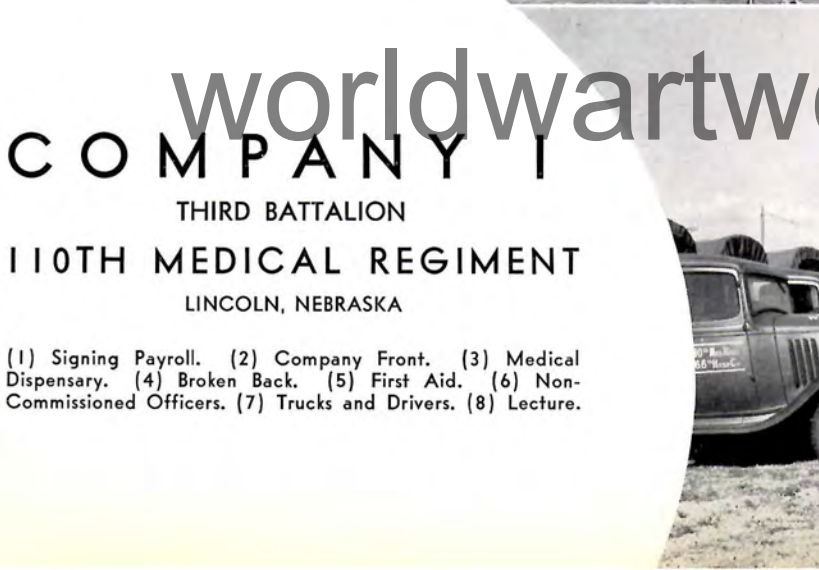
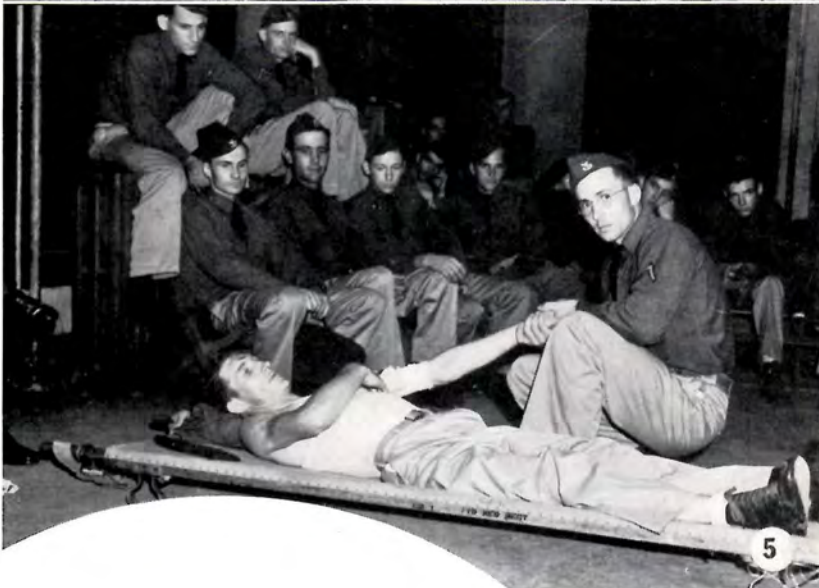

#### FACTUAL HISTORY

The present Company "I," 110th Medical Regiment, organized January 1, 1927, was first recognized May 10, 1905, as the Ambulance Company. On December 26, 1907, the Company was redesignated Field Hospital No. 1.

It was mustered into service July 7, 1916, for Mexican Border duty and was mustered out March 3, 1917. The unit was called back into service for the World War July 23, 1917, and was redesignated as Field Hospital Company No. 2, 117th Sanitary Train, Forty-second Division, on August 16, 1917. On September 15, 1917, it was redesignated the 166th Field Hospital Company, 117th Sanitary Train.

The Company is entitled to battle credits for its service in the Luneville Sector, the Baccarat Sector, the Esperance-Souain Sector, Champagne-Marne Offensive, Aisne-Marne Offensive, St. Mihiel Offensive, Essey and Pannes Sector and the Meuse-Argonne Offensive. It returned to the United States and was demobilized May 15, 1919.

The unit was reorganized as Hospital Company No. 1 May 23, 1921. On October 25, 1921, it was redesignated 130th Hospital Company and on September 1, 1927, was redesignated the 166th Field Hospital. It was redesignated the 166th Hospital Company February 10, 1930, and was given its present designation of Company "I," 110th Medical Regiment, January 1, 1937.

The Company served on rescue and relief work from June 1 to June 6, 1935, during the Republican River flood and from June 15 to June 22 of the same year rendered medical service during the Omaha street-car strike.

## *Quartermaster Regiment*



National Guard units of the several states were called into Federal service by Presidential Proclamation August 5, 1917, and on that date the Missouri Supply Train (Motor) assembled at its home station in St. Louis, Missouri. By general order of the War Department July 18, 1917, Camp Doniphan, Oklahoma, was assigned as the training camp for units of the Thirty-fifth Division, which was to be composed of Kansas and Missouri National Guard troops. Maj. Gen. William W. Wright was ordered to command of the Thirty-fifth Division.

The 110th Supply Train (Missouri Supply Train), predecessor of the 110th Quartermaster Regiment, was organized at Camp Doniphan September 13, 1917. During its service in France it participated in active operations as follows: Geradmer Sector (Alsace), July 1 to September 2, 1918; Grouge-le-Compte Sector (Lorraine), September 21 to 25, 1918; and the Meuse-Argonne, September 26 to October 3, 1918, and October 14 to November 8, 1918.

The unit sailed April 16, 1919, from St. Nazaire for return to the United States. It arrived at Newport News, Va., April 29, 1919, and went to Camp Funston, Kansas, where its disbandment was completed May 7, 1919.

The Thirty-fifth Division Train was allotted to Nebraska on September 1, 1921, and the Thirty-fifth Division Train Headquarters was Federally recognized June 7, 1923, at Lincoln, Nebraska. In 1925 the 110th Supply Train was, with the consent of the Governor of Missouri, reconstituted and consolidated with the Thirty-fifth Division Quartermaster Train, Nebraska National Guard. It was redesignated the 110th Quartermaster Regiment, Nebraska National Guard, effective April 1, 1936.

The history of the companies composing the Regiment is as follows:

"Company 'A.' Organized December 29, 1922, as the 137th Motor Truck Company, Thirty-fifth Division, Quartermaster Train; redesignated Company 'A,' 110th Quartermaster Regiment, April 1, 1936.

"Company 'B.' Organized May 22, 1923, as the 138th Motor Truck Company, Thirty-fifth Division, Quartermaster Regiment; redesignated Company 'B,' 110th Quartermaster Regiment, April 1, 1936.

"Company 'C.' Organized March 23, 1923, as the 119th Wagon Company, Thirty-fifth Division, Quartermaster Train; redesignated Company 'C,' 110th Quartermaster Regiment, April 1, 1936.

"Company 'D.' Organized March 29, 1923, as the 120th Wagon Company, Thirty-fifth Division, Quartermaster Train; redesignated Company 'D,' 110th Quartermaster Regiment, April 1, 1936.

"Company 'E.' Organized April 2, 1929, as the 119th Motor Repair Section, Thirty-fifth Division, Quartermaster Train; redesignated Company 'E,' 110th Quartermaster Regiment, April, 1936.

"Company 'F.' Allocated to the State of Kansas as the 110th Motorcycle Company and reallocated to Nebraska as Company 'F,' 110th Quartermaster Regiment, April 8, 1936. No record of its organization. The National Guard Bureau advises informally that it is inactive."

Headquarters Company. Organized June 7, 1923, as Headquarters Detachment, Thirty-fifth Division, Quartermaster Train.

Headquarters Second Battalion. Organized April 1, 1936, General Order 6 AGO, Nebraska, March 30, 1936.

On May 11, 1923, Maj. Marcus L. Poteet was placed in command of the Thirty-fifth Division Train, Quartermaster

Corps, Nebraska National Guard. He commanded until December 30, 1932, when he became Division Quartermaster, and Maj. Guy N. Henninger took command and remained in command of this organization until April 1, 1936, when the Thirty-fifth Division Train was reconstituted as the 110th Quartermaster Regiment. Col. Marcus L. Poteet was placed in command with a regimental staff consisting of Lieut. Col. Guy N. Henninger, Executive Officer; Capt. Willis F. Haycock, Division Supply Officer; Capt. Doy H. Carr, Plans and Training Officer; and Lieut. Richard V. Koupal as Regimental Adjutant.

This entire Regiment had state service in the Omaha street-car strike in June, 1935. Portions of the Regiment were in the Republican River flood disaster relief work May 31 and June 1, 2, 3 and 4, 1935, and a part of the Headquarters of this Regiment were called for duty in the "water war" at Scottsbluff in August, 1935.

FACTUAL HISTORY

Headquarters Company, 110th Quartermaster Regiment, was first organized and Federally recognized on June 7, 1923, as Headquarters Detachment, Thirty-fifth Division,

Quartermaster Train, with official headquarters at Lincoln, Nebraska. The personnel consisted of First Lieut. George Cravens, commanding, Second Lieut. Michael A. Blodgett, Train Supply Officer, and eleven enlisted men.

First Lieut. Claude L. Williams commanded the Detachment from February 26, 1924, to April 15, 1929, and First Lieut. Howard Turner, with Second Lieut. William H. Browne as Train Supply Officer, was in command April 20, 1929, to November 4, 1933. Lieutenant Brown was promoted to First Lieutenant on November 22, 1933, and given command of the Detachment, with Second Lieut. Herbert D. Gish as Train Supply Officer.

Quartermaster Section, Headquarters Detachment, Thirty-fifth Division, less one officer, was organized in Missouri on December 8, 1921, and re-allotted to Nebraska on April 8, 1936. Headquarters Detachment, Thirty-fifth Division, Quartermaster Train, and Quartermaster Section, Headquarters Detachment, Thirty-fifth Division, were consolidated and redesignated Headquarters Company, 110th Quartermaster Regiment, on June 17, 1936. The three officers were Capt. William H. Browne, Commanding; First Lieut. Herbert D. Gish, Regimental Supply Officer; and First Lieut. Harold G. Petz. The enlisted personnel consisted of thirty-one men.

This unit served the community and the state in emergencies at Oxford, Nebraska, during the Republican valley flood disaster, from May 27 to June 4, 1935, and again at Omaha during the street railway strike of June, 1935. The Company's high standards are reflected in the small turnover of the enlisted personnel, and especially of the non-commissioned officers.

Since its organization Headquarters Company has received only the highest ratings at its annual Armory inspection. During the 1937 maneuvers of the Fourth Army at Fort Riley, Kansas, this unit functioned very creditably in feeding and supplying the Thirty-fifth Division.

FACTUAL HISTORY

Besides participating in every annual encampment since its organization, the Medical Department Detachment, Thirty-fifth Division, Quartermaster Train, Kear-



ney, Nebraska, has also done flood duty and riot duty and taken part in the Fourth Army maneuvers at Fort Riley, Kansas, in 1937.

When organized on June 5, 1923, it was under the command of Maj. R. R. Ensor, M. C. The Veterinary Section, organized at Fremont, Nebraska, on July 23, 1923, under command of Capt. Charles H. Chambers, V. C., was mustered out on June 30, 1926, and re-established at Kearney.

When the Thirty-fifth Division Quartermaster Train was redesignated the 110th Quartermaster Regiment on

April 1, 1936, the Medical Department Detachment was reorganized (under T-O 91-NG Feb. 27, 1936) and redesignated a detachment of that regiment. The present commander, Maj. Wallace E. Rose, M. C., regimental surgeon of 110th Q. M. Regiment, assumed command of the detachment on May 5, 1927, succeeding Capt. Henry Farrell, resigned.

Answering the call of the Governor on two occasions, the Detachment did flood relief duty in the Republican River Valley and riot duty in Omaha during the street-car strike in that city, both events occurring in June, 1935.

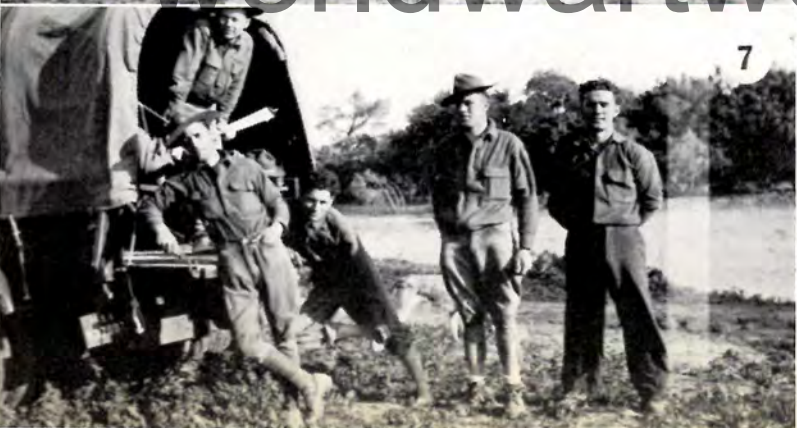
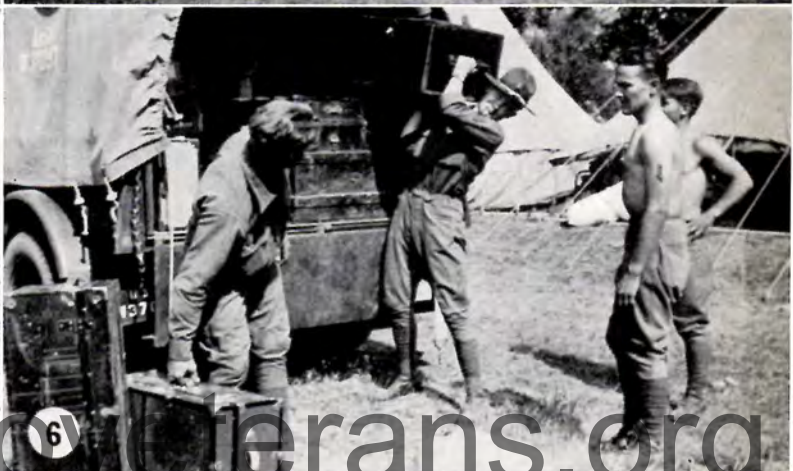

### FACTUAL HISTORY

Company "B," 110th Quartermaster Regiment, was first organized as the 138th Motor Transport Company in May, 1923, under the command of First Lieut. Walter Williams and Second Lieutenant Dow. Nels A. Olson, now the commanding officer, was then First Sergeant of the Company of fifty-four enlisted men.

Lieutenant Dow resigned in January, 1924, and First Sergeant Olson became Second Lieutenant until September, 1924, when he was promoted to First Lieutenant and given command. He discharged all the members of the Company with the exception of five enlisted men and reorganized the unit. The 138th Motor Transport Company was on active duty during the Omaha street-car strike in June, 1935. In April, 1936, when the 110th

Quartermaster Regiment was authorized, this Company was redesignated as Company "B" of that Regiment, with two officers and forty-five enlisted men. The officers were Captain Olson and Second Lieut. Vaughn Peterson.

John A. Waterman, the present First Sergeant, has been in the Company since its organization. Second Lieut. Egbert E. Hammond was promoted to First Lieutenant in February, 1938, when Lieutenant Peterson was transferred to the command of Company "E" upon the resignation of Captain Yakish.

The Company was called upon to furnish a guard for the President of the United States on his visit to Fremont September 29, 1935. Company "B" also convoyed the Omaha units to Fremont to assist in furnishing a guard.

### FACTUAL HISTORY

Company "C," 110th Quartermaster Regiment, was first organized in the winter of 1922-'23 and given Federal recognition March 23, 1923, as Wagon Company No. 119, Thirty-fifth Division Train, Nebraska National Guard. Victor M. Hovis, one of the principal organizers, was commissioned Captain and given command on the date of Federal recognition. Many of the early members of the Company were World War veterans.

Captain Hovis remained in command until June 4, 1929, when he was assigned to the State Staff. During the Captaincy of Captain Hovis the Company received a number of honors at the various summer encampments at Camp Ashland. The Company has been consistently successful in winning rifle honors, with several members going to the National Rifle Matches at Camp Perry as part of the Nebraska state team. Those most persistent in qualifying each year were Captain Hovis, Lieut. B. Clarence Neff and Sgts. O. H. Burnett, Lloyd Whaley and C. T. Smith. In 1923 and 1926 the 119th Wagon Company won the championship of the Thirty-fifth Division Train in competitive rifle marksmanship.

Capt. Clarence Neff assumed command on June 6, 1929, and during this year the Company began training with mules. The fact that the members became good "mule skimmers" was demonstrated by their trim ranks while passing in review on Governor's Day. Captain Neff resigned in 1930 and Merton O. Bates was commissioned Captain and given command on February 28, 1930.

In 1934 the 119th served admirably during the strike in Omaha and the flood in the Republican valley. The only incident to mar Captain Bates' command was the deal put over on the Company by Captain Mattson of the 120th Wagon Company. This intrepid Captain cunningly managed to have the 119th Wagon Company bury one of his dead mules.

On March 30, 1936, the Company was redesignated Company "C," 110th Quartermaster Regiment. Shortly thereafter Captain Bates resigned and on June 22, 1936, Monte R. Kiffin was commissioned Captain and given command. Under the leadership of Captain Kiffin the unit has been getting consistently better ratings on rifle and Federal inspections.

## FACTUAL HISTORY

Company "D," 110th Quartermaster Regiment, was organized at Kearney, Nebraska, as the 120th Wagon Company, Thirty-fifth Division Train, in March of 1923, with Capt. Ira D. Beynon commanding.

Captain, Beynon resigned his command in April 1927, and First Lieut. Guy N. Henninger was assigned as Commanding Officer and promoted to Captain.

On January 4, 1933, Captain Henninger was assigned as Commanding Officer of the Thirty-Fifth Division Train, and promoted to Major. First Lieut. W. J. Atkinson was assigned to command Company "D," and promoted to Captain.

The Thirty-fifth Division Train was redesignated as the 110th Quartermaster Regiment on April 1, 1936, and the 120th Wagon Company became Company "D," 110th Quartermaster Regiment, changing from an animal-drawn unit to a motor transport company. Captain Atkinson was promoted to Major, and assigned to command the Second Battalion of the Regiment, and

First Lieut. Herman G. Mattson was assigned to command Company "D."

In July, 1934, the 120th Wagon Company was in charge of the salvage of the National Geographic-U. S. Army Stratosphere balloon, which fell in the vicinity of Loomis, Nebraska, serving on that duty July 28, 29, and 30.

The 120th Wagon Company was called out for duty in the Republican River flood at Oxford, Nebraska, and vicinity, and served there from June 1 to 4, 1935, inclusive.

Almost immediately upon the return of the Company from flood duty, they were called to Omaha because of the street-car strike, and served on that duty from June 15 to 21, 1935, inclusive.

On January 1, 1937, Company "D" moved into the new Armory at 16th and Central Avenue.

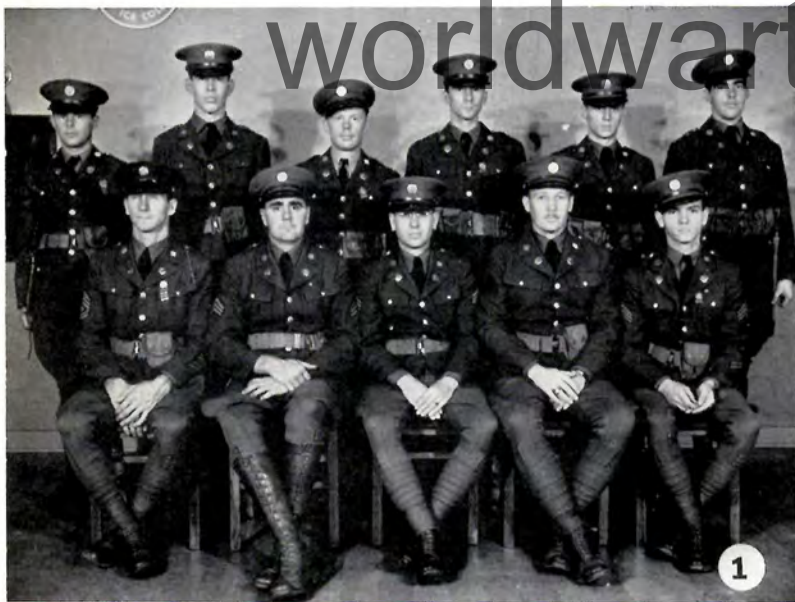

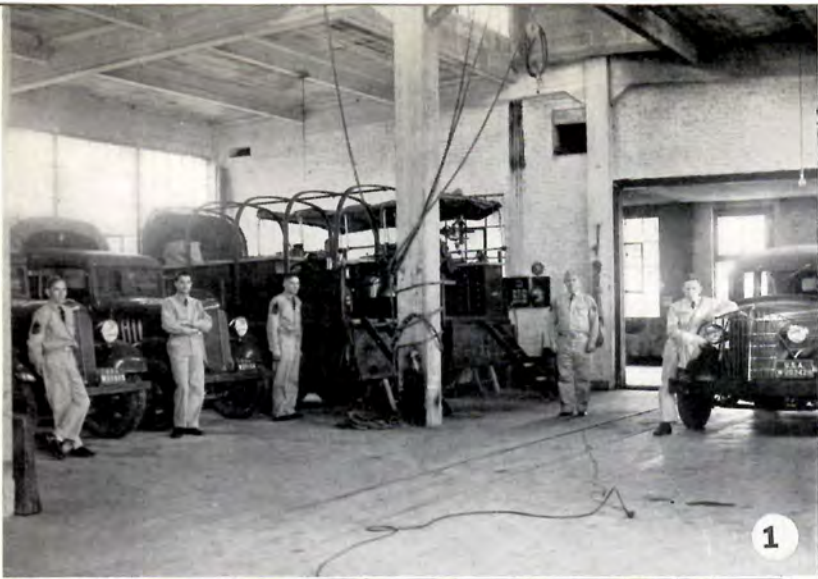

of the parapet; the foe could see him from his knees up. He quietly drew his sword and allowed the rebel skirmishers to empty their guns at him, and then gave the command, 'Forward, Ninety-seventh! Charge!' Before the enemy could reload their guns his soldiers were upon them, rolling down the hill like an avalanche and up the other side with great force. Vifquain made for the battle-flag on the works, with the color company right upon his heels. While he cut the halliard of the rebel standard with his sword and was in the act of pulling it down, his color-bearer planted the Union standard by his side. For a second or two Vifquain was hidden by the folds of the victorious banner mingling with the colors of the enemy. The color-bearer was killed on the spot. General Canby that same evening sent Colonel Vifquain a note in pencil which read as follows: 'Dear Colonel—Thank you, and may God bless you and your brave boys. E. R. S. Canby.'

#### INDIAN WAR

Co-Rux-Te-Chod-Ish (Mad Bear). At Republican River, Kansas, July 8, 1869. Sergeant, Pawnee Scouts, U. S. Army. Ran out from the command in pursuit of a dismounted Indian; was shot down and badly wounded by a bullet from his own command. Residence at enlistment unknown. Born in Nebraska.

#### INDIAN WAR

Herron, Leander. Near Fort Dodge, Kansas, September 2, 1868. Corporal, Company "A," Third U. S. Infantry. While detailed as mail courier from the fort, voluntarily went to the assistance of a party of four enlisted men, who

were attacked by about fifty Indians at some distance from the fort and remained with them until the party was relieved. Lives at St. Paul, Nebraska.

From 1866 until 1881 the numerous calls for troops to quell Indian disturbances caused detachments to be mobilized and moved to the scene of the trouble. During this period the War Department was asked to establish roads north and south across the state to facilitate movement of troops during Indian troubles. Carrying out the above request necessitated the building of bridges across the Platte River. This did much to remove the barrier between the north and south portions of the state.

On July 13, 1881, the Regiment was re-organized and redesignated the First Regiment, Nebraska National Guard.

In 1890 the Regiment participated in the operations against the Sioux Indians at Long Pine, Nebraska. While there, Col. W. F. Cody (Buffalo Bill), Aide-de-Camp on Governor Thayer's staff, was dispatched to the Pine Ridge Agency to learn and report the location of hostile Indians and the main points of danger to Nebraska citizens. A consultation was arranged between General Miles and the Indians. The chiefs expressed great confidence in General Miles and a peaceful settlement was made which ended the Sioux Indian War.

At the call of the President, April 26, 1898, the Regiment was mobilized. On June 14 the Regiment embarked for the Philippines and arrived in Manila Bay on July 17, 1898. Upon landing, it was immediately assigned to the defenses of the city of Manila. The Regiment repulsed a small attack on July 26, having one man killed and several wounded. Other engagements followed and the Regiment, commanded by Col. John Stotsenberg, was part of the American forces that drove the rebels from Quinua. General Hale who was an eye-witness to the action, said, "There goes the First Nebraska, and all hell can't stop them." The trenches were captured and the enemy routed, but Col. John Stotsenberg was dead from a bullet through his breast. Fort Stotsenberg, P. I., is named in honor of Colonel Stotsenberg of the First Nebraska Volunteers.

The Regiment returned to the States and were mustered out on August 23, 1899.

April 1, 1913, the First and Second Infantry Regiments were consolidated and reorganized into the Fourth and Fifth Nebraska Infantry Regiments. On June 19, 1916, the Regiment was called out for service on the Mexican Border, serving at Llano Grande, Texas, until the spring of 1917. The Regiment was again called out for service on July 15, 1917, mobilized at Camp Cody, Deming, New Mexico, where it was redesignated as the 134th Infantry, Thirty-fourth Division. The Regiment embarked for France October 13, 1918, and arrived in France October 28, 1918. The personnel was used as replacements, and nearly all saw action at the front. Previous to reorganiza-

tion as 134th Infantry in 1921, units participated in field training, tornado service in Omaha, 1913, Border service and World War service with units to which they belonged.

In 1920 the Regiment reorganized as separate companies of the First Nebraska Infantry, National Guard. On June 22, 1921, the Regiment again was designated the 134th Infantry, Sixty-ninth Brigade, Thirty-fifth Division. Headquarters companies and auxiliary units were formed to complete the regimental organization on the above date.

Since reorganization as 134th Infantry, 1921, the Regiment has participated as a unit in field training as follows:

The shield is argent (white) and azure (blue), the old and the present colors of Infantry. The Katipunan sun

represents the Philippine Insurrection, and the palm tree the Spanish-American War service. The olla is made gold to comply with heraldic rules, and denotes the World War service of the organization in the Thirty-fourth Division. The snake symbolizes the Mexican Border service.

The original officers of the Omaha unit were First Lieut. Guy T. Davis and Second Lieut. Judd W. Crocker. When Lieutenant Crocker was promoted to First Lieutenant and assigned to Company "K," the vacancy in the Company's officer personnel was filled by Second Lieut. John T. Trout. First Lieutenant Davis resigned in 1934 and was succeeded by Lieutenant Trout. In January, 1936, Lieutenant Trout resigned and Alford C. Boatsman was transferred from Company "C," Beatrice, Nebraska, to Omaha and given command of the Company. In June, 1937, the present officers, First Lieut. James A. Bradley and Second Lieut. Thurston J. Palmer, both of whom had seen service with the Regimental Headquarters Company, 134th Infantry, were selected.

Headquarters Company was mobilized for riot duty the first time in June, 1935, and served during the Omaha street-car strike. The Omaha companies were the first on the scene, so it was necessary for this Company to take a leading part in keeping order the first night. The officers and enlisted men performed like veterans.

The Company is proud of the fact that one of its members, Philip J. Horan, Jr., received an appointment to the United States Military Academy at West Point. His advancement will be watched with interest by his former fellow-soldiers.

On January 28, 1922, it was called out to assist in maintaining order during the strike in the meat-packing industry at Nebraska City. On June 15, 1935, it was again called out to maintain order during a strike, this time the street-car strike at Omaha, jocularly referred to by the men of the Company as "The Battle of Who Run." On both of these occasions Company "I," along with other units of the Nebraska Guard called into service, conducted itself with such polished efficiency, competence and understanding that rioting promptly ceased, and order was maintained without bloodshed and without provoking the ire of either faction in the disturbances.

The history of Company "I" does not extend as far into the past as does that of some companies of the regiment, for during the Civil War, which saw Nebraska troops from older cities winning perpetual renown on the field of honor, Lincoln was not yet a settlement; and during the 70's and 80's when Nebraska troops saw active service

against hostile Indian uprisings, Lincoln was only a frontier village sprawling on the open prairie, whose entire population was scarcely larger than a war-strength company of infantry. So those of adventurous spirit from this settlement who wished to do their bit for state and nation, trekked across the plains to Omaha, Nebraska City, Wahoo, or some other city large enough to send a separate contingent of troops, there to enlist for whatever service lay in store for them.

But on May 9, 1898, when the First Nebraska Regiment was mustered into Federal service under the command of Colonel Stotsenburg, Company "L" of that regiment was composed of Lincoln men, and throughout the course of the Spanish-American War, which rang down the curtain on the United States as an infant nation and ushered it into its present position as a world power, Company "L" of the First Nebraska Regiment contributed liberally to the record of heroism made by the regiment in its campaigns against seasoned Spanish regular troops in the Philippine Islands. After the fall of the enemy's defenses, the company saw continued service through the Philippine Insurrection, in warfare that for stark savagery has not been exceeded in the annals of modern history. Many of its number made the supreme sacrifice for their country, and the company returned to its station with a seriousness and a devotion to duty that has not diminished since.

Soon after the war, in the reorganizational shakeup that followed, Company "L" of the First became Company "A" of the Fifth Nebraska Regiment. There followed days and years when the War Department paid scant attention to its National Guard troops, when pay for National Guardsmen was practically unknown, when uniforms and equipment were nondescript and almost unserviceable, and when the annual period of active training consisted, in the main, of walking some place, and walking back. This period ended in 1916 when the Nebraska National Guard was mustered into Federal service for duty on the Mexican boundary to protect and defend our southern border against the raids and fiascos of the colorful but treacherous and bloodthirsty Pancho Villa. Company "I," Fifth Infantry, formerly Company "A," became as weary of the desert as were the other troops on the same tour of duty, but as a result of this training the World War found it a company of thoroughly trained and seasoned troops, fit and ready for active wartime service. The Fifth Nebraska Regiment became the 134th United States Infantry, its present designation, and saw service with the Thirty-fourth (Sandstorm) Division on the Western Front. Again many casualties left on the field on honor enriched the Lincoln company's history, and increased mightily its store of the tradition of heroism.

Since the war, Company "I," 134th Infantry, has made unceasing progress. Its first active training, after being mustered out of Federal service, was at Camp Dodge, Iowa, in 1921. In 1922 it trained at Camp Berry, Plattsmouth, Nebraska. Following that encampment, it went to Camp Ashland, Nebraska, for its active training every summer until 1937, when as a part of the Thirty-fifth Division it participated in the Fourth Army maneuvers at Fort Riley, Kansas. In 1938 it again went to Camp Ashland. It is

now commanded by Capt. Rolla C. Van Kirk, who received his baptism of fire with the Fifth Marines at Belleau Woods in France. First Lieut. Clarence J. Stewart and Second Lieut. Foster Weyand, another World War veteran, comprise the remaining commissioned personnel. Frank Conner, the hardest boiled but best liked "top-kick" in the U. S. Army, a veteran of the Mexican Border service and of the World War, is First Sergeant.

Recognizing that perfection is never achieved but only striven for, Company "I" is never content to rest on its laurels. The entire company constantly cooperates to make its best mark of last year its poorest of this. It is proud of being a crack company of a crack regiment, and will, in memory of those who, while on its roster, gave up their lives in true soldier fashion, do its full part to keep the Regiment one of Uncle Sam's choicest.

On June 1, 1924, the four above sections were consolidated into Service Company, 110th Medical Regiment, under the command of Captain Brooks. Captain Ball was assigned as Regimental Adjutant.

When Captain Brooks was promoted to Major, he was succeeded in command by Earl N. Deppen, Captain, M. C.

On April 1, 1926, Captain Ball assumed command of the Company, and has continued in that assignment to the present time.

The enlisted Detachment of the Division Surgeon's Office, which had been organized in January, 1927, became a part of the Company September 1, 1931.

The Band Section at Crete was mustered out of service on June 16, 1933. The present Band Section, which is directed by Warrant Officer Lyle A. Welch, was Federally recognized June 23, 1933.

The Medical Laboratory Section was eliminated by new tables of organization on March 1, 1934.

The Service Company furnished nine trucks and a detachment of eighteen enlisted men during the Republican River disaster June 1-6, 1935.

During the emergency declared because of the street-railway strike in Omaha June 15-21, 1935, nine trucks and eighteen men from the Company participated.

Captain Anderson, the Company had two successful years. He was succeeded in turn by Lenor White, Arthur Nasland, George Galloway and Earl Boydston.

In 1911 command of the unit was taken over by E. J. O'Shea, a Spanish-American War veteran, who continued in command until 1913 when he was succeeded by Ed Strickland. This unit was mustered out of service in 1914 with the designation of Company "M," Fifth Nebraska.

Holdrege was without a Guard company at the entrance of the United States into the World War.

The 137th Motor Transport Company was organized by First Lieut. Gold Sonneborn on December 29, 1922. A second unit organized shortly after as the 119th Motor Repair Section was transferred from Holdrege to Fremont. The 137th Motor Transport Company was commanded successively by H. H. Ellis, D. C. Leffler, and Edward Gillette. In 1936 the Company was redesignated Company "A," 110th Quartermaster Regiment, and now has twelve modern cargo trucks.

The Company has been called out three times since 1922. On August 28, 1934, it guarded the Army's stratosphere balloon "Explorer I," which landed near Loomis, Nebraska. The following spring the unit spent four days along the Republican River during the 1935 flood, and almost immediately afterwards the Company was on duty for eight days at the Omaha street-car strike.

Many of its members are graduates of Holdrege High School.

1935, it was called into the service of the State to quell a riot disturbance at Omaha during the street-car strike of that year.

The unit was redesignated Company "E," Light Main-

tenance Company, Third Battalion, 110th Quartermaster Regiment, on April 4, 1936. First Lieutenant Yakish was promoted to Captain and Norris E. Walther was commissioned Second Lieutenant July 7, 1936. Upon the resignation of Captain Yakish in February, 1938, Second Lieut. Vaughn Petersen was transferred from Company "B," 110th Quartermaster Regiment, and given command of Company "E."

Captain Petersen served with the First, Fifth and Thirteenth Engineers of the Regular Army, and enlisted in the 138th Motor Transport Company, Thirty-fifth Division Train, May 22, 1923, in Fremont. He was commissioned Second Lieutenant in June, 1929. He served with Company "B," 110th Quartermaster Regiment, until March, 1938, when he was transferred to the command of Company "E," 110th Regiment. He was promoted to Captain in July of 1938.

Company "E" handled all the repairs to motor transportation of the entire division at the 1937 maneuvers at Fort Riley, Kansas.

Company "E" was requested to act as guards for the President of the United States on the President's visit to Fremont, Nebraska, September 29, 1935. This organization transported troops from Omaha to Fremont, to assist in guarding the President, also there were other organizations from Lincoln, Nebraska, who came in their own transportation, to help in guarding the President. In the evening it transported the Omaha troops back to Omaha.
