




HENRY MASTON MULLINNIX

Rear Admiral, United States Navy. Graduated from the Naval Academy June 1916. He was assigned to destroyers, with which he served at Queenstown, Ireland, and in the North Atlantic during World War I. In 1923, he was designated a Naval Aviator and served with the Aviation Branch of the Navy afloat and ashore throughout the remainder of his career. During the years intervening between the two world wars, he served on the U.S.S. Saratoga, as Commander of a bombing squadron, and had tours of duty at Pensacola, Washington, and in the Hawaiian Islands. He was promoted through the various ranks of the Navy and in 1941 was a Captain, U.S.N., serving as Commander Patrol Wing Seven operating on the neutrality patrol in the North Atlantic. When detached from Command of Patrol Wing Seven, he served for several months in the headquarters of the Commander, Eastern Sea Frontier, in New York. He was promoted to Rear Admiral and assigned to command a division of four escort carriers, and was so serving when his flagship was struck by a torpedo and destroyed on November 24, 1943, at which time he, along with a large number of officers and men, was lost. He was awarded the following medals for service: Purple Heart Medal, Victory Medal, World War I, American Defense Medal, American Area Campaign Medal, Pacific Area Campaign Medal, World War II Victory Medal, Legion of Merit Medal.

2nd Lt., 0715788. Entered the service January 28, 1943. Fort Benjamin Harrison, Indianapolis, Indiana, as an Air Cadet. Received wings and commission, March 12, 1944. Sent overseas July, 1944 to England. Killed in mid-air collision over Belgium while on 4th mission to Germany on September 21, 1944. Served as co-pilot on B-24 Liberator Bomber.

2nd Lt., entered Army Air Corps, August, 1942, received his basic training at San Antonio, Texas then went to Ellington Field, Texas for Bombardier training. He graduated from San Angelo, Texas in April, 1943, receiving his wings and commission. He then went to Avon Park, Florida where he trained in B-26 Martin Marauders until September, 1943 when he went overseas and landed in England, he was transferred to Ireland then back to England where he was with the 303rd Bomb Group, 360th Bomb Squadron. He had completed seven successful missions and was on his eighth when his plane was badly shot up over the target, in trying to return to England with crippled plane, they crashed in the English Channel. No further particulars were ever received. He has one daughter Lynda Christine, born October 3, 1944, whom he had never seen. He was the son of Mr. and Mrs. Glen Walter of Attica, Indiana.

EDWARD T. COOPER



35143892, Co A 474th Infantry Regiment. Inducted May 19, 1943. Qualification-Combat Infantryman Badge, Battles and Campaigns-Naples-Foggia, Rome-Arno, Southern France, Rhineland, Central Europe. Overseas 24th of November, 1943 to October 25, 1945. Discharged October 30, 1945.



DONALD L. SHUPPERT

Enlisted in Co. F, 151st Infantry National Guard, January 9, 1941. Served with Co. F until August 6, 1942. Went on maneuvers in fall of 1941 in Louisiana. Went to Officers' School at Ft. Benning, Georgia, August 6, 1942. Graduated as 2nd Lt., October 31, 1942. Served rest of enlistment with Service Co., 391st Inf., 98th Div. Was Bn. S-4 for 2nd Bn. Promoted to 1st Lt. June 15, 1943. Went on maneuvers in Tennessee and went to Camp Rucker, Alabama, November 12, 1943. Left Camp Rucker for overseas service March 15, 1944. Left Ft. Lawton, Washington, staging area on April 21, 1944. Arrived at Honolulu, Hawaii, April 27, 1944. 151st Infantry was assigned defense of Maui Island. Left Oahu, Hawaii, September 6 for Japan. Landed in Japan September 27, 1945. Was released on points the 23 of December, 1945 and arrived in Los Angeles, California, January 3, 1946. Attained rank of Captain and was discharged on April 4, 1946 after 5 years and 3 months service.



L. E. CLEMENTS

Ensign, entered service in the Navy on December 27, 1944. Served at the Naval Research Laboratory in Washington, D. C., in the Radar Department. Discharged September 29, 1945.



ROBERT H. HERSHBERGER

Separated from service March 14, 1946.

Enlisted July, 1917. Discharged January, 1925. Was in Co. A, 37th Infantry, Co. F, 11th Infantry, 5th Infantry Division.

Enlisted October 16, 1942. Discharged September 9, 1943. Basic Training at Daytona Beach. Motor Corps, Camp Polk, Louisiana and Camp Stewart, Georgia. Promoted to T/5, June 1, 1943.

Master Sergeant, inducted in U.S. Army from Beaumont, Texas, March 4, 1942. Stationed 6 months at Camp Crowder, Missouri, training for Radio Work in the Signal Corp. Went overseas September 21, 1942, landing in Cairo, Egypt. Was in the European Area, Africa, Italy, France, England and Germany. Returned September, 1945. Was discharged from Indianapolis, Indiana; re-enlisted for 3 years consequently receiving 3 months furlough. Was instructor in Radio School, in New Orleans, Louisiana until December, 1946 at which time he was assigned a permanent post as Chief Radio Operator at Warrentown, Virginia.



REX ARNETT KIRKMAN

PHM 3/c United States Naval Reserve. Inducted December 28, 1943, at Indianapolis, Indiana. Training at Great Lakes, Illinois. Received Victory Medal, American Area Ribbon, and Asiatic Pacific Ribbon. Discharged at Great Lakes, Illinois, May 4, 1946.



DONALD EUGENE BUTLER

Motor Machinist's Mate 3/c. Entered service May 21, 1945. Served Naval Training Center, Sampson, New York; USS YDG-10. Discharged at Camp Wallace, Texas, July 24, 1946.

Injured in Holland then again in Bastogne, Belgium. Was Discharged August, 1945. In 1946, re-enlisted in same outfit, which had been changed to 82nd Airborne. 
CLARENCE A. GUSTUS


HAROLD M. BUCKLEY




CHARLES HURYCH, Jr.


OLLIE D. CRANE
