



The Board of Governors meets at least once each quarter to consider ways and means by which the Association might seek to further the objectives of the U S Army Reserve and to conduct such other business that might come before the Board.



BOARD OF GOVERNORS - Activities Report

In June 1978, LTC Stanley T. Hoversten was elected President of the Board of Governors for the year 1978-1979. Regular meetings of your Board have been held under his capable leadership. Many former members of the Board and members of the Association at-large, have attended such meetings.

Key items on the Agendas have been objective discussions of ways and means by which the Board and Association might further the goals of the Army Reserve Program.

Transfer of the Los Alamitos Naval Air Station to the California National Guard was accomplished in 1977. Concern of the Board centered about the subsequent operation and maintenance of the Los Alamitos Armed Forces Reserve Center and other installations in Southern California. Increased budget costs under new management of several reserve facilities were carefully considered.

The Board deliberated on ways and means by which there might be made available to the news media accurate and timely information concerning the status of the USAR and other reserve components. To this end and, acting upon recommendation of the Board, President Hoversten appointed a new Political Action Committee to analyze and evaluate the current issues by whatever means are appropriate that may come before the Board of Governors, and to prepare factual information and, where advisable, draft proposed comments and/or communications for use by the membership and others in contacting appropriate legislators at all levels in expressing concern and need for a strong national defense posture.

A special committee, under the chairmanship of BG Robert D. Upp, drafted a proposed revised Constitution and By-Laws of the Association. The Board subsequently approved the document to be submitted to the membership for approval and adoption.

In keeping with the current policy, former members of the Board of Governors have a standing invitation to participate in the regular meetings of the Board. Other Association members are invited to attend such meetings. It is to be noted that during the year many such individuals have attended and contributed to the meetings of the Board.


The Board of Governors appreciates the support of Association members and their continued interest and attendance at the annual dinner meetings, and the growing number of Life Members.

CONSTITUTION AND BY-LAWS of the 63D INFANTRY DIVISION ASSOCIATION (USAR)

Revised 12 May 1979

Constitution

ARTICLE I. NAME. The name of this organization shall be 63D INFANTRY DIVISION ASSOCIATION (USAR).

ARTICLE II. PURPOSE. The purpose of this association shall be to perpetuate the history and honor of the 63d Infantry Division (USAR) and to promote and enhance the national security of the United States of America through a strong military program.

ARTICLE III. MEMBERSHIP. The membership of the association shall consist of those individuals who have been or are presently or shall hereafter become members of the 63d Infantry Division (USAR).

ARTICLE IV. GOVERNING BOARD. The governing board of the association shall consist of members of the association. It shall consist of twelve members and they shall be known as the Board of Governors.

ARTICLE V. ELECTION OF MEMBERS OF THE BOARD OF GOVERNORS. The Board of Governors shall be elected for a term of two (2) years by the association members with a majority of those present and acting at the annual meeting, with six (6) members elected each year.

ARTICLE VI. MEMBER EMERITUS OF BOARD OF GOVERNORS. A member of the association who has served as a member of the Board of Governors for three consecutive two-year terms, shall become a Member Emeritus of the Board of Governors without voting privilege upon completion of his final or qualifying term of office.

ARTICLE VII. ASSOCIATION FUNDS. Funds may be accumulated through periodic assessment of members of this association and by such other means as may be approved by the Board of Governors.

ARTICLE VIII. CONSTITUTIONAL AMENDMENT. This constitution may be amended by secret written ballot submitted to all members by a majority of the membership voting.

ARTICLE IX. EFFECTIVE DATE OF CONSTITUTION. This constitution shall become effective upon approval of the Board of Governors and ratification by a majority of the membership voting.

BY-LAWS OF BOARD OF GOVERNORS

BY-LAW I. OFFICERS AND COMMITTEES.

SECTION 1. The members of the Board of Governors shall, at a regularly scheduled meeting, elect one of their number to serve as President of the Board, and one member of the Association to serve as Secretary-Treasurer who would not have voting privileges unless he is an elected board member. The term of office shall be one year.

SECTION 2. The President if present, shall conduct and preside at all meetings of the Board and over any meeting of the Association that may be held.

- SECTION 3. If for any reason the President of the Board is unable to attend a regularly scheduled meeting, the Board members present at such meeting shall designate one of the members present to preside over such meeting as President pro Tempore.
- SECTION 4. The President shall appoint from time to time members of the Board of the Association to such committees as he shall deem necessary to conduct the business of the association.
- SECTION 5. The President shall appoint a Standing Chairman of the Arrangements Committee who shall be an ex-officio member of the Board who shall have voting privileges during the term of his appointment.
- SECTION 6. The management of the funds shall be entrusted to the Secretary-Treasurer. He shall be charged with the duty of accumulation, holding, managing and disbursing any and all funds entrusted to his care and he shall maintain accurate records of all transactions involving the funds entrusted to his care. The Secretary-Treasurer shall inform the Board of Governors of matters in need of the Board's attention, schedule meetings of the Association and the Board of Governors, prepare notices, agenda, and minutes of such meetings.
- SECTION 7. Contracts and other documents shall be signed by the President and the Secretary-Treasurer, or such individuals as may be authorized by the Board.

BY-LAW II. MEETINGS OF THE BOARD OF GOVERNORS.

- SECTION 1. Meetings of the Board of Governors shall be held at the call of the President, but not less frequently than four times each calendar year.
- SECTION 2. The Secretary-Treasurer shall give at least seven days notice to each and every member of the Board of the fact that a meeting of the Board is called by the President. Such notice shall state the date, time and place of such meeting.
- SECTION 3. Three members of the Board currently serving in office, excluding Member Emeritus of the Board, shall constitute a quorum for the conduct of any business of the Board.
- SECTION 4. The Secretary-Treasurer shall at each meeting render a report as to the financial condition of the Association unless such report shall be dispensed with by motion of the Board.

BY-LAW III. AMENDMENT OF BY-LAWS.

SECTION 1. These by-laws may be amended at any meeting of the Board by affirmative vote of two-thirds of the members of the Board serving in office voting, after having been served a reasonable notice in advance of such meeting.
