

# President's Message



I had one of my usual sincere messages for publication all roughed out and received my Army Times of April 1, 1985. The lead paragraph deserves a rerun and states as follows: "An important trend has developed in American military policy that has attracted little attention outside the military community: increasingly the Reserve Components are being asked to play a greater role in defending the nation, and they are being given more weapons and equipment to do the job. The question, as posed by senior Pentagon officials in recent Capitol Hill testimony, is how far this can go." A new development. . .I thought that was what the Reserve training program was all about.

Looking back, I am sure that our members would agree that the 63d Infantry Division, USAR, in the early 60's would have accomplished any reasonable mission tasked because we were trained to do just that. There were many times that I thought the telegrams might be sent, just like the one I received in 1950 at the outbreak of the Korean conflict, but with all of the years with the 63d and units of various types and sizes years later, no telegram. What a waste. Countless millions go into these special training programs, more equipment, better opportunity through the many service educational programs in attaining a professional degree, and so on. The soldier is there for as along as 20 years or more, and no recall or telegram. Maybe that's good. No one likes a war. But, the better trained soldier is going to be a better trainer and combat soldier as well as becoming a direct reflection on experience and ingenuity that keeps the casualty lists down.

The editorial goes on to say "In the Vietnam War, for political reasons, the Reserves were not called up, but some Reserve and Guard units did serve in the war zone. More recently, Reservists served in Grenada." They continue with information on an increased reliance on the Reserves because they are less expensive than their counterparts on active duty.

Some facts are that Reserve Officers and NCOs are doubly talented and perhaps more valuable than those counterparts. They have multi-skills in both military and civilian specialties and can be utilized in whatever position the commander needs based on those skills. It's like getting a new trooper with a dozen MOSs.

Our Reserve forces are more crucial today than ever before. We need a strong and well trained reserve and it must be paramount in this and all other military oriented organizations if we are going to keep a proper professional military posture in order to keep the peace. We need to get at it and actively support the Reserve forces in any way we possibly can.

### Political Action Committee Annual Report

Reviewing the past six years of existence of the Political Action Committee, the Defense Posture and Security of the Nation has improved to a great extent. The very reasons for formation of the committee, i.e., cancellation of development of new weapons systems, abnormally high turn-over rate of trained personnel in our military, inadequately equipped units and troops, recommended cuts in ancillary benefits such as Post Exchange and Commissary operations, failure to establish comparability between military and civilian sector pay, and many other items adverse to the morale and physical capability of our military to accomplish it's mission have been somewhat alleviated.

However, much remains to be done, and the voices of the members of this organization as well as those of others with like purposes, must be heard where it counts:

TAX EXEMPT STATUS OF MILITARY HOUSING ALLOWANCE. In their proposals for tax reform measures, both the IRS and Department of Treasury include the tax exempt status of military housing allowance in the category of "in need of reform." The impact on morale of our active and reserve forces is obvious.

RETIRED MILITARY PAY. This organization agrees totally with the statements made by Army Chief of Staff General John A. Wickam, Jr., that drastic changes in the Retired Military Pay System would be catastrophic to the recruitment and retention of a high level professional military force. Further, we regard the utterances of Mr. Stockman before a Congressional Committee as utterly absurd.

COMPARABILITY OF MILITARY PAY. Four years have passed since the military has enjoyed pay comparability with the civilian sector. Reestablishment and maintenance of a level of compensation and incentives comparable to and competitive with the civilian sector is a must if the military is to maintain the force balance necessary to achieve its mission.

FAMILY HOUSING. Inadequate on-post housing and exhorbitant costs of off-post housing create horrendous problems for military personnel, particularly to the lower officer and enlisted grades. The Department of Defense and the Congress must be urged to provide a Variable Housing Allowance program to compensate for actual housing costs in a high cost area, world-wide.

TRANSPORTATION COSTS. Permanent change of station transportation costs, including movement of families, should not cause any soldier to go into debt. All reasonable costs as a result of change of station should be reimburseable.

AB 2266. Assemblyman Dennis Brown, Fifty-eighth Assembly District (Long Beach) has twice introduced bills providing for increased state income tax exemption of military and retired military pay. In both instances, 1983 and 1984 Legislative Sessions, his bills have failed to clear committee hearings. This organization will support Assembly Brown's efforts this year, urging him to present a modified bill.

The items we as an organization are currently most interested in are those matters affecting the Quality of Life of our active and retired military personnel. We promise vigorous pursuit to insure we have done our best to see them become a reality.

It is proposed that a change to the By-Laws be made to include the following article regarding Member Emeritus status in our Association:


ARTICLE VI. MEMBER EMERITUS OF BOARD OF GOVERNORS







# Commander 63d ARCOM

# MG Daniel C. Helix CPL Thomas A. Pope Medal of Honor, WW I



Major General Daniel C. Helix began his military career as an honor-man in the 4th Division, proved himself to be a troop leader early on and cintinues to be one of our outstanding USAR commanders today.

He is a native of Wisconsin, a resident of the City of Concord at the present time and is Commander of the 63d Army Reserve Command with their Headquarters located at Los Alamitos AFRC, California.

He served in combat in Korea where he was awarded the Combat Infantryman's Badge, the Silver Star, Bronze Star with V Device, Army Commendation Medal, Purple Heart with 1 Oak Leaf Cluster, the Parachutists Qualification Badge and many other service medals.

He was Mayor of Concord, California from 1972 to 1974 as well as having served on the Planning Commission and City Council. He was director of the Bay Area Rapid Transit District, President of the Contra Costa Waste Management Commission and chaired their open space commission.

When he is a civilian, and that isn't too often these days, he is President of Helix and Associates, Incorporated, a land development and real estate investment corporation in Concord.

In addition to his many command assignments, he served as Deputy Director of Operations, Readiness and Mobilization, in the office of the Deputy Chief of Staff, Operations, Department of the Army.

He presented an overview of the 63d ARCOM via video tape and supplemented the script with personal comments. He was presented a citation and made an Honorary Member of the 63d Infantry Division at our 1984 Annual Meeting.



On June 5, 1917, draft registration day for ten million young americans---Tom Pope left his Edison Park home on the outskirts of Chicago and put his civilian life behind him. He decided at that time to enlist, instead of wait to be drafted, and joined the 1st Illinois Infantry of the National Guard. He was sworn in that afternoon as a private in Company E and joined the unit awaiting its call into federal service.

He began to soldier and became part of Lieutenant Arthur N. Clissold's platoon where he remained for the rest of his time on active duty.

Early in 1918, the Germans unleashed a great offensive designed to create havoc among the British and French before the United States actually got their troops into the field. The 33d Division was reassembled under British command and began its share of the offensive sweep and attack. Lt Clissold gave his men their last minute instructions and to move out. They waited for their artillery support (161 guns he learned later) and the attack began. The infantry were driven back by concentrated machine gun fire and it was well emplaced.

Corporal Tom Pope ran out in advance of the rest of the platoon, across an open patch of ground, ducking and dodging as best toon, across an open patch of ground, ducking and dodging as best he could the effort of the enemy machine gun fire. The enemy swung the gun on him, but before they could pull off a burst he had charged into their midst. He waded into the Germans with his bayonet and wiped out the entire crew. A nearby enemy squad mounted a charge toward him but Pope, standing astride the mach-ine gun, leveled his rifle and calmly picked them off. More Germans surged toward him, but he coolly reloaded and fought them off. Finally, the rest of the attacking force caught up with him and his captured machine gun and the balance of the survivors were sent back as prisoners. In 1919, Corporal Thomas A. Pope received the Medal of Honor from General John J. Pershing in a ceremony at Chaumont, France. He later was recognized for his ceremony at Chaumont, France. He later was recognized for his valor by the British, French and Italian governments.

He was the first Army recipient of the Medal of Honor in World War I and was cited by and made an Honorary Member of the 63d Infantry Division Association, USAR at our 1984 Annual Meeting.


