48th Annual Reunion Meeting

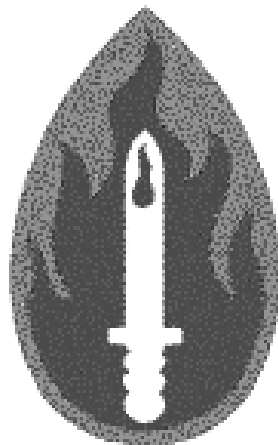

 - The US isn't Afghanistan. Or Haiti. DSCA has different rules for DoD.
- All Reserves can now be DSCA-sourced by Service Secretaries (and it ain't Immediate Response).
 - Army Reserve is DSCA-suited.
 - Army Reserves must be prepared to
 - Activate quickly in unit sets with equipment
 - Operate in CONUS, likely locally
- Understand the process; Federal and state EM agencies and partners, regional emergency response plans and regional DSCA issues, Mission Assignments and the DSCA paradigm.

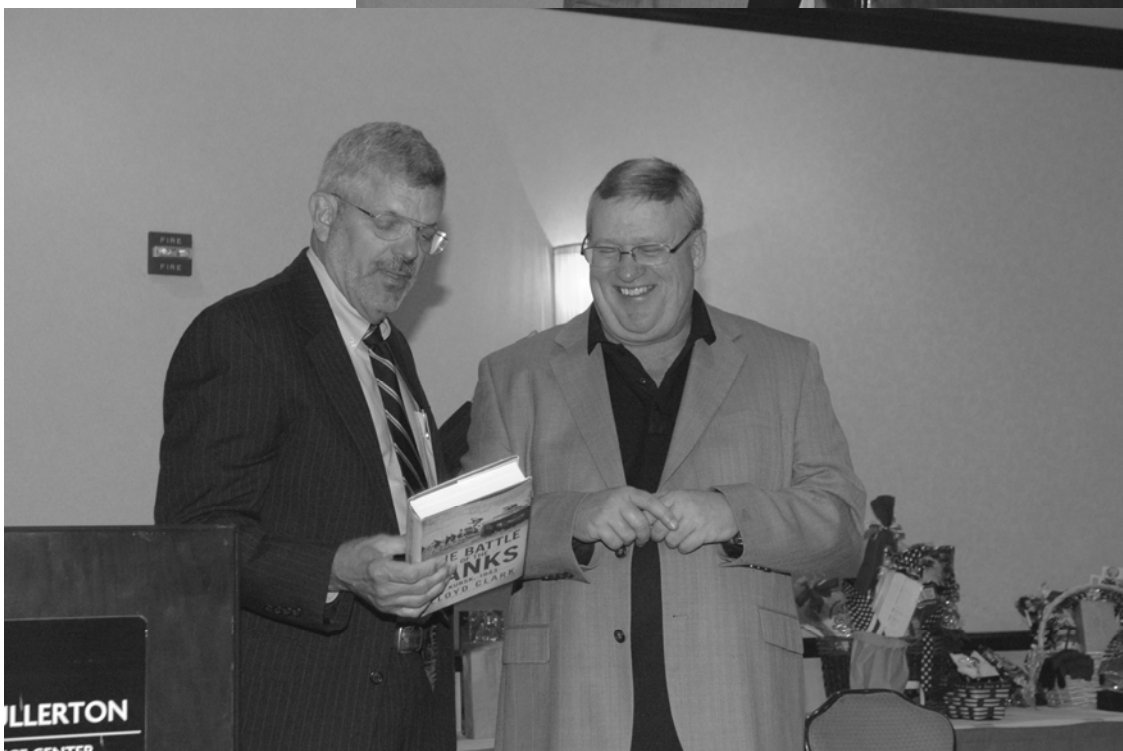
