He was a member of the 63<sup>rd</sup> Infantry Division USAR before going on to serve with the JAG Corps before retirement. BG Upp was a key leader in the evolution of ROA.

The second fallen comrade is Marc Pelesasa. Marc was the Senior Safety Officer for the 63<sup>rd</sup> RSC when I was the Chief of Staff and Deputy Commander from 2002 to 2009. Marc was a no nonsense guy who went the extra mile to insure that we did everything to keep our Soldiers safe, which often resulted in agitation in the command group. I have the utmost respect for both of BG Upp and Marc, what they did with their lives made a difference, which to me is the best that you can do. May they rest in peace.



# THE SHORT STORY OF MY LONG LIFE

Brigadier General Robert Dean Upp died on March 13, 2015 of cardiac arrest at home in Solana Beach, California. General Upp was born in Allerton, Illinois on February 6, 1916. He graduated from the University of Illinois in 1937 with a degree of B.A. in Journalism, and was commissioned a second lieutenant of infantry in the Army. Upon his completion of Senior ROTC at the University, he was ordered to Active Duty for Infantry training at Camp Custer, Michigan from 8 June to 20 August, 1937. At the end of that tour he became a member of the Reserve Officers' Association (ROA) for \$3 dues collected at the end of the pay line. He then applied for more active duty and was ordered to CMTC Camp at Jefferson Barracks, in Saint Louis, and was put in charge of a mule-drawn heavy machine gun platoon. His Sergeant warned him that the mule got mad if its crupper (leather flap under its tail) got dirty.

Unable to find work in Illinois, Bob hitchhiked to Portland, Oregon, then to Southern California and was hired by the W. T. Grant Store chain in 1938 to work in their Huntington Park, California, site. In January, 1939, Grants transferred him to Wichita Falls, Texas, then on to Waco. In July he married an Illini classmate, Margaret Thiel, '39 (Sue) in Chicago. They had two Children, Robert Rexford (Rex) and Dolores Dean (Dee). While in Waco, he joined the ROA Chapter there and made a publicized speech about the German/Russian conflict in WWI. As a result, he was invited to join the 36th Division (Texas National Guard) for 28 days Army duty on the famed Louisiana maneuvers. He was promoted to 1<sup>st</sup> LT and given command of an anti-tank platoon. They had no 37 mm. small cannons, so his weapon was a wooden fence post strapped between two bicycle wheels. The Group he was assigned to included three smart LTCs named Eisenhower, Bradley, and Patton. He was then released from that duty and transferred by Grant's to Port Arthur, Texas where he was promoted to Assistant Manager "and to increase your salary to \$25 per week." He later was offered a job with the Social Security Board and left Grants.

Two weeks later in June 1941, he was called to Active Duty with the army as a 1<sup>st</sup> LT. After graduating from an Infantry School course at Fort Benning, Georgia, he served as a Captain, Infantry Company Commander, first in charge of heading and instructing Several IRTC and BIRTC classes. Then with combat action, first in the Aleutian Islands, and then with the 65<sup>th</sup> Infantry Division as spearhead of General Patton's Third Army across France. Third Army was part of the 15<sup>th</sup> Corps under General Bradley, in the European army under General Eisenhower. General Upp was a front line soldier in France, Germany, and Austria until the end of the war in Europe. He had accumulated enough points so that he was in the first "Green Project", a plan to fly veterans home. This elite group flew in a converted B25 bomber from Nice, through Morocco, Senegal, Brazil, British Guiana, and Trinidad to Miami. After a short stay there, he commanded his 4<sup>th</sup> Troop Train of WWII, to Los Angeles and home. While there on a Rest and Recuperation leave, President Truman used the A-bomb and ended the war with Japan.

Captain Upp asked to be relieved from duty so that he could go back to school under the GI Bill. His request was granted and he enrolled at the University of Southern California where he received degrees of Juris Doctor in Law, an MS in Social Science and an MA in Education.

He passed the California Bar Exam in 1948 and began a law practice with a partner, Neil N. Werb. He thought that he was now ready to enjoy a peaceful life. However, in June 1951, he was involuntarily recalled to active duty as a Major for the Korean conflict. His wife, Sue, said that one war was all that she could handle and asked for a divorce. It was amicable. He gave her all of their property and moved her to San Diego where her parents and siblings lived. He wound up in Korea as a War Crimes investigator and Historian, drafting the white paper that went to Congress and the United Nations.

After Korea, he was again relieved from active duty, he resumed his practice of law, associated with his former partner. He also taught business law, civics, and American history as a Professor at Law at Angeles City College. While there, he co-authored a college text in Business Law, which was published by West Publishing Company, through five editions, over a period of thirty years.

Major Upp remained in the active Army Reserves, transferring from Infantry to The Judge Advocate General's Corp. He was the JAG of the 63<sup>rd</sup> Infantry Division, USAR, and promoted to Lt. Colonel. He was next assigned as the Deputy Commandant of the JAG School at the University of Virginia and promoted to Colonel. His last reserve assignment was as Special Assistant to the Army's Judge Advocate General, and promotion to Brigadier General, in which rank he retired in 1976.

He was active in Military Associations, particularly The Reserve Officers Association, of the U.S. He was the ROA California State President in 1960 and the National President in 1972-73. He was a lifetime member of the Veterans of Foreign Wars; the American Legion; the Military Officers Association of America; the Military Order of the World Wars; the Disabled American Veterans; the 65<sup>th</sup> Division Association; the 63<sup>rd</sup> Division, a continual member of the United State Army Association; and a long-time member of the British Officers' Mess of San Diego. He was also a life member of the University of Illinois Alumni Association; the University of Southern California Alumni Association; and Mensa.

He was awarded the Legion of Merit; the Bronze Star with "V" for combat and an oak leaf cluster; the Combat Infantry Badge; The Meritorious Service Medal; The Army Commendation Medal; the Korean Commendation Award; and twelve service medals.

General Upp was also a world traveler. He was a gold card member of the Century Travel Club, having visited 215 locations on their list. As a railroad buff, he had been across Russia on the Trans-Siberian RR; on the Blue Train in South Africa from Pretoria to Cape Town; he also went across Australia from Adelaide to Perth; the Indian Express from Calcutta to New Delhi; the trans-Andean from Peru to Bolivia; Chinese overnight from Beijing to Nanking; the French TGV trains; and many of the specials in Western Europe. During WWII he was the train commander of four different cross-country troop trains in the continental United States

General Upp married M. Jane A. McIntosh Dinneen Upp; on 26 December 1953. She predeceased him in 2008. From his prior marriage to Sue, he has a daughter, Dolores Dean Upp Boutin and son-in-law, Fred Boutin, of Tuolumne City and a son, Robert Rexford Upp and daughter in law, Linda Gianella Upp, of San Jose. He leaves four grandchildren: Becky McDill of Salinas; Anton Boutin of Pine Mountain; Ryan Upp of Pasadena; and Staci Binns of Campbell, in addition to four great-granddaughters.
