44th Annual Meeting

The 44th Annual Meeting of the 63rd Infantry Division Association (US Army Reserve) was held on 18 April 2010 at the Crowne Plaza Hotel in Fullerton, California. Approximately fifty-nine (59) members and guests attended. President LTC Beverley A. Houghton, AUS-ret, called the meeting to order at noon. The meeting began with singing of the National Anthem by Miss Diana I. Diaz, the daughter of COL and Mrs. Alfred M. Diaz, AUS (ret). Association life member Chaplain COL Donald L. Forden, AUS (ret), led us in the invocation. A delicious and abundant buffet lunch was served, featuring roast beef and chicken with all the trimmings.

LTC Bev Houghton introduced the special guests and the luncheon speakers, Major General Theodore W. Paulson, AUS (ret), a former Commanding General of the 63d Army Reserve Command (ARCOM) and LTC Thomas Christianson, Historian of the new 63d Regional Support Command (RSC) located at Moffett Field, California.

Tom Christianson, who retired from the active Army as a Lieutenant Colonel, spoke eloquently about the history of the 63d Infantry Division during World War II. MG Paulson made an equally eloquent presentation regarding the history of the 63d Infantry Division (USAR), the 63d Army Reserve Command (ARCOM), the 63d Regional Support Command (RSC), and the 63d Regional Readiness Command (RRC).

The third scheduled speaker, Major General Bruce A. Casella, USAR, was unable to attend due to airline flight delays. A few days before our Annual Meeting, MG Casella had been reassigned from his position as Commanding General of the 63d Regional Support Command, Moffett Field, CA, to the position of Commanding General of the Army and Air Force Exchange Service (AAFES), Dallas, Texas, an extremely prestigious joint assignment. Mr. Christianson covered the most significant elements of MG Casella's intended presentation regarding the organization and mission of the new 63d Regional Support Command located at Moffett Field, CA.

During the annual business meeting, a plaque was presented to Major General Jerry J. Josten, AUS (retired), for his contributions as publisher of this association's quarterly "The Blade" and its "Annual Report." As the owner of a printing business in Fullerton, for several years MG Josten has printed this association's publications at no cost for "The Blade" and at his cost for the "Annual Report."

The business meeting included the nomination and election of new Association Board of Governors members for the term 2010-2012. Those re-elected to the two-year terms are COL Lydia Collins, LTC James T. Wright, LTC Donald L. Wirth, CW4 Layland A. Carson, CSM Arnold Greenberg, and SGM Thomas Gorden, Jr. Also elected to the Board of Governors for one year was CPT Danny L. Staggs, as a replacement for the remaining term of MAJ Raymond H. Edgerly (who resigned for health reasons). At its next meeting on 26 August 2010, the Board of Governors will elect the President, Vice President, Secretary, Assistant Secretary, and Treasurer of the association for the year 2010-2011.

Later in the business meeting COL Michael A. Ewens, AUS (ret), moved that the association suspend publication of its "2010 Annual Report" and donate the money to the Family Support Program of the Los Angeles Chapter of the Association of the United States Army (AUSA). After a second and significant discussion, COL Alfred M. Diaz, AUS (ret), suggested a substitute motion that the association's "2010 Annual Report" be published as usual, and that the association's Board of Governors consider a contribution to the Family Support Program of the Los Angeles Chapter of AUSA. The substitute motion was seconded by MG Theodore W. Paulson, discussed, and adopted.

COL Mike Ewens and COL Lydia Collins conducted the raffle of the door prizes. The meeting concluded with a benediction given by Chaplain (COL) Donald L. Forden and adjournment by association President LTC Beverley A. Houghton.

Committee Reports

Membership: This past year, we gained eight new life members, and had two renewals. If you are not yet a life member, please consider becoming one. The cost is only fifty dollars, and the secretary would love to send a life membership card. Three Years membership \$25.00, we gained one new, three year member. Treasurer: The monetary position of the Association is stable based upon the generous donations made to the Association and the successful Annual meeting. When I assumed the responsibilities of the Treasurer on 20 Aug 09 there were \$6,197.46 in the Associations bank account. As of 30 April 2010, there is \$8,194.09 in our account. A known upcoming expense is the printing and publication of the Annual Report which in the past has been under written by MG Josten. The Board is working hard to control the cost of publishing the Report and maintaining a stable bank balance. The Board of Governors meets quarterly at their own expense, to carry out the business of the Association. A financial report is distributed and voted on at each Board Meeting.

Publications: We continue to publish *The Blade* on a quarterly basis. We try with the limited space available, to inform the membership of the passing of our members, of the activities of the board of governors, and to present information on critical issues, as well as news of general interest. All members are welcome to submit articles for publications as space permits.

The **Annual Report** summarizes the past year's activities as well as providing the membership with a current roster of the members, recent photos and "Whooze Nuze" update on our member's doings and other interesting information. We maintain a mailing list of all active members and honorary members (~250 individuals) and a U.S.Postal Service Bulk mail permit.

The format of this and future publications is changing due to MG Jerry Josten retiring from the printing business. His generosity over the 15 years of providing with minimal cost To the Association printing and editing support of the Blade and the Annual Report cannot be replaced. We are now going out to commercial printers and the funds to continue in the outstanding publishing format that MG Josten provided us are not available. Thank you MG Josten!

2009-2010 National Interest Report

Perhaps the most significant event of national interest was the adoption of the Affordable Care Act of 2010. Only those who believe in Santa Claus, the Easter Bunny, the Great Pumpkin, and a goose that lays golden eggs, would believe the numbers that cost justified the program as “budget neutral” over the first ten years. Even the Centers for Medicare and Medicaid Services (CMS), a component of the Department of Health and Human Services, issued a report in April 2010 stating that the provisions of the healthcare reform act will increase costs over the next ten years instead of reducing them. The Chief Actuary of CMS is responsible for providing accounting information and cost-projections to the Medicare Board of Trustees. And a statement of actuarial opinion by the Chief Actuary must be included in the Board’s annual reports on the status of the Medicare Trust Fund.

Part of the “budget neutral” cost justification for the Affordable Care Act of 2010 was a 21% reduction in reimbursements to Medicare, Medicaid, and TRICARE providers that was supposed to occur in 2010 under current law. Immediately after the adoption of the Affordable Care Act of 2010, legislation was introduced that would overturn the 21% reduction in reimbursements to medical providers and would even permit increases in future years.

What will be the effects of the Affordable Care Act of 2010 on TRICARE, TRICARE for Life, and veterans’ health care? It was claimed that there would be no effect. However, Rep. Ike Skelton (D-MO), Chairman of the House Armed Services Committee (HASC), who voted against the Affordable Care Act of 2010, immediately introduced legislation to clarify the issue. The clarification bill introduced by Rep. Skelton was adopted. At last report a similar bill clarifying the effect on veterans’ health benefits had been introduced.

In other news, Congress adopted and the President signed the FY 2010 Defense Authorization and Appropriation Acts, and a Supplemental Appropriation Act to fund the wars in Iraq and Afghanistan. The FY 2010 Defense Appropriation Act increased defense spending as compared with the FY 2009 act. But overall defense spending (the Appropriation Act plus the Supplemental Appropriation) decreased. And the President’s budget request for FY 2011 reduces again the Department of Defense budget. It appears predictable that the intent is to use decreases in defense spending as a bill payer to pay for other administration priorities.

Recently the President and Chairman of the Joint Chiefs of Staff recommended the repeal of the “Don’t Ask, Don’t Tell” law that bars openly homosexual individuals from serving in the US armed forces. It was assumed that a bill to repeal “Don’t Ask, Don’t Tell” would be acted upon only after a study by the Department of Defense, to determine the possible effects of repealing “Don’t Ask, Don’t Tell,” that was to be completed by 1 December 2010. But it now appears that a back door proposal is in the works in which Congress would authorize the President, Secretary of Defense, and Chairman of the Joint Chiefs of Staff to repeal the “Don’t Ask, Don’t Tell” policy without further action by Congress. It appears that the back door proposal will pass easily through the House of Representatives, but will encounter problems in the Senate, where more conservative Democrats may join Republican opposition.

As a result of the wars in Iraq and Afghanistan, it became clear that the force structures of the US Army and Marine Corps were inadequate. Congress increased the force structure authorizations. Unless defense budgets are increased, the increased personnel and equipment costs resulting from increased force structure, will decrease the money available for other procurement, maintenance, and operations, to include the development and procurement of modernized systems and equipment. Our nation's national security posture will be weakened. We must remain vigilant and encourage adequate spending for national security.

The civilians and top military brass who run the Pentagon are not our friends. As overall budgets for defense decrease, there will be future attempts to shift the cost of military health and retiree benefits to the beneficiaries. We must remain vigilant and support legislation such as that currently pending that will authorize only the Congress to approve increases in TRICARE enrollment fees, premiums, and deductibles.

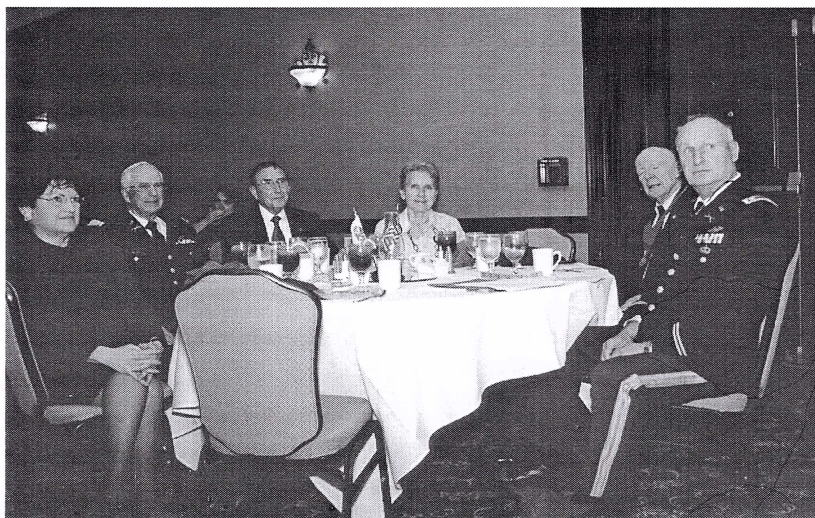
