

#### **ABOUT THE COVER**

At a meeting of the Board of Governors during the past year, CW4 George Murray offered a recommendation by which the Association would join other military organizations in placing a unit plaque at the Riverside National Cemetery. This commemorative plaque would honor all persons who have served under the colors of the 63rd Infantry Division. The Board unanimously approved the recommendation and directed CW4 Murray to proceed with the project.

The 63rd Infantry Division has a proud history. After activation at Camp Blanding, Florida, on 15 June 1943, and following intensive combat training, the Division was transferred to the European Theater of Operations. During the period 8 February -29 April 1945, the Division, assigned to VI Corps, Seventh Army, played a key role in the bitter, deadly combat of the time. The 63rd penetrated German defenses in Southern France and Germany, earning recognition in three major operations. Two members of the Division earned the Medal of Honor. Following the end of hostility in Europe, the 63rd Division was returned to the USA and deactivated on 27 September 1945.

On Washington's Birthday, 22 February 1952, the Division was reactivated as a unit of the Army Reserve. Divisional units were activated in Southern California on 1 March 1952. Quickly, the Division earned a prominent place as a member of the USAR in the "One Army Concept". The 63rd was again deactivated on 31 December 1965 during a total reorganization of the USAR. The proud colors were once again retired.

The bronze plaque shown on the cover will be dedicated on Armed Force Day, Saturday, 19 May 2001.


## Presidential Unit Citation

The following is a copy of The Presidential Unit Citation awarded of one World War II Battalions of the 63<sup>rd</sup> Infantry Division.

By virtue of the authority vested in me as President of the United States and as Commander in Chief of the Armed Forces of the United States, I have today awarded

#### THE PRESIDENTIAL UNIT CITATION (ARMY) FOR EXTRAORDINARY HEROISM TO THE 2nd BATTALION, 253rd INFANTRY REGIMENT

The 2nd Battalion, 253rd Infantry Regiment is cited for outstanding and gallant performance of duty against the enemy from 4 to 12 April 1945 in an area between the Jagst and Kocher Rivers northeast of Heilbronn, Germany. It was in this area that the enemy committed its best available troops in defensive positions along open ridges; giving them almost perfect observation and fields of fire. The battalion was at an additional disadvantage due to severe dispersion of supporting fire. Early dawn on 4 April, the 2nd Battalion crossed the Jagst River at Untergriesheim and quickly secured a bridgehead. The enemy employed a series of sharp counter attacks before the battalion could consolidate, using devastating firepower of tanks directed at individual fox holes and penetrated forward defensive positions. Inspired by the courageous leadership of their officers, these counter attacks were all beaten back. Assisted by the 1st Battalion, they then enlarged the bridgehead, but were still unable to establish a vehicular crossing over the Jagst River for two days due to intense and accurate artillery fire. Finally, on 5 April, a bridge was completed and some armored assistance was secured. On the evening of 5 April, three tanks were lost as the attack was continued. On 6 April, against extremely heavy opposition, troops of the 2nd Battalion captured the town of Buchhof. Two enemy counter attacks followed causing heavy casualties within the Battalion, but both attacks were beaten back. With only about 50 percent effective combat strength, the Battalion made ready to resume the attack on 8 April. The 2nd Battalion was to secure the high ground overlooking Stein Am Kocher. Again it met formidable resistance. but pressed the attack home with determination. Even after the tank support withdrew because of casualties and heavy fire, the 2nd Battalion fought its way forward. The cost in casualties was high but the tough core of SS resistance was broken. By this time the effective strength of all line companies was whittled down to about 50 men. Four Company Commanders had been killed or wounded, most companies had only a few Non-Commissioned Officers left and they had no company officers left. It took courage and determination of the highest order to continue the attacks, particularly after the leaders were gone and especially after the tank support withdrew. The 2nd Battalion was relieved on 10 April, but with very little time to rest and regroup; the battalion was ordered to attack to the south to cross the Kocher River. Though its ranks were thinned and its key personnel gone, the 2nd Battalion had the spirit, determination and punch left to continue the attack and make new gains, reaching and crossing the Kocher River to pursue the badly mauled 17th SS Division. Opposing the Battalion during these battles were two regiments of the 17th SS Division, the 17th SS Reconnaissance Battalion and the Battalion Bitche. Reinforcing these elements were young, fanatic Nazis, former members of the 12th SS Division and Hitler Youth. During this operation, the 2nd Battalion suffered 280 casualties: 54 killed in action; 211 wounded in action: and 16 missing in action. But the 2nd Battalion, with great determination and heroic achievement, ripped the fanatic 17th SS Division to shreds and caused it to withdraw from the fight, thus preventing the enemy from gaining time to prepare the Danube defenses in the National Redoubt area. The achievement of the 2nd Battalion, 253rd infantry Regiment, 63rd Infantry Division is a credit to all its officers and men and added a glorious page to the history of the American Infantry.

We also improved our affiliation with the World War II 63d Infantry Division Association. We are receiving copies of their publications and we send copies of our publications to five of their officers. We also access their website for additional data.

Many thanks to CW4 George Murray who recommended and designed the plaque shown on the cover. The plaque is dedicated to all 63d Infantry Division personnel from WWII and the USAR. The plaque will be dedicated at the Memorial Wall, Riverside National Cemetery on Armed Forces Day, 10:00am, 19 May 2001.

In closing, I want to thank all the members of the Board of Governors for their hard work and support. I especially thank all of you, the members, for your support and your generous contributions to our sustaining fund.

This will be my last term as President. I am going to take my doctor's advice and step down, but I will continue as board member emeritus. I will support the board as an advisor.

### **2000 ANNUAL MEETING NOTES**

The 34th Annual Meeting of the 63rd Infantry Division Association was held at the Embassy Suites Hotel in Arcadia on 16 April 2000. The Luncheon, served buffet style, was attended by 73 persons.

We received a briefing on the activities ,both state-side and in Bosnia , of the 311th Support Command from the Commander, Major General James Comstock. Colonel Michael Schweiger, Commander of the 1394th Direct Support Battalion 63rdRSC, representing the Commander of the 63rd Regional Support Command, Major General John Scott, gave a briefing on the activities of the 63rd both at home and overseas.

Our speaker and honored guest was Staff Sergeant Andrew A. Ramirez. Sergeant Ramirez, a decorated soldier, is a native of Southern California. He joined the U.S.Army in 1991. In January, 1998, he was assigned to Schweinfurt, Germany, as a Bradley gunner and later as a Bradley commander in the 1st Battalion, 4th Cavalry. From Germany, he was sent as a member of the United Nations Task Force Able Sentry to Macedonia. As an assistant observation post commander, Sergeant Ramirez helped to remove Serbian units from the UN observation posts.

No longer assigned to the United Nations operation, Sergeant Ramirez became the commander of a Humvee in a NATO Cavalry unit. During a routine patrol on 31 March 1999, along the border of Macedonia and Serbia, Sergeant Ramirez and two other soldiers were ambushed. They were taken by Serbian forces across the border into Serbia. The three soldiers were held as prisoners of war for 32 days. They were released through the negotiations of the Reverend Jesse Jackson. During his presentation, he related many of the circumstances of his capture and release.

At the time of his dramatic presentation, he was attached to the Fort Irwin, Public Affairs Office. He was the "Total Army Involvement in Recruiting" coordinator.

Following this presentation, the prestigious Eagle Award was presented to Major General William J. Hixon, a former Commander of the 63rd Infantry Division (Reserve). The Eagle Award was also presented to Major Raymond H. Edgerly, a former Adjutant of the 363rd Medical Battalion. He also serves as the Treasurer of the 63rd Infantry Division Association.









**BG Robert Upp** said that he served in combat infantry in both theaters of WWII and JAGC in the Korean conflict.

In April 1945, Patton's third Army crossed the Rhine River and was speeding across Central Germany. I was a captain, commanding K Company of the 259<sup>th</sup> Regiment of the 65<sup>th</sup> Infantry division. My equipment included 21 jeeps and trailers and one <sup>3</sup>/<sub>4</sub> ton truck.

Under Patton's orders we had mechanized ourselves. It was easy since we only had about 100 survivors from our original 200 men. We were the point of the Third Army in our sector. When we neared the Fulda River, Fulda was showing white flags and sheets everywhere. As I approached the city gate, a small group of civilians came out to meet us.

One stately woman told me that she was the Burgermeister's wife and that he was some where on the Eastern front. She handed me his long barreled Luger pistol and said that the city was ours. I said that our orders were to do no harm or damage if there was no resistance, but that we needed to take housing until advised of our next objective.

I selected a nice looking residence at the edge of town for my headquarters. I walked in the front door yelling "Auss mit der ganzen haus", probably incorrect but already proved effective in evacuating civilians from their homes.

An attractive, frightened young woman appeared, looked at me and asked me in

good English, "Are you going to rape me?" I laughed and replied, only if you ask me to. She then said that she had been told that the 65<sup>th</sup> Division soldiers were General Patton's SS troops and when we arrived we would rape and kill the women. I then told her that if an American soldier raped a German woman, we would hang him. She didn't believe me but left shaking her head in wonder.
