The Private Who Cracked The Siegfried Line

March 16, 1945 – just ten years ago – was a raw, overcast day on the German border. At 6 o'clock in the morning, the 254th Infantry Regiment of the 63rd Division (I was commanding M Company) trudged in ragged single file out of the town of Ensheim. Our destination, just 1,500 yards ahead, was the Siegfried Line - Germany's "impenetrable West Wall."

We didn't know it, but we were about to conquer the world's most fearsome fortification through the amazing ingenuity of a

nameless private!

Into the Siegfried Line, extending along the frontiers of Holland, Belgium, Luxemburg and France to the Swiss border, Hitler had poured 6 million tons of concrete and 3 million rolls of barbed wire. It had taken 532,000 men, working in relays day and night, to build reinforced-concrete bunkers, pillboxes and tank traps. The Fuhrer believed in it - completely.

Now we were spearheading an American drive to crack the southern sector of the Line and overrun the Saar, Germany's industrial

heartland.

To the north, the First Army had already crossed the Rhine; Patton's tanks were slashing across the plains of Germany toward Bavaria. But all this meant nothing to us. Our war was here. We had a tough part of the Line to crack, and it was still as sound and strong as the day the war started. (The Pentagon vouches for the fact that the author's regiment was the first of the Seventh Army to reach the Siegfried Line — Ed.)

Our plan was simple. Under cover of night we hoped to slip through the Line by way of a wooded draw and hit from the rear. But it didn't work out that way. For as the gray dawn broke, we found ourselves strung out over a long hill, staring the enemy in the

face!

With knots in our stomachs - there wasn't a man who wouldn't admit he was scared - we drew closer. Up and down the line you could hear whispers, "Looks like a trap." There wasn't a sound.

Then to our amazement, one enemy soldier arose from his trench, threw a blanket from his shoulders and leisurely stretched in the brisk, tense air. They hadn't seen us! But he soon did, and took off like Paul Revere.

It was obvious now that we wouldn't "slip through." Thirty minutes later it seemed that the whole German First Army had awaken-

ed. It was raining artillery shells!

Shortly we were within "throwing distance" of their pillboxes. Some of them, we learned later, could have qualified as small hotels. Two or three stories deep, several even had cooking facilities and sleeping quarters for troops. Built mostly underground, they had grass and brush growing on top – excellently camouflaged. Some even were covered by houses and trees. All were connected by tunnels or trenches.

These emplacements were built in groups of six or seven to cover the draws and likely avenues of approach. Mutually supporting, each was protected by the machine-gun fire of two or three others. So the logical procedure of attacking one at a time wouldn't work; we had

to take them as a group.

The way to capture a pillbox - we had been trained - was to close up the enemy guns by continuous firing of machine guns and automatic rifles, then send one man forward with a "pole charge." (A pole charge consisted of 15 to 20 pounds of TNT tied on the end of a stick, hobo-fashion. By sticking the sharpened end in the ground, the TNT could be propped against the pillbox. It had worked in the Pacific, we were told.)

By 10:40 A.M. we had recouped from the artillery shelling, had three pillboxes closed up and a man was crawling forward with his

pole charge. He pulled the fuse and ran.

With ears still ringing, we peeked — and could hardly believe our eyes. The only damage was a chip, slightly larger than an apple! Bewildered, the explosives man wanted to try the pole charge again. And again he got just a chip.

So the battalion commander called for "bazookas" (2.38-inch rockets) which, according to the manual, would penetrate 12 inches

By Charles E. Ball, C.O. Company M, 254th Infantry Regiment of masonry. They, too, bounced off like bean shooters. It turned out that the walls and tops of these pillboxes were 4 to 12 feet thick!

On each side wall was a small opening – a foot square on the inside, fanning out to about 5' x 5' outside. Covering the small opening inside was a steel door four inches thick. Soon as we stopped firing, it would fly open and a machine gun would roll out to spray the area with about 600 bullets per minute. We could "close the door" with machine-gun fire any time we wanted, but it was afternoon now and our ammunition supply was dwindling.

Frustration reigned. Here we were at the Siegfried Line . . . in it . practically on top of it! But we were helpless. Tanks couldn't get within a mile, because of tank traps, dragon's teeth, anti-tank

guns and rough terrain.

As time rocked along — mid-afternoon — the situation grew a little amusing. "Where's the dragon?" called out a Texas Sergeant, who had gained quite a reputation for easing tension during deathly circumstances.

Siegfried, legendary hero, once killed a dragon on the east bank of the Saar River, thus winning the magic ring and the helmet of Tarnhelm, This made him invincible in battle. And that's where the Siegfried Line got its name.

During the lull, the Colonel was approached by a confident Corporal: "Sir, see that open vent pipe sticking out the top . . . how about me dropping a grenade down it?"

"Best idea of the day," the Colonel replied. So with machine gun fire we closed all three pillboxes again and the Corporal worked for-

ward. Confidently, he dropped the grenade and jumped.

Two seconds later . . . out it rolled right by the Corporal's feet wounding him. The Germans, apparently anticipating such a stunt, had a trap door in the vent, with a chute that rolled objects like grenades out the side.

For a while we just waited — some lay prone in little depressions for cover — while the battalion commander and staff cogitated on what to do next. We kept enough rifle fire knocking on the pillbox doors to keep their guns quiet and permit us cautious movement.

It was perhaps a half hour later that a meek ammunition bearer, carrying a bangalore torpedo, approached his commanding officer.

"Sir, he said, "this won't roll out. Let me try it."

(A bangalore torpedo, 2 1/8 inches in diameter and five feet long, is something like a drain pipe packed with nine pounds of TNT. These torpedoes can be screwed end to end, and are built for pushing ahead of you to blow a path through mine fields or barbed-wire entanglements.)

So with our machine guns blazing again, the Private ran 30 yards and then on hands and knees climbed the big mound. We watched the kid with hearts in our throats. Nervously, he stuck his bangalore down the vent, pulled the fuse and jumped into a nearby trench.

A few seconds of tense waiting . . . then a dull boom like a giant

fire-cracker in a vinegar barrel.

All was quiet for a few minutes, except our automatic weapons to the immediate right and left that kept the adjacent bunkers shut up. We crept around the pillbox and found that the safest place was behind it, for those of us who were not actually shooting.

Then the big rear door slowly opened – like a vault door in the Chase National Bank. Two German soldiers staggered out with hands in air. One had a burned face, the other, a bleeding nose. "Our Com-

rades will have to be carried out," they said.

The lowly Private had done it! He had found the "key" to the strongest part of the "impenetrable West Wall!" Taking the remaining five bunkers in this group was a routine 30-minute job.

(In our country it would cost from \$20,000 to \$50,000 to build one of these pillboxes. And just to think that for another \$4 the

Germans could have put a top on that vent!)

But darkness soon overtook us, and with it came counterattack after counterattack. By midnight our battalion was completely surrounded and we were on the defensive, fighting for our lives. Ironi-

cally, it now seemed to be we who were defending the Siegfried!

Fighting for the next two days was fierce. But we had opened a gate. After an explosives team blew out a few dragon teeth, a bulldozer filled tank traps and our armor poured into the Saar. Then followed the Seventh Army's historic link-up with the Third and the rat race to the Danube.

The Private? Well, in the confusion and excitement that followed, he was absorbed in the battle. I haven't been able to find anyone who remembers his name. He was just a G.I. without even a First Class Private chevron. But to him an untold number of Allied soldiers owe their lives.
