#### Banquet Speaker Former Thunderbird



Major General James B. McGoodwin currently Commanding General, 49th Armored Division, Texas Army National Guard will be the principal speaker at the Saturday night banquet during the annual reunion.

MG McGoodwin is a native Oklahoman, born in Woodford, graduated from Springer High School and Oklahoma State University with a B.S. in mechanical engineering. He received his MBA from Texas Christian University.

He enlisted in the 45th Infantry Division, Oklahoma Army National Guard in May 1949 and mobilized with the Division in September 1950. He was inducted as a Sergeant First Class and was a member of Co H, 179th Infantry during the Korean conflict.

He graduated from Officer Candidate School in August 1952 and served at Aberdeen Proving Grounds Maryland until released from active duty in 1954.

He returned to Oklahoma State University and earned a degree in Aeronautical Engineering. While attending OSU, he served with the 95th Infantry Division USAR.

General McGoodwin joined the Texas Army National Guard in March 1958. He served in various assignments in the Texas ARNG until assigned as CG, 49th Armored Division in February 1985. He was promoted to Lieutenant Colonel in 1970, Colonel in Colonel in 1976, Brigadier General in 1979 and Major General in 1984.

General McGoodwin's civilian occupation is Facilities Project Manager for General Dynamics Corporation in Fort Worth, Texas.

#### Dalphonse Receives First NH POW Plate

Carmen Dalphonse a World War II member of the 157th Infantry received the first New Hampshire special license plate for former Prisoners of War. Carmen was captured in Germany while serving with the 157th Infantry. He sustained serious wounds when captured and spent most of his 3½ months POW time in the hospital. The special plates are provided free of state fees and are inscribed "LIVE FREE OR DIE".

Carmen is a director of the New Hampshire chapter of American Ex-Prisoners of War.

Clark received his BS Degree in Agricultural Science from Tennessee Tech in 1948 and his Masters Degree in Agricultural Economics from the University of Tennessee in 1957.

He began his Extension career upon graduation from Tennessee Tech and has been a longtime leader in this field.

#### Only In America

He drove his GERMAN car made of SWEDISH steel with interior of ARGEN-TINE leather to a gasoline station, where he filled up with ARAB oil shipped in a LIBERIAN tanker and bought two FRENCH tires, composed of rubber from SRI LANKA.



# Thunderbird Suggests Veterans Monument For NY/NJ Port Authority

Edward I Gavin WW II member of Ho Btry Div Arty a Construction Inspector for the NY/NJ Port Authority was concerned that a Veterans plaque erected in the former port Authority building had not been moved when they relocated to the World Trade Center. Edward submitted an inquiry as to the fate of the monument. As a result of his inquiry, a new plaque was designed and prominently mounted on the 44th floor of the World Trade Center, Dedication ceremonies were conducted prior to Veterans Day in 1986. Gavin was a major participant at the unveiling and dedication ceremony.

#### Life Of A Yankee With The 45th Division

I joined the 45th on July 1, 1941 at Abilene, TX, being transferred from a basic training camp at Camp Walters in Mineral Wells, TX. I was assigned to Co B, 157 Inf, but was transferred to Hq Co, 90th Brigade the night the 157th left for Louisiana manuevers. I was the first person assigned from north of the Mason-Dixon line and all I heard was "you sure talk funny". It was with this unit I saw my first real life general officer, Brig Gen Louis A. Ledbetter, the Brigade Commander.

On the way to Louisiana maneuvers we walked one day and rode in trucks the next day. Most of the trucks were old and worn out as they were issued to the Oklahoma National Guard years ago. While in Louisiana near the town of DeRidder, our company commander Lt. Heckenkamper and I were run over by a 6x6 on its way from the railhead. I can still see BG Ledbetter running out of his tent in orange shorts, GI undershirt, and a campaign hat looking over the situation and yelling "ground that driver" (the poor driver had been up for three days).

Lt. Heckenkamper retired as a Lt Col and is now deceased. I don't know what became of WO Cowboy McClure, 1st Sgt Mercer, Sgt Sparger, Alan Nichie, Major Owenby, Lt Col Paris, Jon Anderson, Felker Bill (the first Indian I ever met). Another great character was guy named Van DerVort.

Two boys from Cincinnati who were with our group from Walters were Bill Hodapp, Bud Schlenker (deceased) both of Hq Co 157 Inf and Bud Dumont with the MP's.

Being a Yankee, I drew KP a lot on the weekend as most of the boys would go

back to Oklahoma to their home towns of Lawton, Durant, Muskogee, etc. So, I will never forget what I was doing on December 7, 1941, cleaning up after lunch.

I would sure like to know how many of the people I have mentioned are alive and well.

I left the 90th Brigade which later became the 45th Cavalry Recon Troop and went to flight training with the Army Air Corps. I still have a Thunderbird bumper sticker on my car-

#### Pfeifer Checks Up After 42 Years

I am a charter member of Service Battery, 171 FA organized at Fort Sill, Oklahoma in January 1941. I joined the Oklahoma National Guard 9 December 1939 and was assigned to Battery A, 160 Fa, Wewoka, OK.

At the end of World War II while occupying the BMW factory in Munich, Germany I obtained the addresses from many of the members of our battery.

Forty-two years later, I started checking out the names and addresses during a vacation in Florida. My first stop was a visit with Joseph Morrel in Auborndale, FL. #### International Korean War Memorial

We appreciate an opportunity to clear away any possible confusion between the campaign to erect the international Korean War Memorial and the recently approved federal project for a Korean War Memorial.

Our objective is to ensure that our fallen brothers and all allies who fought for the freedom of the Republic of Korea \*and won\* are no loner and never again forgotten by erecting an inspiring memorial in our lifetimes.

Famed sculptor Dr. Felix deWeldon who designed the classic Iwo Jima monument has created what he calls his "masterwork" to remind present and future generations that freedom is never free, that its price is vigilance, valor and sacrifice.

The International Memorial, which will be as massive and dynamic as the Iwo Jima monument, features fifteen allied fighting men of all services and races. Low walls encircling it will list the names of the 297,389 allies from sixteen nations who died in the war. The major inscription will read: "We Eternal Band of Brothers".

We plan to dedicate it in December 1988 on a magnificent headland in Los Angeles overlooking the Pacific Ocean. We selected the location after a nation-wide search because it symbolizes the last U.S. territory seen by the 54,246 Americans who never came home, including 8,177 missing in action, plus the 389 still officially listed as Prisoners of War

A "last man" association named The Chosin Few, reuniting the survivors of the Chosin Reservoir battle in North Korea, is spearheading the project. We began the project January 1985 when research revealed the nation's only two major war memorials 'Iwo Jima monument and Vietnam memorial' were both initiated and funded by "grass roots" movements like ours. It also disclosed there are still no national memorials to World Wars I or II in Washinton, DC or elsewhere in the country.

We wish to stress that we are not competing or conflicting with the federal project and, in fact, endorse it. We started long before it was even introduced as legislation. Its start is reportedly five years away and our goal remains to establish a fitting memorial in our lifetimes. With more than 100 Vietnam memorials now across the country, the fact that two Korean War memorials are planned merely means the veterans of the so-called forgotten war are finally going from "famine to feast" in terms of recognition.
