Governor David Walters declared April 14, 1992 as "Save the 45th Day" in Oklahoma. # CHARLES GEORGE

# (MEDAL OF HONOR RECIPIENT)

Private First Class, Company C, 179th Infantry Regiment, 45th Infantry Division. Near Songnae-dong, Korea, 30 November 1952. Entered service at: Whittier, NC. Born: 23 August 1932, Cherokee, NC. General Order Number 19, 18 March 1954.

## **CITATION**

PFC George a member of Company C, distinguished himself by conspicuous gallantry and outstanding courage above and beyond the call of duty in action against the enemy on the night of 30 November 1952. He was a member of a raiding party committed to engage the enemy and capture a prisoner for interrogation. Forging up the rugged slope of the key terrain feature, the group was subjected to intense mortar and machinegun fire and suffered several casualties. Throughout the advance, he fought valiantly and upon reaching the crest of the hill, leaped into the trenches and closed with the enemy in hand-to-hand combat. When friendly troops were ordered to move backupon completion of the assignment, he and 2 comrades remained to cover the withdrawal. While in the process of leaving the trenches a hostile soldier hurled a grenade into their midst. PFC George shouted a warning to 1 comrade, pushed the other soldier out of danger and with full knowledge of the consequences, unhesitatingly threw himself upon the grenade, absorbing the full blast of the explosion. Although seriously wounded in the display of valor, he refrained from any outcry which would divulge the position of his companions. The 2 soldiers evacuated him to the forward aid station and shortly thereafter he succumbed to his wound. PFC George's indomitable courage, consummate devotion to duty, and willing self-sacrifice reflect the highest credit upon himself and uphold the finest traditions of the military service.

# COMBAT CHRONICLES OPERATION AVALANCHE 180TH INFANTRY REGIMENT

The Invasion of Italy, 9 to 30 September 1943. The 180th Infantry Regimental Combat team did not reach the mainland of Italy from Sicily until the 14th of September 1943, due to a lack of naval transport. The 180th was placed in Army reserve upon landing on the beach at Salerno..

On 19 September the 180th Infantry RCT was returned to division control and moved into the division area NORTH of CANALE DI BENIFICAMENTO, Southwest of Highway 18. One company was retained by Fifth Army as a headquarters guard. During the day the regiment moved by motors to an area just NORTH of PERSANO and WEST of the SELE River.

The 180th took the lead on 20 September in the Army advance against a stubborn enemy. The 157th and 179th Infantry Regiments were in division reserve. The 180th reached a position West of RNE OPPED and SW of OLIVETO where their point was fired on by enemy machine guns. The advance was greatly delayed by the many blown bridges and by many mines.

On the morning of the 21st, the first enemy contact was driven out, but the regiment encountered enemy positions strongly supported by mortars and artillery South of the aqueduct and West of OLIVETO.

The enemy selected favorable terrain for defense along the aqueducts West of OLIVETO. He used aggressive, defensive tactics, combined with long range artillery fire and his mortars and machine guns were well coordinated The 180th RCT continued to push forward toward OLIVETO on an unimproved road North of Highway 91 and met considerable resistance in the vicinity of OLIVETO. The ground in this area was very rough with good enemy observation, and it was defended by the bulk of a battalion of the 64th (cont'd on page 2)

PGR, supported by considerable artillery.

The 3rd Battalion, less 1 company held in reserve for Fifth Army guard, preceded by 2 companies of light tanks from the 756th Tank Battalion and 1 company of medium tanks from the 191st Tank Battalion attacked and secured the high ground about 1/2 miles Southwest of OLIVETO. This action cut off much of the hostile observation, but a continuation of the attack to OLIVETO was prevented when the tanks ran low on gas and ammunition. Throughout the day's action, the 180th suffered 28 KIA and 106 WIA.

On 23 September, the 180th RCT, from positions on the high ground to the West of OLIVETO, moved cross-country along the edge of the hills with SENERCHIA the objective. A strong enemy position was uncovered North of AQUA BIANCA. An attack was launched to envelop both flanks and the position was taken. The RCT continued to the North and took up positions South of PICEGLIA Creek.

The German defense of the area surrounding OLIVETO and QUAGLIETTA was bitter and determined. The enemy was forced to withdraw only after the full weight of superior fire power and maneuvering had been brought to bear.

The 180th RCT captured SENERCHIA on 24 September and organized the ground to the Northwest to cover the advance of the 179th Infantry Regiment.

For the remainder of the month of September, contact with the withdrawing enemy was sporatic with them using many mines and blown bridges to obtain their controlled retreat.

Heavy rains fell throughout the night of 28-29 September, slowing down traffic on all by-passes and washing out the by-pass near CAPOSELE. The 2d Battalion, 180th RCT established a defensive position in the vicinity of FRIGENTO.

The harsh Italian winter was already in evidence through the torrential rains throughout the combat area, slowing the advance of Allied troops and was an ally of the enemy, who was starting to build their insurmountable defensive winter line in the mountains of Italy.

# 45TH INFANTRY DIVISION APPRECIATION DAY

Oklahoma Legislature Concurrent Resolution Number 99, approved 27 April 1988 proclaimed the second Tuesday in April of each year beginning in 1989 as "45th Infantry Division Appreciation Day". Concurrent Resolution Number 67, approved 6 April 1992 further identified 14 April 1992 as "SAVE THE 45TH" day.

Oklahoma Governor David Walters issued a proclamation designating 14 April 1992 as "SAVE THE 45TH DAY" in concurrence with 45th Division Appreciation Day in the State of Oklahoma. Supporting Resolutions Were submitted by Oklahoma City Mayor Ronald J. Norick and the American Legion.

Speakers for the occasion were United State Senators David Boren and Don Nickles. Both pledged their support to reducing the personnel losses of the Oklahoma Army National Guard and retaining the lineage and colors of the 45th Infantry Division.

The Concurrent Resolution "SAVE THE 45TH" was read by State Senator William G. "Bill" Gustafson a 45th Infantry Division veteran who was severely wounded during the Korean War while a member of the 179th Infantry Regiment.

The association and museum were represented during the ceremony by Fred Daugherty, Eddie Cope and Bill Wilson.

# MUSEUM HOSTS MEMORIAL DAY CEREMONY

Marian Opala, Chief Justice of the Oklahoma supreme Court was the principal speaker for the annual Memorial Day Ceremony conducted at the 45th Infantry Division Museum.

The event also marked the opening of a new special exhibit at the museum honoring the late Colonel James O. Smith of Okemah. Oklahoma. He was commissioned as a second lieutenant in June 1940, three months before the 45th Infantry Division was called to active duty. He served as a unit and battalion commander throughout the war and completed his wartime service as a Lieutenant Colonel. Subsequent to World War II he was promoted to Colonel and assigned as commander of the 180th Infantry Regiment. He served in that capacity during the Korean War. Following the Korean War he continued as commander of the 180th until he was named Assistant division Commander, holding this position until his retirement.

Inclement weather required cancellation of the band music, Hotchkiss Mountain Gun Salute, Massing of the Colors and the Helicopter fly-over. Ceremonies were conducted inside the museum. Vocal solos were performed by Marcie Barrett, Miss University of Central Oklahoma

Speaker of the Oklahoma House of Representatives Glen Johnson officially opened the special exhibit honoring Colonel Smith.

Approximately 500 persons attended the ceremony.

It was startling and extremely satisfying to find Corporal Jack Korakian's name listed under "Posthumous awards of the Distinguished Service Cross". This from the book presented to General Fred Daugherty and the group of thunderbirds that revisited Korea this past October.

I was with Jack on the day this action occurred, January 23, 1952 (40 years ago almost to the day), near Hyonyogdae, just North of Chorwon, I was the platoon leader and he was an assistant squad leader.

I left Korea before I heard of Jack's award, but heard from friends that he was nominated. So, it was confirmed for me by the January newsletter.

I remember Jack as not being an "enthusiastic" garrison soldier, but as the record indicates, he was one "Great" combat soldier, which is what it is all about.

In May 1945, I was serving as the ranking NCO in the 2d Platoon, Company C, 179th Infantry Regiment. At that time we did not have an assigned officer in our platoon. Captain William White was the company commander.

The 45th Division was moving down the Autobaun toward Munich using all four lanes. As we came out from an overhead, we were stopped cold by 88 fire from a point about a mile ahead of us. The 8 8's were backed up by

infantry in a town called Garching.

My platoon was given an order to go into Garching and secure some houses so the rest of the unit could move in after dark. We were transported into Garching by four tanks. I believe this was the last combat for our battalion as Germany surrendered the next day.
